# AN ORDINANCE TO ABANDON A PORTION OF OLD US-HIGHWAY 190 (Sponsored by Councilman Harold Taylor)

AN ORDINANCE FOR ABANDONMENT OF A PORTION OF PARISH ROAD OLD U.S. 190 IN TOWNSHIP T6S/R6E OF SECTION 12.

WHEREAS, the Parish Council has received petition to abandon a portion of Old U.S. Hwy 190. Beginning at a point where US Highway 71 and Old US Highway 190 intersect at Old US 190 measuring from the center line of Old US Hwy 190 for 100 feet, the point of beginning. Thence, east along Old US Hwy 190 for 2265 feet to the intersection of north/south section line of T6S/R6E Section 12 the ending point, and

WHEREAS, the party namely Brushy Bayou Properties, LLC ETAL represented by Robert Taylor, Managing Partner, has provided documentation indicating the party owns 100% of the land adjoining said highway and further states that have met all provisions for abandonment of a parish road as provided in the St. Landry Parish Code of Ordinances, and

WHEREAS, the section of Old U.S. Hwy 190 proposed to be abandon has been close to traffic for more than 10 years and of no further public use.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE ST. LANDRY PARISH GOVERNMENT, that Beginning at a point where US Highway 71 and Old US Highway 190 intersect at Old US 190 measuring from the center line of Old US Hwy 190 for 100 feet, the point of beginning. Thence, east along Old US Hwy 190 for 2265 feet to the intersection of north/south section line of T6S/R6E Section 12 the ending point be declared abandoned, and the property be returned to the adjoining property owner.

# ADMINISTRATIVE/FINANCE COMMITTEE MEETING MINUTES

- 1. Chairman Wayne Ardoin called this meeting of the Administrative/Finance Committee of the St. Landry Parish Council to order.
- 2. Councilman Easton Shelvin led the Pledge of Allegiance & Invocation.
- 3. Roll Call: Jerry Red Jr., Easton Shelvin, Harold Taylor, Wayne Ardoin and Timmy Lejeune. Ex-Officio Vivian Olivier. ABSENT: Nancy Carriere. *Councilwoman Nancy Carriere was late for roll call but later joined the meeting.*
- 4. Person to address the Committee: None.
- 5. Parish President & Finance Report:

Parish President Jessie Bellard stated, "Mr. Red asked for a comparison of the fuel cost compared to last year. So in your packet you have a breakdown of each department and the fuel purchases year to date. It is a yearly comparison and a monthly comparison. It is in your packet for review. The list of vehicles, we have a sale coming up on July 23rd to sell some vehicles. Once everything is sold, we will put a list back together of what we have and we will get you all a copy of that at the next meeting."

Councilman Easton Shelvin questioned, "Do you have a list of the vehicles that you are going to sell?" Parish President Jessie Bellard stated, "Yes, we have a list of the vehicles. We have a list of everything that we are selling. It is not just vehicles; it is odd items that is just hanging around. I want to get rid of that. We have a list that we will be selling."

Councilman Jerry Red Jr. questioned, "I was looking at the print out on the fuel. On Public Works, if you are looking at it, it is almost \$10,000.00 more per month. I knew it was going to go up. Do we have any plans on the vehicles?"

Parish President Jessie Bellard stated, "We are going to have to take it away from materials. We are going to use material money. Right now we are going to be at 100% on our fuel budget so we are going to use the money from material and not put as much material on the road to keep the vehicles running." Councilman Jerry Red Jr. questioned, "With the fuel cost, will we continue having everyone taking their vehicles home?

Parish President Jessie Bellard stated, "Only the employees that are on call are taking vehicles home." Councilman Jerry Red Jr., stated, "All right."

Councilwoman Nancy Carriere questioned, "Since you all were talking about vehicles, about two Sunday's ago, I meet the Parish Government's small car going to Lafayette. I was just wondering where the vehicle was going on a Sunday."

Parish President Jessie Bellard stated, "The little tiny, tiny care?"

Councilwoman Nancy Carriere stated, "Yes, the one that is parked at the Civic Center.

Parish President Jessie Bellard stated, "That is one of the WIOA vehicles. Sometimes they take it back home when they have to go to a meeting on a Monday in another parish, instead of driving to Opelousas to get the car and driving back home, they come and get the car on a Sunday to start their Monday off." Administrative Finance Chairman Wayne Ardoin questioned, "Mr. Bellard, how many vehicles do we have out there now? Can you give us that figure?"

Parish President Jessie Bellard stated, "I can't give you an accurate count, no. We will have that list compiled after July 23rd.

Administrative Finance Chairman Wayne Ardoin stated, "Okay."

Parish President Jessie Bellard stated, "The Woman's Shelter, right now we are still looking at buildings. Until they find a location to put it we don't need any action from the council until that takes place. As of right now they are trying to get it to an off sight location in the parish but not on the Airport Grounds, something that is already built. Right now they are just trying to find something built. It is too expensive to build one."

Councilman Harold Taylor questioned, "What involvement do we have in this? Do we have a financial involvement?"

Parish President Jessie Bellard stated, "No we don't. I just think that maybe the Shelter will have to comply with our new ordinance that we just put in place with the Group Homes. I think it is going to be their definition so at that point, I think we will come to the council to get approval for that. Initially they wanted to do it on the Airport property but it will cost too much money to do it there."

Councilman Harold Taylor stated, "So we don't have any financial involvement in it at all, is that correct?" Parish President Jessie Bellard stated, "That is correct."

Councilman Harold Taylor stated, "Okay."

Parish President Jessie Bellard stated, "On the Animal Control Ordinance, Katy still has it. She assured me that she will have it for me for the council meeting to be introduced at the next council meeting on the 19th, she has not given me the final draft yet."

Parish President Jessie Bellard stated, "Update on the Walmart Distribution Center, nothing public to go out right now. We have not received anything since we last discussed it. Bill called me today about some other issues but not ready for the public yet."

Parish President Jessie Bellard stated, "On the Buller Property, it is still in the hands of Jacob and them. They are drafting an ordinance or a sample ordinance for us to bring to the council hopefully for the next board meeting. That way, we can have that introduced and ready to go."

Administrative Finance Chairman Wayne Ardoin questioned, "So Mr. Jarrell is working on that Mr. Bellard."

Parish President Jessie Bellard stated, "Correct, yes."

Councilman Jerry Red Jr., questioned, "What is the plan on the Buller Property?"

Parish President Jessie Bellard stated, "I think once we change the ordinance then it will be able to comply with that ordinance. So there is no variance needed, he will just have to comply with the new ordinance that is in place."

Councilman Jerry Red Jr., questioned, "So what is the plan to change the ordinance?"

Parish President Jessie Bellard stated, "To make it to a private subdivision that has to be gated and it has to have a HOA and those stipulations. It will be basically a private road built to our specifications but not with our involvement at all. Once they build it, it has to meet our specifications for a gated community and have a HOA and a couple of other things but basically they will be on their own. It will be in the contract that it will be theirs and only theirs and it will never come to the parish."

Councilman Jerry Red Jr., stated, "I will be honest, I am against private subdivisions. Right now, I would not be for it."

Parish President Jessie Bellard stated, "The Blighted properties, number 8 on the agenda, 38 adjudicated properties, I also have the Blight Properties that we submitted to you all tonight, four of them, we will take action on. We gave them time to do their work and they did not do it so now we will go along and tear

them down and clean up their property. The bottom two is newly blight properties, we will need that to start the process of demolition and start doing notifications on those."

Administrative Finance Chairman Wayne Ardoin questioned, "Are all of those outside of the city limits of any municipalities?"

Parish President Jessie Bellard stated, "I am not sure about Bullard that has already been done. The other two are, the first four already went thru the process in front of the council. Those are the ones we gave time to do it. Some it helped and some it did not. Now we are just going to go ahead and knock them down and clean them up. The new ones are Parcel No. 010659220R - Robert Lee Henry - 121 Annointing Drive, Opelousas. The other new one is Parcel No. 0201848700 – Carolyn Winnworth – 221 Cameron

Drive, Arnaudville. Those are the two properties that we need to start the process of demolition."

Councilwoman Nancy Carriere questioned, "I see that Lena Mayo on McNeese, is that the one that I was speaking of that was supposed to do it that did not ever do it?"

Parish President Jessie Bellard stated, "Correct, they started but they did not finish."

Councilwoman Nancy Carriere stated, "I don't think they started because I went by. It is a trailer and you all are going to finally do it."

Parish President Jessie Bellard stated, "We will have to do it, yes."

Councilwoman Nancy Carriere stated, "I understood that she sold the property. Is she still the owner or do you know?"

Parish President Jessie Bellard stated, "At last we have known that is correct. If she sold the property they we will get with the new owner but at the same time this has already been approved and ready to go. We gave them time, they did not fulfill their obligations."

Councilwoman Nancy Carriere stated, "Well three years' time. Thank you."

Councilwoman Mildred Thierry questioned, "The beginning process for the demolition process is to send them a letter, what is the first step?"

Parish President Jessie Bellard stated, "We have sent letters out already. We have already sent certified letters and everything else. Now the council will send out registered letters to come show cause at the council why we should not proceed. Whenever it gets here we have already sent out letters and certified letters and stuff."

Councilman Jerry Red Jr., questioned, "After this is passed by the council, what is the timeline on starting the process of it being cleaned up?"

Parish President Jessie Bellard stated, "Whenever they come here in front of the council or if they don't show up, then we usually do 30 days after that process and start to clean them up."

Councilman Jerry Red Jr., questioned, "Some of these did not come before the council."

Parish President Jessie Bellard stated, "They did, they just ask for more time and we gave them more time."

Councilman Jerry Red Jr., questioned, "And we still have to give them more time to come before the council?"

Parish President Jessie Bellard stated, "No the first 4 we don't. I am just letting you all know that we gave them time but they did not fulfill the obligation so now we will just have to go and do it. Whenever they come before the council and say give me 30 days or whatever, we try to work with them but if they don't keep up their end of the bargain, we will just have to go and clean it up."

Councilman Jerry Red Jr., questioned, "So the process after they passed the first 4, we can start cleaning them up. But the last 2....."

Parish President Jessie Bellard stated, "We are just starting the process now. We already sent out the certified letters and did our part on our side now it is time for them to come to the council and show cause why we should not."

Administrative Finance Chairman Wayne Ardoin questioned, "Where is the list of the monies on the American Rescue Fund? Do you have that in a separate account?"

Finance Director Caryn Fulop stated, "We keep track of it in a separate quick book file."

Administrative Finance Chairman Wayne Ardoin questioned, "Are we privileged to that?"

Finance Director Caryn Fulop stated, "I can get you copies of it."

Administrative Finance Chairman Wayne Ardoin stated, "Jessie and I had a conversation this morning. I think you all have disbursed some of the money to the municipalities."

Finance Director Caryn Fulop stated, "Yes we did. We sent that out."

Councilman Harold Taylor questioned, "Madam Director Caryn, I spoke to an Auditor yesterday to get an update on when we can get the audit. I think you asked for an extension. Would you explain what that was for?"

Finance Director Caryn Fulop stated, "When Kevin and I had spoken he had one of his managers that left. He is catching up and because I came in at the end of the year and I have been trying to find where information is that I did not know where it was at. We have been getting it together and sending him stuff as we get it. We have seen them, they have not come there so it is just a matter of me finding it and sending it to them. Jennifer, she is usually with the manager on the audit, she left like a couple of weeks ago in the middle of June after vacation so he is playing catch up with it."

Councilman Harold Taylor questioned, "Any time line as to when we can expect it?"

Finance Director Caryn Fulop stated, "We asked for a 60 day extension which would give them enough time to come in and do what they need to do. We sent them all of the stuff so it was just a matter of them taking what we have sent them and doing what they needed to do. I think they are on the single audit part of it now though."

Councilman Harold Taylor stated, "You said 50 days?"

Finance Director Caryn Fulop stated, "60."

Councilman Harold Taylor stated, "60 days."

Finance Director Caryn Fulop stated, "I think you can do an extension up to 90 days. Kevin and I spoke and we did 60 just to make sure we had enough time."

Councilman Harold Taylor questioned, "So 60 days from when?"

Finance Director Caryn Fulop stated, "From June 30th.

Councilman Harold Taylor stated, "Okay, thank you."

A motion was made by Councilman Jerry Red Jr., seconded by Councilman Easton Shelvin to accept the Parish President & Finance Report.

### PUBLIC WORKS COMMITTEE MEETING MINUTES

- 1. Councilman Coby Clavier called this meeting of the Public Works Committee of the St. Landry Parish Council to order.
- 2. Roll Call:

Mildred Thierry, Gil Savoy, Alvin Stelly, Jimmie Edwards, and Coby Clavier. Ex-Officio Vivian Olivier. ABSENT: Public Works Chairman Dexter Brown.

3. Person to address the Committee:

Ms. Lena Charles addressed the council. She stated, "Good evening, Chairperson, Councilmen and Women I missed you all last month. I had COVID again. I am almost in the book of world records for COVID. I stand before you today in appreciation of our parish and what we have done. The original Southwest Louisiana Zydeco Music Festival went virtual for two years. It was for the safety of the community and being wise and following the rules. For 2022 we are going to be live and we are coming back for the 40th year. Forty years of non-stop Zydeco. This 40 years represent the keepers of the culture. I just want you all to know that since working with all of the different administrations from years and being accepted as a Parish Festival, we are very responsible to get all permits, all requirements and always have a good safe festival. We work with the Opelousas Police Department as well as the Sheriff's Department. Everybody is working with the Parish President to make sure that it is a good and save festival. Again we will bring our parade route coming down Landry Street at the Courthouse Square. We will have our breakfast in the morning and the music will start at the Yambilee Festival Grounds in the Zydeco Capital of the World as well as St. Landry Parish. That will be from 12:00 to 12:00. We are looking forward to August 4th, to unveil all of the details of the Festival Activities. You are the seed of the parish and I just wanted to let you all know that we are going live again and we are excited about it. We think the community is ready. So thank you and I appreciate it. I just want to congratulate the parish, I brought Zydeco to Essence Festival Saturday for the State of Louisiana. We represented St. Landry Parish and Southwest Louisiana with Zydeco Day at the Essence Festival. We have been doing this for 5 years. Even with the hiatus, they welcomed us back and we were excited. I also missed the opportunity for bringing back the BBQ Festival. I heard it was a huge success. I applaud you all on that. This is so exciting that we can bring people to our community and let them know this is the place to be, St. Landry Parish and we have so much to offer. Thank you all for the BBQ Festival and we look forward for the support for the Zydeco Festival this year as well. Thank you." Councilman Coby Clavier stated, "Thank you Ms. Lena. Thank you for keeping us

informed on those things.

4. Public Works Report:

Parish President Jessie Bellard stated, "We started the ditch digging on the second phase of the ARA Funding. They are in the process of digging ditches now. That will continue until they run out of money in that fund for the category. So that is happening. We are still waiting on Engineers to start the Overlay Project for Raiders and Grant Road at any time now. The courthouse renovations and the changing of the windows will start soon. They estimate it to be a 1-year project. It will be a long process but it is starting as soon as they can get here and get the material in to start the process. They will start on the front of the Courthouse and take out 10 windows. They will start doing it with 10 windows at a time until they get it all complete. We have 278 windows. That is about all." Councilman Coby Clavier questioned, "Are they putting new windows or they are pulling out the old ones and putting in new ones?"

Parish President Jessie Bellard stated, "They are capping over the old ones with that Bronze Aluminum and sealing it and putting a new glass in the insert. It will be insulated windows. We should be better on electricity. The sealing of the Courthouse has been completed, that is done. The roof won't be long. We had a Consultant Group to come and look at the roof and we have 2 layers that is on the roof. Now they have to take off the 2 layers before putting a new roof. That money is coming from the state. That is from a grant that we got from the state last year."

Councilman Coby Clavier questioned, "What material is going on the roof?"

Parish President Jessie Bellard stated, "It is a flat roof. I think it is that new material that stretches. I forgot the name of it. It is going to give a little bit. It is better than the one that we have now. That is it for now."

A motion was made by Councilman Jimmie Edwards, seconded by Councilman Alvin Stelly, to accept the Public Works Report.

- 6. Discuss when the work will begin for the widening of Beck Miller Road. (Councilman Coby Clavier). Councilman Coby Clavier stated, "Barry called me about this also. That will be in the works real soon. He is getting it going. That is being handled." Parish President Jessie Bellard stated, "The only problem is the cost. We got a price a while ago. They just e-mailed it to us this afternoon, \$194,000.00. We have to look at that and see how we can adjust some of the work."
