AN ORDINANCE TO REPEAL THE ANIMAL AND FOWL ORDINANCES IN CHAPTER 8, ARTICLES I, II, III, IV, V, VI, AND VII IN THE ST. LANDRY PARISH CODE OF ORDINANCES AND REPLACE THEM IN CHAPTER 8 WITH THE FOLLOWING ANIMAL AND FOWL ORDINANCES

XII. RESOLUTIONS TO BE ADOPTED:

RESOLUTION NO. 002 OF 2023

A RESOLUTION IN SUPPORT OF LEGISLATION TO CREATE THE ACADIANA REGIONAL JUVENILE JUSTICE DISTRICT COMPRISED OF VARIOUS PARISHES IN OR NEAR THE ACADIANA REGION; PROVIDING FOR THE EFFECTIVE DATE THEREOF; AND OTHERWISE PROVIDING WITH RESPECT THERETO.

WHEREAS, for a number of years, there has been inadequate space in local juvenile detention facilities to protect public safety through the pretrial detention of youthful repeat offenders and/or those charged with committing the most serious violent crimes, many of which involve the use of firearms and other dangerous weapons; and

WHEREAS, there approximately 12 local juvenile detention facilities in the state, many of which do not have space available to hold pretrial youth from outside of their respective jurisdictions or will not accept such use; and

WHEREAS, Act 501 of the 2016 Regular Session of the Louisiana Legislature raised the age of juvenile jurisdiction to include seventeen (17) years old (Raise the Age Legislation), and

WHEREAS, many jurisdictions have experienced dramatic increases in serious violent crimes committed by youthful offenders with the use of firearms and other dangerous weapons since passage of the Raise the Age Legislation; and

WHEREAS, many youthful offenders committing these violent crimes with the use of firearms and other dangerous weapons must be released back into their communities because there is no available space in local juvenile detention facilities to hold them before trial thereby creating serious public safety concerns; and

WHEREAS, this problem has been made worse by the fact that the Louisiana Office of Juvenile Justice (“OJJ”) recently informed judges throughout the state that it is currently unable to accept sentenced youth into state custody because the OJJ juvenile detention facilities in that state are at full capacity causing a backlog of sentenced youth to remain in local juvenile detention facilities; and

WHEREAS, public safety can best be protected in the parishes in or near the Acadiana region by creating additional local detention facility space in the parishes in or near the Acadiana region for the pretrial detention of youthful repeat offenders and/or those youth charged with committing the most serious violent crimes many of which involve the use of firearms and other dangerous weapons; and

NOW, THEREFORE, BE IT RESOLVED that the St. Landry Parish Council hereby expresses its support of Legislation to create the Acadiana Regional Juvenile Justice District to be comprised of various interested parishes in or near the Acadiana Region.

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to those members of the Louisiana Legislative representing St. Landry Parish.

BE IT FINALLY RESOLVED, that this Resolution shall become effective immediately upon adoption by the St. Landry Parish Council.

RESOLUTION NO. 003 OF 2023

A RESOLUTION TO RELOCATE THE POLLING LOCATION AT LIVING WATERS COMMUNITY CHAPEL TO THE YAMBILEE BUILDING.

BE IT ORDAINED BY THE COUNCIL OF THE ST. LANDRY PARISH GOVERNMENT, that:

The Precinct 24 and Precinct 25 polling location at Living Waters Community Chapel, 946 S. Bullard Street in Opelousas, Louisiana is hereby relocated to polling location at the Yambilee Building, 1939 West Landry Opelousas, La 70570.

RESOLUTION NO. 004 OF 2023

A RESOLUTION TO ADOPT THE RENEWAL OF THE ST. LANDRY PARISH MULTI-MITIGATION PLAN FOR 2022 THAT ALLOWS THE PARISH AND ITS MUNICIPALITIES TO BE ELIGIBLE FOR FEMA HAZARD MITIGATION FUNDS.

WHEREAS the St. Landry Parish Government recognizes the threat that natural hazards pose to people and property within St. Landry Parish; and

WHEREAS the St. Landry Parish has prepared a multi-hazard mitigation plan, hereby known as the 2022 St. Landry Parish Multi-Jurisdictional Hazard Mitigation Plan in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS the 2022 St. Landry Parish Multi-Jurisdictional Hazard Mitigation Plan identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in St. Landry Parish from the impacts of future hazards and disasters; and

WHEREAS adoption by the St. Landry Parish Government demonstrates their commitment to the hazard mitigation and achieving the goals outlined in the 2022 St. Landry Parish Multi-Jurisdictional Hazard Mitigation Plan.

NOW THEREFORE, BE IT RESOLVED BY THE ST. LANDRY PARISH COUNCIL, LOUISIANA, THAT:

The St. Landry Parish Council adopt the 2022 St. Landry Parish Multi-Jurisdictional Hazard Mitigation Plan Renewal and it be forwarded to GOHSEP and FEMA for final approval.

RESOLUTION NO. 005 OF 2023

WHEREAS, the St. Landry Parish Council has received information that the Non-Warranty Cash Sale conveying adjudicated property, which was recorded under Act Number 1236966 in the Conveyance Records of the St. Landry Parish Clerk of Court, is invalid because the State statutes which govern the sale of adjudicated property, LA R. S. 47:2201 through 47:2207, were not complied with.

WHEREAS, the Non-Warranty Cash Sale of the adjudicated property bearing parcel number 0300290300, which was recorded under Act number 1236966 in the Conveyance Records of the St. Landry Parish Clerk of Court, must be declared invalid by the St. Landry Parish District Court so that the property will revert back to the St. Landry Parish Government.

THEREFORE, BE IT RESOLVED, that the St. Landry Parish Council hereby

authorizes any and all lawsuits and litigation on behalf of the St. Landry Parish Government to have the St. Landry Parish District Court declare invalid the Non-Warranty Cash Sale conveying the adjudicated property bearing parcel number 0300290300, which was recorded under Act Number 1236966 in the Conveyance Records of the St. Landry Parish Clerk of Court, so that said property will revert back to the St. Landry Parish Government.

RESOLUTION NO. 006 OF 2023

WHEREAS, the St. Landry Parish Council would desire definitive resolution by the St. Landry Parish District Court on interpreting Sections 5-02, Section 5-04, and Section 2-10 (D) of the St. Landry Parish Home Rule Charter.

THEREFORE, BE IT RESOLVED, that the St. Landry Parish Council hereby authorizes any and all lawsuits and litigation to have the St. Landry Parish District Court render a Declaratory Judgment on whether or not Section 5-02 and Section 5-04 of the St. Landry Parish Home Rule Charter mandate that an amendment to a budget of the St. Landry Parish Government must be passed by December 31 of the year that the budget they are seeking to amend is for.

THEREFORE, BE IT FURTHER RESOLVED, that the St. Landry Parish Council hereby authorizes any and all lawsuits and litigation to have the St. Landry Parish District Court render a Declaratory Judgment on whether or not Section 2-10 (D) of the St. Landry Parish Home Rule Charter mandates that the St. Landry Parish Council must have at least seven votes in the affirmative to pass an Ordinance, Resolution, or take any other action.

RESOLUTION NO. 007 OF 2023

BE IT RESOLVED, that the St. Landry Parish Council approves St. Landry Parish Government to issue a permit to NextEra Energy for a Solar Farm project on Highway 103, one mile south of Port Barre, Louisiana.

MINUTES

- I. This meeting was called to order by Chairwoman Vivian Olivier.
- II. Councilman Jerry Red Jr., led the Pledge of Allegiance and the Invocation
- III. Roll Call: PRESENT: Jerry Red Jr., Nancy Carriere, Easton Shelvin, Mildred Thierry, Harold Taylor, Gil Savoy, Alvin Stelly, Wayne Ardoin, Dexter Brown, Timmy Lejeune, Jimmie Edwards and Coby Clavier. Ex Officio: Vivian Olivier. ABSENT: None.
- IV. Item for Discussion:

ORDINANCE NO. 2022-024
(Sponsored Councilman Timmy Lejeune)

A motion was made by Councilman Timmy Lejeune, seconded by Councilman Jimmie Edwards to Accept Ordinance No. 2022-024, the Amended 2022 Budget.

On roll call vote: YEAS: Jerry Red Jr., Easton Shelvin, Mildred Thierry, Alvin Stelly, Timmy Lejeune and Jimmie Edwards, Chairwoman Vivian Olivier. NAYS: Nancy Carriere, Harold Taylor, Wayne Ardoin and Coby Clavier. ABSENT: Dexter Brown.
ABSTAINED: Gil Savoy.

WHEREUPON, this motion was adopted on this, the 31st, day of January, 2023.

Councilman Jerry Red Jr., stated, "That is 6 votes. Is that good Mr. Duplechain?"

Legal Counsel Garrett Duplechain stated, "You have to have 7 votes.

Councilman Jerry Red Jr., stated, "Our Chairlady could vote, is that correct?"

Chairlady Vivian Olivier stated, "I was supposed to declare my vote, can I vote now?"

Councilman Jerry Red Jr., stated, "Yes you can."

Legal Counsel Garrett Duplechain stated, "Yes, you declared before the meeting you wanted to vote and you declared it to me and no one else."

Council Clerk Sherell Jordan stated, "Ms. Vivian Olivier."

Chairwoman Vivian Olivier stated, "I vote 'Yes' ."

Councilman Jerry Red Jr., questioned, "Madam Chairlady, can I ask a question. We will come to a lot of conclusions where we only have 5 or 6 votes because of a lack of so many people in a meeting. My only question is if there is a majority and there are only 12 people here including our chairman and 6 would be the majority so you me to tell me that is not a majority?"

Legal Counsel Garrett Duplechain stated, "It supposed to be a majority of the membership and the membership is 13. Our Council Clerk and I got a letter from Tim Winn of Parliamentary Consulting in Georgia that does the training for NACO including voting. He had stated that our Home Rule Charter is a mixture of requiring a majority vote of the membership and a majority vote of those who show up to vote. He will send that letter to us but he charges by the hour which is \$350.00. Once we have that from Parliamentary Consulting than he will disclose that it is up to the Chairman to decide once and for all whether it is a majority vote of the whole membership or majority vote of those who show up to vote. If the Chairman does not decide then it is up to the council to vote on it. So that is the information we got from Parliamentary Consulting which does training for NACO and looked at our Home Rule Charter and told us that. Unless we do that, I think we have to follow the plan language of the Home Rule Charter that says a majority vote of the membership and the membership here is 13. It is in everyone's e-mail and he will charge \$350.00 and he will send us the letter saying that."

Councilman Jerry Red Jr., stated, "But in this case it was 10 votes because District 6 Abstained."

Legal Counsel Garrett Duplechain stated, "Right, it is 7 votes in the affirmative. A Chairman can vote to pass or kill a motion and she voted."

Parish President Jessie Bellard stated, "He brings up a good point, so does Mr. Taylor. I did get two different answers from different attorneys. I think at some point we need to get that answer clarified because we will have some future issues and I think we need to get that answer clarified by somebody having authority to do so, maybe even a Declaratory Judgement by a Judge, I don't know."

Councilman Harold Taylor stated, "Why don't we just ask for an Attorney General's Opinion or get a Declaratory Judgement with the Courts Interpreter on the meaning of what the Charter says that the people voted on and adopted."

Parish President Jessie Bellard stated, "I would like to bring up at the next meeting or maybe tomorrow night we can bring it up in the committee to bring it to full council to get that answer from somebody. I am not saying anything against the Consultant but he is a Consultant. I just want to get a clear answer for the future."

Legal Counsel Garrett Duplechain stated, "If we get the letter from the Consultant we don't have to follow the letter from the Consultant but at least we will have it on paper in front of us."

Councilman Jerry Red Jr., stated, "At the same time can you get from your boss?"

Legal Counsel Garrett Duplechain stated, "I did that already. He said 7 votes is required to pass anything."

Councilman Wayne Ardoin stated, "Out of all due respect to every councilmember that is here tonight. Mr. Easton Shelvin was it proper for you to vote here tonight dealing with finance being that you are an employee of the Opelousas City Marshall? It is time for us to bring this to a heard. You all are coming back and forth, NACO is coming in and Georgia is trying to tell us how to vote over here. I am going to ask this simple question, Mr. Shelvin, do you feel that it is right for you to vote on any kind of Finance in this?"

Councilman Easton Shelvin stated, "Do I fell if it is right?"

Councilman Wayne Ardoin stated, "Yes sir."

Councilman Easton Shelvin stated, "Of course. I will stand up my company. Garrett, is it?"

Legal Counsel Garrett Duplechain stated, "A councilman can vote on something that affects them like a position to a board or something like that. In this case Mr. Shelvin would never be able to vote on anything having to do with Parish Government Finances if he would abstain. I don't see that Mr. Shelvin did anything wrong. It does not affect him personally. Now what Mr. Shelvin voted on affects Public Finance. Part of Public Finance is Financing City Marshall. That is a Public Finance for a Public Entity. If the council was voting on something that financially affected an ABC Cooperation or a Private Entity owned by Mr. Shelvin, Mr. Shelvin could not vote on that. But it is affecting Public Finance for a Public Entity. He just could not vote if it was accepting a Cooperation or a Private Company, for sure he could not vote on that."

Councilman Wayne Ardoin stated, "As a matter of record, you are siding with what they stated, people from the NACO Convention and everything else. I know our neighbor here, Mr. Brown is not here so we don't have the 13 members here. We only have 12 members here. I also wanted to find out about Mr. Shelvin. Because of the fact that we finance the Marshall's Office."

Legal Counsel Garrett Duplechain stated, "There is a difference between voting to finance a Public Entity and a Private Entity. If it is a Private Entity the councilman who owns that Private Entity cannot vote. But the City Marshall is not a Private Entity."

Councilman Jerry Red Jr., stated, "I have one question. Anytime we abstain are we supposed to give our reason why?"

Legal Counsel Garrett Duplechain stated, "I would think so."

Councilman Jerry Red Jr., stated, "Robert's Rule of Order states that you suppose to give your reason why you are abstaining."

Legal Counsel Garrett Duplechain stated, "Yes because I would think that there is no secret of abstaining."

Councilman Jerry Red Jr., stated, "My reason for asking that question is because we just had a councilmember abstain. Mr. Savoy, do you have any reason why you are abstaining?"

Councilman Gil Savoy stated, "Yes sir, I don't want to go to jail, I am too old. I have been in politics a long time and this is the first time that I have abstained. Explain to me why we should vote for this? I do have a right to abstain?"

Councilman Jerry Red Jr., stated, "I guess you can but I believe that you should give your reason why."

Councilman Gil Savoy stated, "I respect your 'Yes' or 'No.'"

Councilman Jerry Red Jr., stated, "I give you my reason why I voted yes."

Councilman Gil Savoy stated, "I gave you my reason why I abstained."

Legal Counsel Garrett Duplechain stated, "Nobody said that it had to be a good reason it is just a reason."

ABSTAINED: Gil Savoy.

WHEREUPON, this motion FAILED on this, the 31st, day of January, 2023.

Councilman Harold Taylor stated, "Just for the record, I voted 'No' because I don't believe that this is a realistic budget. It is a budget that is full of one time money doing reoccurring expenses."

Council Clerk Sherell Jordan stated, "Ms. Vivian, are you going to vote?"

Madam Chairlady Vivian Olivier stated, "Yes, I am voting. My vote is 'Yes.'"

Council Clerk Sherell Jordan stated, "That is 6 'yes' votes and 5 'no' votes so it 'Failed' if you all are going with the 7 'yes' votes. It has to be 7 'yes' votes to pass but it failed because we have 6 'yes' votes,

but if you are voting for the 6 ‘yes’ votes then it passed. So it depends on what you all are going to go with. We have voted and passed things before with just 6.”

Councilman Harold Taylor stated, “You cannot do it with 6 votes, the man just said that. The Charter stated you have the majority.”

Council Clerk Sherell Jordan stated, “It is Ms. Vivian’s call, Ms. Vivian.”

Madam Chairlady Vivian Olivier stated, “I say, let it pass.”

Councilman Jerry Red Jr., stated, “If I am in line can we set up a meeting possibly next week to discuss the budget again. If you all want to look at it again in order for us to pass it, let’s look at it again next week.”

Madam Chairlady Vivian Olivier stated, “It is not going to look any better.”

Councilman Jerry Red Jr., stated, “Well you want to make changes. If you all don’t want to make any changes.”

4. Person to address the Committee:

Mr. Tony Guillory addressed the council. He stated, "It gives me great honor to have you all meet this gentleman, he is from Lake Charles, LA. As you know I do believe in supporting anyone that do believe in helping people. This gentleman is definitely going to help people, his vision and everything to help people as your next Governor. I would like to bring on Mr. Hunter Lundy and he is going to tell you a little bit about himself."

Mr. Hunter Lundy addressed the council and stated, "Thank you Tony. Thank you all for letting me speak here, Ms. Chairlady, and councilman. I am a native of Lake Charles. I grew up in Lake Charles, graduated from LaGrange High School. I was 1 of 4 children to Pat and Patricia Lundy. My father is deceased but my mother is 91 years and looks like my sister so I have pretty good genes and one of my brothers is deceased. I practiced law for 40 years. I started college at McNeese then transferred to a small college in Mississippi and played football at Millsaps College. Then I went on to law school and worked for a Federal Judge in Biloxi, Mississippi. Then I moved back to Lake Charles in the early 80's and worked for Governor Jones Law Firm. Sam Jones is the last Governor from Southwest Louisiana and he was called a reformer after the long years. In 1986 I started my own Law Firm. I been the CEO for that Law Firm for the last 36 years. At the end of 2021 I made the decision I was going to leave the law practice and run for Governor. It was only after a lot of prayer and a lot of thought and encouragement from different people suggesting that I do this so I made the decision to do it. My record probably speaks for itself. As an advocate I have been all over the world and I litigated cases all over the United States. Many of them in the environmental communities that were affected adversely by industry but at the same time I represented Mari-Time Companies. I have defended lawyers and doctors and I have walked everyway that you could walk as far as community service I have been on the Executive Board of Boy Scouts. I have helped to build Churches. I am in the middle of building a Youth Camp at a Church right now in another state that we are trying to get the Youth Camp done. I have been involved in every aspect of life so why do I share these things with you is because I will be the candidate with the most gray hair. I will be the candidate that has the wisdom and the energy and will not be outworked by anyone else. I will be the only Independent in the race. I became an Independent a number of years ago. The question I answered is there such a time as this Louisiana will elect an Independent Governor because of the divisiveness that is occurring in both parties. I got out at the first of last year and started going across the state and here with me tonight is Mr. Wayne Sensette whom has worked with five District Attorneys in Calcasieu Parish. We leased his wife bus and we wrapped it and it say Lundy for Louisiana and we have been all over the state. This is like my 6th or 7th police jury to speak to. We have spoken to all of the DA's and all of the Sheriff's and we have done all of the things that we have to do politically. At the same time I was in Washington last week and I got to visit with Mr. Red an honorable man that you all have on the Police Jury here, a Godly man. I feel really good and nobody will outwork me, I care about people. My call in life was always to help people. My younger brother is now the CEO of our law firm. We have had as many as 21 lawyers and 60 employees at one time so we understand what it is. I am a developer, a business man and a preacher. I have done a lot of different things and God has put me in a place right now at a time as such it is to do well for the state of Louisiana and for the people. My calling never has changed, it just will go from the court house to the capital. We are still going to help people. I tell people that I am going out of this world with booths on the ground. I am not going to quit. That is who I am and that is what I am about. I have 2 living siblings a sister and a brother. As I told you my 91 year old mother is still going strong and I have 5 grandchildren. Two of my sons live in Beauregard Parish. One of my sons is a Ship Captain and one is a Fire Captain. I have a daughter that is a School Teacher. We come from a family that my mother was a teacher and a professor. My dad worked on the waterfront in 1954 as a Crane Operator. Thirty years later he ended up owning the Maritime Companies. My older brother, sister and I all had to have jobs and Scholarships to go to College. My younger brother went with a credit card and a new car so there was a difference in the economy and lives but we were given a work ethic like no other from my father. So that is kind of the story of the Lundy Family. My mother was a daughter of a rice farmer and my dad was the son of a football coach from Mississippi that moved to Louisiana to be the Boy Scout Executive. My dad eventually ended up in Louisiana and that is where we grew up. If you have any questions, I don't want to take up the time because I know you all have a lot of business to do but

if you want to ask and take a free shot right now hopefully you will have your next Governor standing right here and you can get to ask him a question.”

Councilman Coby Clavier stated, “I don’t have a question, I just want to make a statement, I met you back in Alexandria a few weeks ago and I appreciate you coming to see us today and I wish you luck.”

Councilman Harold Taylor stated, “Hunter Lundy, I knew you 26 years ago when you ran for Congress. Was that your last race?”

Mr. Hunter Lundy stated, “That was my only race.”

Councilman Harold Taylor stated, “I have admired you then and I admire you today. Thank you for giving service to your community and thank you for joining us tonight and pitching your candidacy for Governor.”

Mr. Hunter Lundy, “Thank you Mr. Taylor, in response to that I was young and I ran in the open primary and there were 8 candidates in the race no one knew who I was but I ended up in the run off with Chris John who was a good Congressman and I lost in the run off. It was the best thing that ever happened because I ended up being a single dad raising my youngest son who now is the ship captain at 36 years old. It was never meant for me but I learned a lot from it and I never thought I would do this again but I am doing it again. Are there any other questions?”

5. Parish President & Finance Report:
Update on the Old Federal Courthouse

Parish President Jessie Bellard stated, “So the update on the Old Federal Courthouse, we pulled that item because it is not feasible for the parish to purchase this building. The all in price would be about \$4.9 million dollars. I don’t think we would be able to obtain the donations or the Federal Grants to do what needs to be done. I am pulling it from the budget and the budget will reflect that whenever we make that change. In your packet is a Resolution to adopt our Hazardous Mitigation Plan. Every 5 years we have to adopt a plan and submit it to FEMA for their approval. That is how we get our funding every year. We have to adopt it and all of the municipalities have to adopt it so this is the first step.”

Administrative Finance Chairman Wayne Ardoin questioned, “Do we have a copy in our packet Ms. Sherell?”

Council Clerk Sherell Jordan stated, “Yes, it is Resolution 004-2023.”

Administrative Finance Chairman Wayne Ardoin questioned, “Do we need a motion for that? It is the Hazardous Mitigation Plan.”

A motion was made by Councilman Timmy Lejeune, seconded by Councilman Easton Shelvin to forward to Regular Meeting held on Wednesday, February 15, 2023 to approve Resolution 004-2023. Parish President Jessie Bellard stated, "Mr. Chairman, regarding this resolution the 7 Parish Region that is with the Acadian Planning Commission with the addition of Allen Parish and Jeff Davis Parish is trying to form a Coalition to bring to the Legislature to pass and it gives that Coalition the Taxing Ability to Tax and also create the division to build a Juvenile Detention System within that 9 Parish Region. That is strictly for those 9 parishes and strictly for a 72 hour hold which is what happens now. Right now we don't have a place to send out Juveniles so we have to send them to Alabama and that cost us \$300.00 plus dollars a day if they will take them. Our Judges are asking for some help on this issue and pretty much everybody that is in our Judicial System and 9 of those parishes. So this is just a Resolution to support the Legislation. It is not creating the tax or anything. It is just supporting that it goes to the State for them to approve. When that is done then we will come back to the table."

Councilman Jerry Red Jr., stated, "Mr. Chairman, my only question is it is going from District 10 to District 1, is that a problem? Would that be a problem?"

Parish President Jessie Bellard stated, "I think that it will but if I am not mistaken Mr. Mike Hefner will be at our full council meeting to address another issue dealing with the polling locations and the prescient changes. That might be a question that we can ask him."

Administrative Finance Chairman Wayne Ardoin questioned, "At this time are we going to hold off until the question is answered?"

Councilman Harold Taylor stated, "We can still forward it to the Full Council Meeting."

A motion was made by Councilman Harold Taylor, seconded by Councilman Jerry Red Jr., to forward to Regular Meeting held on Wednesday, February 15th, 2023 to approve Resolution No. 003-2023. 12. Discuss who has the authority to escort a speaker out of a meeting. (Councilman Wayne Ardoin).

Administrative Finance Chairman Wayne Ardoin stated, "I ask this question and I was made aware that it is the Chairperson that will ask security to remove anyone, am I correct Mr. Duplechain?"

Legal Counsel Garrett Duplechain stated, "I happen to have here a copy of our Home Rule Charter and the Hand Book of Internal Rules for the Council. It was passed by an Ordinance by the Council. Section 2-06 states that the Chairman or Chairwoman shall preside at council meetings supervise and delegate supervision of council employees and carry out any other duties. The chair shall preside at council meetings. In the Hand Book of Internal Rules for the Council passed by the council Section 2-1.0.2, Powers and Duties of the Parish Council, the Chairman shall preserve decorum and order speak to points to order in preference to other members and decide all questions of order subject to however to appeal to the parish council. So it says the chairman shall preserve decorum and order in the council. 6B states, every official shall confine himself to decorous language and behavior in addressing chairman and shall make no personal or derogatory remarks to or any other member of the council. This does pertain to members of the public who are in here. During any one meeting failure to comply with the orders of the presiding officer first offense, reprimand, second offence, ejection from the meeting for a specific period of time. So that puts an incumbent upon the Chairman to enforce the decorum in the order that includes members of the public who are inside of the council chambers during a meeting."

Councilman Harold Taylor stated, "The rules are pretty clear. I think that we understand that it is the Chairman's position and job to have decorum ordered in the chambers."

Councilwoman Mildred Thierry questioned, "Mr. Chairman, I am glad that this statement was brought up because it was questioned why when someone is removed from the meeting I did not ask why it was done. I would like for it to be made clear that we as councilmembers don't have that authority to say who is removed from the audience and who isn't. I just wanted that to be said."

Councilman Easton Shelvin stated, "If I could chime in, if we have someone removed or if someone is removed from the chambers will they be removed from the premises?"

Legal Counsel Garrett Duplechain stated, “The Chambers is the Premises.”

Councilman Easton Shelvin stated, “I am talking about the parking lot.”

Legal Counsel Garrett Duplechain stated, “That is up to Security to maintain the security. So Security makes that decision. Security has to maintain at all cost. So that is really up to Security to determine the level of un-security.”

Administrative Finance Chairman Wayne Ardoin stated, I think it will be a call on Security or the Police Officers that are outside to keep the peace. The main thing is we will not have any interference in our meetings here. The question was asked like Ms. Thierry said was why someone was removed and the Chair never recognized that the person needed to be removed.”

Councilwoman Mildred Thierry stated, “So just to be made clear that we as councilmembers don’t have that authority to do so.”

13. Discuss any other business properly brought before this committee.

Councilman Harold Taylor stated, “Mr. Chairman, just a request from Administration. Mr. Bellard, I have a copy of the Ordinance. It was actually converted to a loan. It was a line of credit that was done September 30th, 2020. I would like to get the details of the particulars of how this got to be converted, who converted it and a list of the first and the last check that was written on it. Just so when we do our 2023 Budget we can understand how this is going forward.”

Parish President Jessie Bellard stated, “Okay.”

Councilman Harold Taylor stated, “I will get a list to you.”

Councilwoman Nancy Carriere stated, “I just wanted to ask our Legal Counsel Mr. Duplechain a question. You mentioned last night about getting some information from the NACO somebody about the \$350.00. Is that still necessary? Or can we just go and get that opinion like we did. Last night it was asked about Mr. Pitre, what did he think about the 7 votes? I know you said that we were going to be paying someone to give us that opinion and that would cost us \$350.00 per hour.”

Legal Counsel Garrett Duplechain stated, “To receive the letter from Tim Winn of Parliamentary Consulting he charges \$350.00. It is not necessary that the council do that transaction to pay \$350.00 and get the letter. The council can just proceed as it always has or seek an opinion from an Attorney General or someone may want to file a lawsuit to get a Judge to decide that. The council can proceed without paying \$350.00 to get the letter from Parliamentary Consulting.”

Councilwoman Nancy Carriere stated, “I was just saying, it can get expensive for 13 people.”

Legal Counsel Garrett Duplechain stated, “At this time I think a clear reading of the Home Rule Charter on when it takes 7 votes to do anything. If the council wishes to deviate from that they can file a lawsuit. It does clearly say the majority of the membership and the membership is 13 so that means it takes 7 votes to do anything.

Councilwoman Nancy Carriere stated, “So I think because you are stating that and it is in the Charter that should be a done deal.”

Legal Counsel Garrett Duplechain stated, “Well it should be 7 votes to do anything, yes.”

Administrative Finance Chairman Wayne Ardoin stated, “Ms. Nancy, this has nothing to do with Mr. Taylor’s request from Mr. Bellard’s office.”

Councilman Coby Clavier stated, “Mr. Wayne, didn’t you want to add in that Resolution 004-2023. Did you all vote on that?”

Council Clerk Sherell Jordan stated, “Yes we did, that was the first Resolution that we had voted on. It was in Mr. Bellard’s Parish President’s Report.”

Councilman Timmy Lejeune stated, “Last night we sort of spoke about getting a Judge here. What is that process? Would that be faster to determine if it actually have 7 or if the Chairperson should rule if there

are 12 members here. I mean we will never have anything passed. If it is a 6-6 and there is only 12. If somebody skips every month and it is a 6-6 vote nothing will get accomplished in St. Landry Parish. We just started this, we use to not vote on a 7. It was 7 for a full council meeting and majority of the attendees of the council was the ones who declared the vote. Do we go a step further and try to get a Judge to rule on this? What do we do?"

Legal Counsel Garrett Duplechain stated, "The council has have that option to get a ruling on it."

Councilman Timmy Lejeune stated, "Do we need a motion on that?"

Councilman Harold Taylor stated, "Declaratory Judgment."

Legal Counsel Garrett Duplechain stated, "You will need a motion if you want to get an Attorney General's Opinion."

Councilman Harold Taylor stated, "I don't think he wants an Attorney General's Opinion. He wants the courts to decide whether or not it takes 7 votes or less. That would require a legal Declaratory Judgement or what?"

Legal Counsel Garrett Duplechain stated, "The Declaratory Judgement would come from a Judge."

Councilman Harold Taylor stated, "Would this be where this would have to go to get that done."

Legal Counsel Garrett Duplechain stated, "From a Lawsuit filed in the Courthouse."

Councilman Harold Taylor stated, "Typically speaking because the 27th Judicial District has a conflict because we fund then. They would probably get an Independent Judge or they could kick it up to another parish or what."

Legal Counsel Garrett Duplechain stated, "That I do not know. That is up to the Judges."

Councilman Harold Taylor stated, "The second issue was regarding the Home Rule Charter as it pertains to Adopting Budgets and Amending the Budgets. You made the statement that we were following the Revise Statue but the Charter is a little stricter than that. It says that we have to pass a Budget the month before the final meeting of the year. It says the same thing for the Amendments. I would like to include that in the Declaratory Judgement. Have the Judges Rule on the Home Rule Charter regarding that."

Legal Counsel Garrett Duplechain stated, "Yes that is procedurally possible to put whatever issues you want inside that."

Councilman Harold Taylor stated, "I offer a motion to the full council. We would like to read the judgement before you send it up if you don't mind Counselor. The last time that we sent one up to the Attorney General it did not apply to the question, so I am being pretty blunt about it. If you are going to do this we would like to read it before you mail it or bring it to court. Do we understand?"

Legal Counsel Garrett Duplechain stated, "Right."

Public Works Chairman Dexter Brown questioned, "Mr. Lejeune, regarding the 7 votes can you repeat what you said."

Councilman Timmy Lejeune stated, "I don't understand your question Mr. Brown but last night we had a vote and it was 6-5 I will say. I don't remember the number but I will use that as an example. Because it was not 7 it did not pass because the majority of the council was not here to vote so therefore it ended up with a 6-5 vote. Therefore if we continue in that path nothing will get accomplished. We need to have clarity. It takes 7 people to have a meeting, of those 7 if you have 5 of them that says 'yes' and two of them that say 'no' then the whole agenda is null and void. We have to have an understanding that it takes only 6 or the majority of the present is the ones that carries the vote and that is what we need to know. This is the second or third time that it has happen."

Councilwoman Mildred Thierry stated, "Instead of us going backwards and forward, backwards and forward with this same issue we need to decide whether we are going to go with the majority present or if we are going to go with that 7 votes. We need to make a decision and stop continuing to throw it around. We are not accomplishing anything."

Administrative Finance Chairman Wayne Ardoin stated, “Is there anything you want to add on to this motion that Mr. Taylor is offering?”

Councilwoman Mildred Thierry stated, “I don’t remember what Mr. Taylor’s motion was.”

Administrative Finance Chairman Wayne Ardoin stated, “Let her read the motion. If you want to add something onto it I will recognize you. Would you read the motion Ms. Sherell?”

Legal Counsel Garrett Duplechain stated, “Can I make a suggestion?”

Administrative Finance Chairman Wayne Ardoin stated, “Go ahead Mr. Duplechain.”

Legal Counsel Garrett Duplechain stated, “This needs to be in a form of a Resolution which would be passed at the full council meeting. That way the council will see the Resolution and read the whole resolution as to any lawsuit and this is in the lawsuit, this will be filed, this is what they want to know and this is the whole deal.”

Councilman Harold Taylor stated, “Perfect.”

Legal Counsel Garrett Duplechain stated, “So the Resolution needs be ready two weeks from now right? So you all will do that motion order and two weeks from now we will have the Resolution. The motion should read to pass to full council meeting a resolution to go to District Court to get a Declaratory Judgement on how many votes are required for the council to take any action on something and to decide on the Home Rule Charter.”

Councilman Harold Taylor stated, “Add Section 502 and 504.”

Councilman Jerry Red Jr., stated, “And that is pertaining to the budget is that correct?”

Administrative Finance Chairman Wayne Ardoin stated, “That is pertaining to the budget when it is adopted.”

Councilwoman Mildred Thierry questioned, “I thought we were talking in regards to the number of votes that it takes to pass.”

Administrative Finance Chairman Wayne Ardoin stated, “That is part of it.”

Councilwoman Mildred Thierry stated, “Does it have to be that complicated that it has to go through a judge? Can’t we as a council do a Resolution and state that? This is just my opinion or suggestion.”

Legal Counsel Garrett Duplechain stated, “Ms. Mildred, I have the answer to your question. What Tim Winn from Parliamentary Consulting verbally told me and the clerk is that a Chairman can make that decision. If the chairman won’t the council can vote on it. We don’t have that on paper. That is what was told to us. This council can basically make its own in house rules if they want to or it can go to court to get a Declaratory Judgment. It is really up to you all but that is what was verbally told to us by Parliamentary Consulting. Because of the way a Home Rule Charter is written a chairman can decide if it takes 7 votes or not or the council can vote on it. We don’t have that on paper from Parliamentary Consulting. That was just verbally told to us. So you all want you might want to go and get a Declaratory Judgement from a Judge.”

Councilwoman Mildred Thierry stated, “So can we write up a Resolution stating that the majority of the councilmembers present, would that be legal?”

Administrative Finance Chairman Wayne Ardoin stated, “Ms. Thierry, we are bringing it to the full council. So if you do not want to vote on this item then you can vote Nay. Am I correct by saying that Mr. Duplechain? She is on the other end. I can barely hear her over there but I understand what she is trying to say. We will bring it to the full council and it will be a Resolution to bring it for a Declaratory Judgement in the 27th

Judicial Court. Correct. With the two items dealing with the Budget.”

Councilwoman Mildred Thierry stated, “I know that Mr. Ardoin.”

Legal Counsel Garrett Duplechain stated, "A Resolution voted on by council I am sure that our clerk will e-mail the Resolution to you all along before the meeting so everyone can read it and see if it is in there what they want."

Councilman Harold Taylor stated, "Just a reminder, Sherell placed the Home Rule Charter Book on our desk, you may want to read about that before you take a vote on it. It is pretty plan to me, I am not a lawyer I am just a layman. It is pretty plan that you need 7 votes to pass any instrument through the council. Let's get the courts to decide and that will be the law. If they say it will take 6 or 5 or 7 votes I am good with it but the people voted on the charter and they said they wanted to see 7 votes on any instrument that we pass. So we will leave it up to the courts. An opinion is an opinion, it does not mean anything but the courts is going to rule on it. That is what we are asking."

Councilman Jerry Red Jr., stated, "My only question is this, Ms. Thierry at the full council meeting you will get an opportunity if you want to let it go to the Judge or if you want the council to allow the Chairman to make that decision. You have either/or, okay."

A motion was made by Councilman Harold Taylor, seconded by Councilwoman Nancy Carriere to forward to Regular Meeting held on Wednesday, February 15th, 2023 to approve Resolution No. 005-2023. A Resolution to go to District Court to get a Declaratory Judgement on how many votes are required for the council to take any action on something and decide on the Home Rule Charter and Add Section 502 and 504 pertaining to the budget.

On roll call vote: YEAS: Jerry Red Jr., Nancy Carriere, Easton Shelvin, Harold Taylor and Timmy Lejeune. NAYS: None. ABSENT: None. ABSTAINED: None.

Motion forwarded.

Parish President Jessie Bellard stated, "Mr. Chairman, I have a question for Mr. Duplechain in regards to that property. If we have to bring it to court to have that title reversed or however that case maybe, shouldn't it come before the council?"

Legal Counsel Garrett Duplechain stated, "That would be standard procedure to have the council pass that Resolution and that would kick off the lawsuit."

Councilman Jerry Red Jr., questioned, "What are we talking about?"

Administrative Finance Chairman Wayne Ardoin stated, "The one on item number 9. Authorize for the cell tower. Is that what you are talking about?"

Parish President Jessie Bellard stated, "No sir, we will have a potential issue with a piece of property that was sold that we will probably have to ask the courts to step in and reverse that sale. So I was asking him to find out if we have to do that through Parish Council or what is the procedure. I just wanted to make that clear."

Administrative Finance Chairman Wayne Ardoin stated, "Are you are talking about the people that come here from Leonville at every meeting? That would be Mr. Alvin's District. You did not make it clear what it was."

Parish President Jessie Bellard stated, "Yes. I just want to ask this question of the committee. If it needs to get to a Judge or to a court to reverse that sale, that is my question for Mr. Duplechain. I think that is the route that we will have to take for that to take place, I am just letting you all know that that is a potential lawsuit that will happen."

Councilman Harold Taylor stated, "Just for clarity, Mr. Duplechain what are your thoughts? Do we need to take this to the courts to have it decided?"

Legal Counsel Garrett Duplechain stated, "Yes, there is a Conveyance Recorded in the Courthouse which has a Record Owner of the property. The only way to reverse that, because we are not going to sell a piece of property twice, is to have the sale invalidated. It is just like when you acquire a clear title on a piece of property you have to go to a Judge for that because it is recorded in the courthouse. Then after that the property will revert back to the parish and the parish can do what it want with it."

Councilman Harold Taylor stated, "So the issue is we have two owners, is that what you are saying?"

Legal Counsel Garrett Duplechain stated, “We had a sale of Adjudicated Property and it went to the person who bought it but it was an invalid sale. It is like if I try to sell your house I could not do it that is an invalid sale, I don’t own it. Conveyance is recorded and that has to be removed.”

Councilman Harold Taylor stated, “You are suggesting that we ask the courts to decide this, is that your recommendation?”

Legal Counsel Garrett Duplechain stated, “Yes, exactly the similar kind of lawsuit as when you acquire a title to determine who owns the piece of property.”

Administrative Finance Chairman Wayne Ardoin stated, “Mr. Bellard, what you are asking is to put that in a suite that we are talking about.”

Parish President Jessie Bellard stated, “It will be a separate one. I was just getting clarification. If we have to do it tonight to the full council I would like to see a draft brought to the full council and then at that time make a decision whether we go forward or not.”

Legal Counsel Garrett Duplechain stated, “So there will be a full council meeting this month and there will be 2 Resolutions. One Resolution for a Declaratory Judgement and there will be another Resolution to Proceed with the Lawsuit to invalidate an invalid sale. Two Resolutions.”

Councilman Jerry Red Jr., stated, “Mr. Duplechain this is the same property that you kept telling us time after time that someone purchased that property and it is in their name. Is that correct?”

Legal Counsel Garrett Duplechain stated, “That is right. The person who purchased the property is the record owner until more information came to light. In light of the new information it did not have the authority so it was an invalid sale that the statutory procedure for selling adjudicated property was not followed. Once that information came to light it is an invalid sale and that changes it. That person is still the record owner but we have to go to the court to invalid that.”

Councilman Jerry Red Jr., stated, “How can you get this council involved in that when that is between them and the owner. Why they can’t handle that themselves in courts? This council don’t have to have anything to do with that.”

Legal Counsel Garrett Duplechain stated, “The Parish Government sold the property. There is the Vendor and there is a Vendee and the Parish Government was the Vendor so we are already involved in it. The lawsuit could be filed by anyone. It could be filed by any interested party.”

Councilman Jerry Red Jr., stated, “At the same time. The one that purchased that property and the one that had the opportunity to purchase the property did not do it so it is between them two.”

Legal Counsel Garrett Duplechain stated, “You could have a private lawsuit a civil lawsuit between those two private individuals but the Parish Government have to be ready to move on it because we are the Vendor and it involves us.”

Councilman Harold Taylor stated, “So, how are we involved in this thing? Why are we in the middle of this?”

Legal Counsel Garrett Duplechain stated, “Every sale has a Vendor.”

Councilman Harold Taylor questioned, “No, No. Did we sell the property twice? The same property twice? Is that what we did?”

Legal Counsel Garrett Duplechain stated, “We sold it once. But the Statutory Procedure for selling Adjudicated Property have to be followed and they were not followed. That information came to light and we need to take action. We should take action on this.”

Councilman Alvin Stelly stated, “That property was sold twice. It was sold twice.”

Legal Counsel Garrett Duplechain stated, “Mr. Lee never had a Conveyance executed.”

Councilman Alvin Stelly stated, “There was no time limit. He tried to get in touch with Parish Government. Mr. Richard would never answer his phone. So how do they get paperwork done when the courthouse don’t answer their phone? There was no time limit.”

Legal Counsel Garrett Duplechain stated, “The paperwork was not done by Mr. Lee. It is no fault of Mr. Lee but his Conveyance was not done.”

Councilman Alvin Stelly stated, “This property should have never been put back on the market before they talked to the first people that bought it. I am sorry.”

Councilwoman Nancy Carriere stated, “I am familiar with this situation. I did some research, actually we have 3 properties that that has happen with. I am wondering how you all will handle this because we have two others.”

Legal Counsel Garrett Duplechain stated, “I know of Mr. Lee.”

Parish President Jessie Bellard stated, “Mr. Duplechain, I would ask that we keep it on this one piece of property. I understand where Ms. Carriere is going but if we can keep it on one piece of property and go from there. I just don’t think that it is the right place to talk about the other pieces of property just yet. I will provide the information to the council and I will even provide the information for this one so they can see what we see to justify the court interference, I guess if that is what you want to call it. At this time I would like to see the council and the committee stick to this one just for right now because that is the one that has been coming up every month. I am just asking that if we have to bring it to court it has to come before this council for that to happen, am I correct?”

Legal Counsel Garrett Duplechain stated, “That is correct.”

Parish President Jessie Bellard stated, “I will ask the committee if this is possible.”

Administrative Finance Chairman Wayne Ardoin stated, “I have a motion to forward that certain piece of property. Do you want to put an item on it, do you want to identify it by any kind of way?”

Parish President Jessie Bellard stated, “I would ask that the draft of the court proceeding be brought to the council ahead of time so you all will see the full picture before voting on the 15th.”

Councilman Harold Taylor questioned, “Counselor, Is that a Resolution that you need?”

Legal Counsel Garrett Duplechain stated, “It is a Resolution. A Resolution authorizing lawsuits are very basic. They just authorize the lawsuit.

A motion was made by Councilman Harold Taylor, seconded by Councilman Timmy Lejeune to forward to Regular Meeting held on Wednesday, February 15th, 2023 to approve Resolution No. 006-2023. A Resolution to Proceed with the Lawsuit to invalidate an invalid sale. On roll call vote: YEAS: Easton Shelvin, Harold Taylor, Timmy Lejeune and Administrative Finance Chairman Wayne Ardoin. NAYS: Jerry Red Jr.

ABSENT: None. ABSTAINED: Nancy Carriere. Motion forwarded.

Council Clerk Sherell Jordan stated, “We have 3 ‘Yeas’ and one ‘Nay’ and one Abstain.”

Councilman Harold Taylor stated, “Technically doesn’t an abstention count as a ‘No’ vote? Did you vote Mr. Ardoin?”

Administrative Finance Chairman Wayne Ardoin stated, “If I need to vote, I will vote to break the tie and I will vote ‘Yea’. These people have come to this meeting numerous times and it is time to take care of the Tax Payers in St. Landry Parish. Mr. Bellard if you have any others that we have a problem with I would like for you to bring them up so that we won’t have all of this. It is not making us look like some good providers for the Tax Payers of St. Landry Parish.”

Parish President Jessie Bellard stated, “This one issue is what I am discussing tonight. To my knowledge there is no other issue right now. I am not saying there is none I am just saying to my knowledge right now I don’t have any.”

Councilman Harold Taylor stated, “My main question is: Have we resolved this issue where it won’t happen again going forward? Is there something that we need to pass in legislation?”

Parish President Jessie Bellard stated, “I will be bringing some more information to the council. I have put a halt on selling any adjudicated property until further notice until we can put a different procedure in place and I will bring it to the council at that time.”

Administrative Finance Chairman Wayne Ardoin stated, “You sent an e-mail out this week that there is an investigation going on with the sale of Adjudicated Property, am I correct? Everybody got a copy I think. Do you care to elaborate or you are going to ask this council to do the investigation? If I read the Home Rule Charter right we are the ones that had to ask for an investigation.”

Parish President Jessie Bellard stated, “This investigation is going to be conducted by the Auditing Firm, Darnall Sikes through the Legislative Auditors Office.”

Administrative Finance Chairman Wayne Ardoin stated, “So you are going to give us a report on this thing later?”

Parish President Jessie Bellard stated, “Most definitely.”

Administrative Finance Chairman Wayne Ardoin stated, “I have an issue. I have an issue Mr. Bellard where a piece of property was sold to an attorney that deals with some of our sales. That piece of property has never been cleaned. It has never been cleaned and I brought it to Mr. Richard Lewis attention not once but twice. It is right behind the Wildlife and Fisheries Office. It is sad that when it gets sold because someone else wanted it. The man that lives in the neighborhood cut the grass and wanted to buy it for his granddaughter and the attorney ended up buying it. It has never been cleaned and it got sold about two months ago. I brought it to that gentlemen that sits in that chair by you.”

Parish President Jessie Bellard stated, “I agree, here is the issue. Just because we award the bid does not mean that purchased the property yet. They don’t have the legal right of the property yet. I has to go through a process so it could be up to six months.”

Administrative Finance Chairman Wayne Ardoin stated, “Could you get your people, Code Enforcement to go and clean the property. These people don’t deserve that on that street.”

Parish President Jessie Bellard stated, “I will take care of that on our end.”

Administrative Finance Chairman Wayne Ardoin stated, “Okay, thank you.”

Council Clerk Sherell Jordan stated, “We still have to vote on another Resolution. Garrett stated that he has to draw up two different resolution for it.”

So will we be looking at a meeting in the near future?”

Parish President Jessie Bellard stated, “Yes, if I’m not mistaken Mr. Hefner will be here on the 15th and at that time we should set up something for the full council to voice their opinions and concerns and get back to the drawing board. I think we have 56 precincts that have lockouts on them meaning several precincts vote on one machine and the lockout have to be done by the commissioner. So if the commissioner makes a mistake, it’s a possibility that the person could vote for the chief of police in Opelousas but they live in Plaisance. I’m not saying that happened I’m saying that’s a subject that could happen. It’s to my understanding that Mr. Hefner can help fix a lot of those issues. I don’t think we can take care of all of them as far as the lock outs are concerned but we could limit our possibility of problems and that’s the best way to start.”

Councilwoman Mildred Thierry stated, “Also in the Washington area we had some constituents who called regarding their precincts and polling locations. Are we going to be dealing with that soon?”

Parish President Jessie Bellard stated, “Yes, Mr. Hefner will be here soon and I think that’s the time and person we need to speak with regarding those concerns.”

Councilwoman Mildred Thierry stated, “I don’t want it to go too far then we told it’s too late.”

Councilman Alvin Stelly stated, “If I’m not mistaken they will change a lot of those precincts back to what they was before.”

Parish President Jessie Bellard stated, “I will suggest that we have paper maps so that we can see them better.”

Councilman Wayne Ardoin stated, “If I’m in order I would like to ask that Mr. Byron Stelly our new Register of Voters also be advised of the meeting and be present whenever Mr. Hefner is here for our February 15, 2023 meeting, I would like to offer that in a motion.”

A motion was made by Councilman Wayne Ardoin, seconded by Councilman Alvin Stelly to invite our Register of Voter Byron Stelly to attend our Regular Meeting held on Wednesday, February 15th, 2023. On roll call vote: YEAS: Mildred Thierry, Gil Savoy, Alvin Stelly, Jimmie Edwards and Coby Clavier. NAYS: None. ABSENT: None. ABSTAINED: None. Motion forwarded.

Councilwoman Nancy Carriere stated, “I would like to make a suggestion when Mr. Hefner comes he’s coming in a meeting and we will have other business on the agenda at that time. I suggest that we have a special meeting with Mr. Hefner and Mr. Stelly that way they can address each one of us individually and not a rushed time during a meeting.”

Public Works Chairman Dexter Brown stated, “Ok so we would have to check both schedules for Mr. Hefner and Mr. Stelly.

Parish President Jessie Bellard stated, “In regards to that, I think it would be a lot faster if the Chairman or myself would call a special meeting than waiting for full council to make a motion and everything else. I want to make sure we don’t wait until the last minute.”

Councilman Timmy Lejeune stated, “If you all going to put it into a motion can you please add that they contact each council member and have a conversation over the phone to get everything organized per district so when they come they have something to look into.”

Public Works Chairman Dexter Brown stated, “Mr. Lejeune if you don’t mind would you let Ms. Sherell get that in order for us that way when they come she can coordinate those meetings.”

Councilman Timmy Lejeune stated, “I’m good.”

Public Works Chairman Dexter Brown stated, “So Mrs. Mildred we’re good.”

Councilwoman Mildred Thierry stated, “Yes.”

Public Works Chairman Dexter Brown stated, “Thank you mam.”

11. Discuss any other business properly brought before this committee.

Councilman Wayne Ardoin stated, “Mr. Bellard are you getting any reports of anywhere else in the parish about missing signs.”

Parish President Jessie Bellard stated, “Unfortunately, it’s been happening a lot we even changed the bolts that we use and everything else but the people are just cutting them. We even put some special stuff on the sign that way when they will grab it they will be stuck to it.”

Councilman Wayne Ardoin stated, “I’m noticing in District 9 that some signs were up last week and this week they are gone and I’m just wondering if it’s like that everywhere else.”

Parish President Jessie Bellard stated, “It is.”

Public Works Chairman Dexter Brown stated, “Mr. Ardoin, four year ago I was going to go on Passe Partout to discuss that matter. They said due to an election year we cannot go on Passe Partout because it is basically like free air time. I am just saying Channel 10 but if we can go on Channel 3, KLFY in Lafayette just to ask the public to help with the awareness of how important these signs are to the public

especially in any area but in the rural area where I stay. When we have ambulance drivers looking at a GPS while they are coming to a house and you have no stop sign or no road sign. If we could get as a group all 13 of us and the Parish President to go on Passe Partout one morning or Good Morning Acadiana, Channel 3 or whatever just to spread the awareness that it is very important to our community to have these signs in place and talk to the constituents that live in the parish on how important it is to have these signs. That is something that we can discuss in the near future.”

Administrative Finance Chairman Wayne Ardoin stated, “I wanted to find out if there were any other areas. I am just asking Mr. Bellard to please correct whatever we can correct. There are too many of them missing. When it comes time for the Ambulance, the Police or the Sheriff’s office to be available to find that street is bad.”

Councilman Alvin Stelly stated, “Mr. Bellard, I was notified today. They would like to place Culverts that goes into the yard of that Culvert Smith’s Place on 93 from the Half-way-House Road. Those trucks are taking Half-Way-House Road and getting to the dead end and they can’t turn. Do we have any problems with that?”

Parish President Jessie Bellard stated, “I will get Barry to go out there and talk to them. We will be able to do whatever we can to help them. That is Half-Way-House Road that you are talking about, right.”

Councilman Alvin Stelly stated, “Yes, give them an entrance to go in.”

Public Works Chairman Dexter Browns stated, “Mr. Alvin, you stated that will be for their trucks to turn in?”

Councilman Alvin Stelly stated, “For the trucks that are picking up Culverts, the 18 wheelers.”

Public Works Chairman Dexter Browns stated, “Mr. Bellard if you can get together with the Culvert people, the people that make culverts and ask them to cut us a deal on the culverts if we can put down cement culverts.”

Parish President Jessie Bellard stated, “We bid out the culvert the culverts for the Parish Government to buy. I will get Barry to talk to them. That won’t be a problem.

Mr. Bobby Ardoin, St. Landry Now stated, “You and a lot of other public officials in this parish can’t wait to run to Lafayette Stations to talk about things. You have two local media representatives here. Do you see any of these television stations here at this meeting? Do they ever come here, no. It is us, my website St. Landry now which as of last November had 2.2 million viewers on our website. Since January we have had 1.1 million. Mr. Kirgan has Eunice News which is the Official Journal of this Parish and yet you want to go to Lafayette. I am not just talking about you, I am talking about other City Officials in Opelousas. You all can’t wait to run to Television but if no one is watching that particular program you won’t get any publicity. That is all that I have to say.”

Public Works Chairman Dexter Browns stated, “I apologize for not mentioning you. I would hope that you all would report that we have a client issue in the parish and put in on your website and broadcast it to the public. Thank you sir.”

12. Adjourn

A motion was made by Councilman Jimmie Edwards, seconded by Councilman Coby Clavier to adjourn the Public Works Committee Meeting.
