#### REGULAR COUNCIL MEETING MINUTES

The Council of the Parish of St. Landry, State of Louisiana, convened in a regular session on this 19<sup>th</sup>, day of October, 2022 at 6:00 p.m.

- I. Vice Chairwoman Nancy Carriere called the meeting of the St. Landry Parish Council to order.
- **II.** Councilman Easton Shelvin lead the Pledge of Allegiance & Invocation.
- III. ROLL CALL: Jerry Red Jr., Nancy Carriere, Easton Shelvin, Mildred Thierry, Harold Taylor, Gil Savoy, Alvin Stelly, Wayne Ardoin, Dexter Brown, Timmy Lejeune, Jimmie Edwards and Coby Clavier. . ABSENT: Ex Officio Vivian Olivier

Madam Chairwoman Vivian Olivier was late for roll call but later joined the meeting.

Councilman Wayne Ardoin stated, "Madam Chair, if I am in order I will ask that we amend the agenda to deal with two items which are both the same situation. It is about getting some blighted property taken care of as far as grass cutting. It deals with 664 Don Guilbeau Road. It was brought up here before. It looks like there is nothing that is being done. Mr. Duplechain said for us to amend the agenda and also deal with 121 Cook Street in Morrow Louisiana."

Legal Counsel Garett Duplechain stated, "As far as the timeline for these two Blighted Properties is on track. Following the Ordinance step by step, the next step this evening is to amend the agenda and put this on. It should be inserted in the Public Comment Section to see if the two individuals are here. They may not be here and then the council can vote to go forward with it from there."

**Councilman Wayne Ardoin stated,** "I am asking to amend the agenda to deal with these two items and I want to add to the agenda the blighted property at 927 McNeese Street for demolition. The Blighted Property of Mr. Ernest Broussard and Mr. Lawrence Ricard which the one on Mr. Broussard is at 664 Don Guilbeau Road and Mr. Ricard is 121 Cook Street in Morrow.

A motion was made by Councilman Alvin Stelly, seconded by Councilman Dexter Brown to amend the Agenda to add three additional items regarding the properties at: 927 McNeese Street, 664 Don Guilbeau Road and 121 Cook Street in Morrow.

Councilman Jerry Red Jr., stated, "You are welcome."

Madam Chairwoman Nancy Carriere stated, "Now we will do the Obituary."

## V. PERSON TO ADDRESS THE COUNCIL:

- Mr. Mike Francis, Public Service Commissioner:

  Council Clerk Sherell Jordan stated, "Mr. Francis called and stated he will come to the next Committee Meeting. He had a prior engagement that came up."
- Judge Valerie Gotch Garett, Candidate for 3<sup>rd</sup> Circuit Court of Appeal Judge addressed the council. She stated, "Thank you for allowing me an opportunity to address your council. It is my humble privilege to do so. Thirty years ago I began my legal career right here in St. Landry Parish and in Evangeline Parish. After the hurricane I went to work for Legal Services and Legal Services allowed me to serve as a Pro-Bono Attorney for the Parish of St. Landry and for Evangeline. Right out of law school now, I have to tell you that I went to law school later in life. I taught school, I ran a business and then went to law school later in life. At the age of seven I was told that I could not be a lawyer when I was in Public School. That is before I went to Catholic School and they told me that I could do anything that I wanted to do. With that in mind I went to law school later in life with two kids. I started off my career at Acadiana Legal Services. By the time I did that, I was not uneasy to come to St. Landry but I was terrified to go to Evangeline. At that time they had Judge Soileau over here and Judge Soileau believe the law was what he said and not what was in the law books. Soon Judge Soileau and I became, I guess not friends really, but he respected the fact that I held my ground and what law said I was going to make him realize whether I took it at the lower level in District Court or I took it to the Appellate Court, I was going to stand my grounds and follow the law. I earned, not necessarily a friendship of Judge Soileau, I earned, Judge Aucoin also, he was more difficult but I earned their respect. That taught me a valuable lesson. It taught me that hard work pays off, respect of people and supporting and fighting for those who could not was my calling. I realized that was easier to do than any other job I had done. So my teacher was wrong, I was good at what I did. Soon with the encouragement and the backing of Legal Services we came in and we helped the most indigent and underserved community of St. Landry and Evangeline. I also traveled to Iberia Parish and that began my true understanding and value for the Legal System and for people rights. In my career I have learned that the Constitution is so valuable. The Constitution that when we say the Pledge of Allegiance, I am sitting in the 15 JVC, and every time I stand in open court, I say the Pledge of Allegiance. I recognize that what I did at the moment really resonated with me when my second to the oldest got his masters, I am kind of telling my age a little bit, but my second to the oldest got his masters from Southern, he decided to go into the

Military. After all the money that I spent to send this young man to school, he wanted to go into the Military. I was like, are you sure, what are you going to do over there? I had no appreciation even though I had Military people in my family that had pre deceased. My son sat and said I got a call from God and I am going serve my country. When I saw the men and women complete this training and come from the woods, I saw my young son who had now became a man, coming through those colors with the Soldiers, it was a moment that I will never forget. So the Pledge of Allegiance, the Constitution and the Bill of Rights are the things that we hold in this country so dear and valuable. That is why I come before you now to let you all know why I want to be the next Third Circuit Court of Appeal Judge. It is because of my value for the Constitution, my value for all that serve our country, my for the rights of our citizens and our people is why I want to serve. I serves as a District Court Judge and I love what I do. I come to realize it is a gift. I had revocations today. Revocation Doctor is where you decide if people go to jail or not and some went to jail but some we were able to do creative thinking and it comes from a true passion to serve that I have. Before I decided to run for the Third Circuit Court, I called all the Judges that I knew that had retired. I consider Judge Harris to be a friend and I called him first. I asked him if he would run and he told me no. I called Judge Edwards who had retired and he said no. I called them all. My opponent is sitting here, I called her as well and she said I don't think so. So that meant in that seat, nobody was going to run. I fought and I fought because that would mean that I would leave where I am now and go higher. I serve as a Drug Court Judge. Every Tuesday Night from 4:00 p.m. to 7:00 p.m. I am in Drug Court. If something goes wrong on the weekend, they call me, I am there to serve. So I say this all to you to say, one might tell you the largest percent of this race comes to St. Landry Parish and it does, we have never had a race in 30 years so we really don't know what our true numbers are. It does and your vote is valuable and I don't believe that anybody should vote a long line. Look at my credential, look at my service years, look at what I have done in the community, look at the things that I have done in my court, look at Lafayette Regional Airport where I have served 12 years. My staff thought I was working there and getting paid. My last four years I worked as a Chairwoman, bringing that new Terminal in. They told me that I could not turn dirt on it, I did, I went to Washington and let me tell you something, I served with some men and I was the only girl on the team. But I learned to work with the men and they thought me a lot. My favorite is Mr. Guilbeau, Paul Guilbeau. We drove that airport in and I don't know if you all know but it is debt free, we don't owe a dime. We get a one cent sales tax, we campaigned on it, we shut it down at a certain time and we start it at a certain time. We went to Washington, we matched the money, you know, New Orleans did not even do it. We matched the money, we saved our own and you have now a beautiful Regional Airport. I created the DBE Policies, there were none, I created DBE Advisory Counsel and I created DBE Group, an ability for people to serve. I say that all to say that I have served. Service is my passion. The Judiciary is honorable, it is humbling, it is meaningful and it is challenging. I would ask that you consider me, even though I am considered an outsider, please consider me on Election Day. Research me, look at my credentials and look at my service to my community on boards that touch across the region and look at my leadership. I am a mother of five, a grandmother of seven. I have two boys that are artistic twins, one get Epileptic Seizures and right before I came here he was sick but I serve. Nobody else that can tell you anything about me, I serve, I serve the people. I believe in the people. When you go to the Third Circuit you make Appellate Law that is important and inclusive to the lives of people. I was happy where I was, there was a challenge to go up and I am ready to receive that challenge. So on November 8<sup>th</sup>, early voting starts Tuesday, on November 8th, consider me Judge Valarie Gotch Garrett, No. 42 on the Ballot. Thank you so much for allowing me to speak to you today."

• Judge Ledricka Johnson Thierry addressed the council. She stated, "Thank you Madam Chair and to the council. I am Judge Ledricka Johnson Thierry, your District Court Judge here in St. Landry Parish. I will say first of all as the St. Landry Parish District Court Judge, I am very humble and honored to have been elected as the First Female District Court Judge. In the northern part of this parish Lebeau Louisiana, I was born and raised there and finished at North Central High School. It is there along with my parents who are both 84 years old, I am very blessed to still have them with me, who have fulfilled a lot of morals and values and hard work. I can comfortably sit here, some of you know me and some may not know me as well but most of you know my story. It is my story. At seventeen years of age I almost lost my life right on HWY 71 in Lebeau.

I was hit by a bus on 71. I have no memory of how that happen or what happen at that moment. At that very time many people that found me on that road said that I continued to say, 'tell God I don't want to die, tell God I don't want to die.' I have to believe that what these people told me happened even though I could not remember it. What it did to me, it connected my Spirituality with my God and I understood that, although I could not understand that I got hit by a bus and not a car. This is different for a seventeen year old to process but I understood that God left me here for a reason. I did not understand necessarily what purpose and what capacity he was going to use me in but I have always stepped up to the challenge. When I recovered from that injury at nineteen years old, I was working with Habitat for Humanity, I was working with Amar core. Every parish that I have resided in whether it was just to undergrad for college or law school, I did service. Upon graduation I returned back to my parish, St. Landry Parish. In 2005, I clerked for Judge Alonzo Harris right here in this same Courthouse Square and I established roots here. I opened a law practice here and I opened an insurance agency here and I also opened a health clinic inspired by my daughter, Madison who has autism and is known as Madison Health Center. In addition to that you have known me before running for office, I did 15 years of free tax services for the residence of St. Landry Parish. We even included Evangeline Parish in those services. Now that I am a District Court Judge, my best friend have decided to take on what I have left behind. I have received an award from the US Department of Treasury for my Public Service back to my Community and the millions of dollars that I brought back to my community during that service. In addition to that you have known me also as a lawmaker, I was the first female District 40 State Representative here. I am very proud of the work that I have done as a State Representative, every baby born in the state of Louisiana tested for hearth defects because of my Legislation. Every person registered as a sex offender is prohibited from being on those social media sites to protect our children. That was requested by State Police. It is a policy that they are not supposed to be on those social sites but without State Law that could be enforced. It was not a popular thing when I did it, I was a Freshman Legislator and since I did it, I was featured on CNN and other States have followed that same law. There is a lady, Davina Chapman, she was thrown over the bridge in Krotz Springs. I don't know if some of you recall that situation but again going back to the injury that I incurred, one of the injuries I incurred from the bus hitting me, I had a ruptured spleen. I lived overnight right here at Opelousas General and they did not even know. When they learned of it, they gave me a blood transfusion and now I am standing here to talk to you today and I survived, well that is one of her injuries. The pathologist believed she lived six hours under that bridge. She had a ruptured spleen, if she would have gotten medical attention in a timely manner then she could have possibly had her life saved. When the family reached out to me, I was at a dinner and they walked over and they took a chance and told me that story. They thought I was not listening but I was listening. The very next day I went to work and I worked on it and we end up compromising on the name of the bill, it is Kelsie Smith Act. I authored it as the Davina Chapman Law. The reason that I did that was, no I could not save her live but I care about people. I wanted to make sure that her death was not in vain. When I offered that Legislation it was to give law enforcement another tool where they can pink a cell phone of an individual that maybe in the same circumstances as her verses having to wait and get a search warrant. When a person life is in danger, we don't have time for a search warrant, we need to be able to locate and find that individual as soon as possible. There are many other stories I could share. I have done Legislation, I got hit by a bus, I have done Legislation to change laws regarding the bus and coming in contact with drivers on the highway. If you look at all of my background, I have always focused on people. At the appropriate time, I have sought office and became the District Court Judge. At District Court Judge, I am a General Jurisdiction Judge. I also preside over Family Preservation Court which means that I am responsible for focusing on administering the K-Plan to try to reunite families that have suffered from substance abuse and try to reunite families back with their children provided that they follow the K-Plan. I am very proud of that and I meet with them twice a month for that program. I also preside over Criminal matters, not just the mild situations such as traffic, I do traffic, misdemeanors and felony including murder. I also do civil matters, some may range in value as low as \$50,000.00 and some of matters that I preside over are valued over \$3 Billion Dollars. Some of the cases that I have had are president cases. When I first took office I called several judges across the state and they said that they have never had situations like that. Every month I was getting unique situations.

Every time I never had a problem stepping up to the challenge and doing the right research and applying the law where I taught it would fit. Several of those matters have been brought before the Third Circuit Court as well as the Louisiana Supreme Court and my decisions were affirmed. So at this time I would not bring this up but since it was brought up in the room, Judge Harris was my person that I replaced and certainly I can tell you and he would certainly confirm what I would say that he had ambitions to run this seat as the Third Circuit Court of Appeals. That is something that we had always discussed for years. He told me recently in June of this year that he was not running for the office. So when my opponent, as she lauded to and stated that she contacted me, she contacted me in the spring of 2021 when I had just taken the Bench for District Court. My response to her was not no but that my Judge and mentor, Judge Alonzo Harris is running for that seat and I would never challenge my mentor. That was my response. When my mentor came to me and told me in June that he has decided because he is on the Washington Bank Board as well as getting retirement that is did not make financial sense for him to do so, then that position was now a place for me to make that decision. That was not an easy decision to make but I will say to you that I feel confident that God as order my steps. The same documents that I pulled for Judge Harris, thinking that he was preparing a run for this race, I am now using those maps and those documents. No it was not in my plans in 2021. In 2021 my job was to be the best District Court Judge that I could for St. Landry Parish. We are gone from that now and at this time what I would say to you is I still believe right at this point if I am elected and if God says the same, I can do three terms which will be 30 years that I will be eligible to sit on a Third Circuit Court of Appeal. The votes for the Third Circuit Court of Appeal does come from majority 48% here in St. Landry Parish and 21% approximately in Lafayette Parish, 22% in St. Martin Parish and 8% in Iberia Parish. Once elected we preside over 21 parishes. Our job is to review the lower court decision. My undergrad is in English Education, everybody knows that I love to read and write. Even as a District Court Judge I sometimes write double digit reasons because I know that they are going to seek review because of the importance of the case. I have always made an oath, everybody knows that a judge or even a lawyer, our job is certainly to analyze the law. I have been on the position where I have the opportunity to create law and now as a judge I can actually uphold the law and apply the facts and evidence as they are presented to me in the court. I do believe at this time with my professional, my educational as well as my personal life experiences it makes me a great fit for the Third Circuit. I have been a small business owner, a wife, a mother of three children but what most important is I am a Public Servant. Judges aren't politicians, we can't promise that I am going to change a road or I am going to fix something, what you want to make sure is that when you come before me you want a judge that you feel has the Judicial Temperament, not someone who gets upset because we have a pass issue or someone who can't be fair. You want to feel like when you come before a Judge you can present your case on both sides and that judge will give your case the importance and listen to each detail so that if you are successful you will know why you won. If you are not successful you will also know why your case did not make it. That is what I do in my court room now. Everybody comes in my courtroom and some of them are nervous because they don't have a lawyer. I tell them you can relax. If you don't have a lawyer, I am patient and I take my time and I try to explain to them that I can't give them legal advice but everybody will tell you in Judge Thierry's Courtroom, I treat you with respect and dignity regardless of what side you are on, you are still people and I attribute that to my humble beginning. With that being said, I will take that same work ethic to the Third Circuit Court of Appeal. I think that at this time I am the right candidate and this is the right time for me to seek this seat and I will certainly ask for your prayers and your support as I am brought from this journey. I will ask that you vote and elect Judge Ledricka Johnson Thierry #43, your next Court of Appeals Judge. Thank you.

Mr. Craig Kidder addressed the council. He stated, "Hopefully no more than two minutes to talk. I have been speaking a lot with Lewis about the Adjudicated Property Process. When someone makes a bid and they have the high bid my understanding is that they have no timeline for the second highest bid to come and collect on the property. We would like for you all to consider putting 90 days or 180 days, whatever it maybe for the second highest bidder to be able to assume control or it goes back to being processed again. I have been waiting six months for one property. The person that won the bid has not shown up, he is MIA. I am ready to assume management of the property and I can't."

- Councilman Timmy Lejeune stated, "Mr. Bellard, what are we doing about this?"
- Parish President Jessie Bellard stated, "It depends on the property, if it is adjudicated for 5 years or more you get the 60 day process you have to do the notices and everything else. If it is 3 years to 5 years, you have to give them 6 months to notify and go thru the proper process and get the affidavit sent to us. We don't have a time frame in which they start that process. They can start it whenever they want to. I don't have a problem with putting 6 months or a year on there but at the same time you have to make that they are doing their due diligence and making sure that they get the system working. I am good with whichever way we have to do it."
- Councilwoman Nancy Carriere stated, "I have been approached with that question also. I think you are asking because you are the next in line. How long the person that received the bid is going to have before they complete their paperwork so that if they don't get it, does the next person in line gets it. I guess the question is, does it go to next in line or does it go back up for bid? Garett if a person wins the bid and they don't start their paperwork, he wants to know also because he is the next highest bidder. Will it go back up for bid or does it goes to the next person that is the next highest bidder?"
- Legal Counsel Garett Duplechain stated, "What the council can do if they choose to set a time limit. If I have the highest bid, I have a certain amount of time to come forward. I don't know what that time would be, whatever is easier."
- Councilwoman Nancy Carriere stated, "I actually thought it was 90 days that they had to complete their work from the time that they did their bid. That is one of the reasons why I requested a policy on the procedures of how we were going to do it because a lot of people ask that question if they only had 90 days. As soon as they get their award letter they had to get their attorney and start that process. At least show you all that they were making that effort. I understand what he is saying that some people figure they got it because they received their award letter and they have not done anything to complete the sale."
- Parish President Jessie Bellard stated, "I don't have a problem amending the ordinance."
- Councilwoman Nancy Carriere stated, "I can make a motion that we can set a time limit and maybe set a rule that if we are putting it back into the bidding process or if we will accept a second highest bid. I also have another question, one of the questions that I have is: What is the time limit that a person can redeem that property? Lately a lot of people have been coming and redeeming after the people have won the bid."
- Parish President Jessie Bellard stated, "The whole purpose of the notices after the sale is to give the property owners their due process. They can come at any time to redeem it"
- Councilwoman Nancy Carriere stated, "I understand that but I am only asking this maybe Garett can answer this question. We advertise it three times, that is almost 3 months that it has been on a roll, it has been on a roll for maybe 5-10 years because it has been sitting there. All of a sudden it is for sale and the people can come up, listen I own property, I would not want to just lose my property, so I understand the process, it is good that we are advertising it three time, I have been checking in other parishes that don't do anything of what we are doing, we are really giving a long time. I understand and I have constituents that have lost the bid because someone came and redeemed it after it was sold."
- Parish President Jessie Bellard stated, "Let me clarify something. It is not sold until everything is done. So just because they are awarded the bid or they have the highest bid, they don't own anything. That goes through the process now where they have to give the notices. A person can come and redeem the property up until the time the affidavit is given back to us and all the process is done. If you all pass an ordinance saying to limit that I will Veto it because the people who owns the property, we have people in the town and in the parish that did not know that their property was adjudicated. We had several people, once they made notice of it, they came and pay. Our goal is to make sure that their taxes are paid and not to sell the property but the taxes are paid."
- Councilwoman Nancy Carriere stated, "I can agree with you on that. I think that we all had an American dream that we would one day own something. So if we own it I can agree that they should be able to have that opportunity to buy it back. All I am saying is let's make the people that is biding aware. As much as you may think, a lot of them and like he thought when is going to happen, you have been watching it. Just like a lot of

the other people, they win the bid and they are thinking I won the bid and now I own a part of this American dream. So I just think when I requested a copy of those policies and procedures it is for me to explain to some of these people that call me and tell them yes you bided on it. A lot of time they are waiting on their award letter to start the next process. So it is like they are waiting on pins and needles so they can hurry and get the lawyer to be able to finish that and go in front of the judge to be awarded that property so they can finally own it. They start all of this paper work and here comes the person to redeem it, it makes it a conflict. We may just need to regroup and get some better policies."

- Parish President Jessie Bellard stated, "I don't have any problems adding a 90 day process after the award letter is given that they have to show some type of process is being done. After 90 days or so, I am good with that. The award letter does not go out until the council approves the actual acceptance. That could be another 30 days after the bid opening. It is a process but the property owners have to have their due process. I am not opposed to a 90 day process saying if you don't have anything done in 90 days after your award letter is done then we will go to the second bidder. I am good with that. As long as we make sure that it is legal. I am good with that."
- Councilwoman Nancy Carriere stated, "Is there any way possible in the future, and I know we are doing the social media, we are doing the paper and all of that, to notify these people that their property is up for adjudication and try to safe guard some future problems. Is there any possible way and I know it may be asking a lot Mr. Lewis because you already have to put signs out and all of this but really that they know that their property is going up for sale. It does lead to a heart break for a person, even though it is not paid for, you really don't own your car until you have paid the last payment but the point is as you are driving it those years and you feel you own your car. It is yours."
- Councilman Harold Taylor stated, "Madam Chair, we are in the comment state, we are not debating issues at this time, can we move on."
- Councilman Wayne Ardoin questioned, "Madam Chair, I have a question on this matter. For Mr. Kidder, Mr. Duplechain, what the state law states on the 90 day. Is it 60 days or 90 days?"
- Legal Counsel Garett Duplechain stated, "After the person wins the bid, they can have a set time to come forward and sign their conveyance, claim their property and complete the process."
- Councilman Wayne Ardoin stated, "The State Statue states 90 days or does it say any other?"
- Legal Counsel Garett Duplechain stated, "It does not state that. It just say how long it has to be prior to whenever it is adjudicated. Five years or more they have 60 days to come forward. If it is less than 5 years, you have 6 months to come forward. That is the beginning of the process. At the end of the process the council can set a limit for them to come forward and claim their property."
- Councilman Wayne Ardoin stated, "My question is the thing with the bidders. Nothing about the owners, they can come back and the have a certain amount of time. I am talking about in the bid process we set up that rule of the 90 days?"
- Legal Counsel Garett Duplechain stated, "Right, the council can set that ordinance."
- Councilman Wayne Ardoin questioned, "Have we set it at 90 days?"
- Legal Counsel Garett Duplechain stated, "No."
- Councilman Wayne Ardoin stated, "Okay, can we bring that to committee next month so we change the days. We can go 120 or 60 or whatever. So we will have something in the ruling."
- Parish President Jessie Bellard stated, "Definitely."
- Councilwoman Mildred Thierry stated, "While we are in the process of redoing the ordinance, is it possible for us to just go on and say in that ordinance that instead of reopening the process all over again, it should go to the next highest bidder instead of reopening it and starting the biding process all over. We already have it ongoing and if that first person did not come forth well then to me it automatically should be the second highest bidder in line. Maybe we should just state that in that ordinance if everybody feels the same way."
- Parish President Jessie Bellard stated, "Madam Chair, I will get with Mr. Duplechain and we will draft something for the next meeting and we will have those two stipulations in there. I will bring it to you all for the next meeting."

#### VII. PARISH PRESIDENT REPORT:

A couple of things that I would like to do and it is not on the agenda and not on my President's Report, I have it right here, McNeese Street on the northern part of the parish, another part of Opelousas, there is a house that is in disarray, it is a safety issue. What we have done with that is barricaded it off from public and placed condemned signs all over it to make sure that nobody goes into the property. We need to do the final letter to do the demolition process. I need the council to make a motion that we...they send out a final letter so the people could come to the next council meeting and give us their reason why we should not tear it down but in the interim we did declare it condemned for safety reasons in the process...in the meantime."

**Councilwoman Nancy Carriere stated,** "I won't bother you all anymore but is that the one that I was talking about?"

Parish President Jessie Bellard response was not clear over the microphone.

**Parish President Jessie Bellard stated,** "On Don Guilbeau Road we were just notified that the driveway is open now and I have cleared it with Mr. Duplechain. Everything has been set legally. We will go and start cutting the grass since the gate is open. If the gate is not open we will open it and start cutting the grass. We did all of our due diligence with the law. That is our next process."

Councilman Wayne Ardoin questioned, "Do you need a motion to that?"

**Parish President Jessie Bellard stated,** "No everything was passed thru the council already. We wanted clarification if there is a gate blocking the driveway and do we have permission to go on the property and cut the grass. I thing that we are good on that right now so we will start that process."

**Legal Counsel Garett Duplechain stated,** "All of the letters required by the ordinance for Don Guilbeau Road was sent out. They were all recorded by our Council Clerk with the Clerk of Court with a Certificate of Mailing, all according to the ordinance. So everything for Don Guilbeau Road and 121 Cook Street in Morrow has been completed to follow the Ordinance."

Councilman Wayne Ardoin questioned, "So do we need a motion on those two items?"

Legal Counsel Garett Duplechain stated, "That would be good."

Councilman Wayne Ardoin stated, "So I will offer it as a motion."

Councilman Timmy Lejeune stated, "Seconded."

Councilman Jerry Red Jr., stated, "That did not pass because it was a lack of a full unity. Parish President Jessie Bellard stated, "We don't need a motion for that."

Councilman Jerry Red Jr., stated, "Yes we do."

**Parish President Jessie Bellard stated,** "Not to go clean that property. It has been through that process already."

I believe those changes were made so the revised ordinance is ready now." **Councilman Wayne Ardoin stated**, "I will offer a motion that we move forward with the ordinance with the changes and I will sponsor it."

Parish President Jessie Bellard stated, "Another issue that we have been having and since we have a Civil Code Officer, those people who are not cutting their grass, even though we give them the letters and the don't cut their grass like the first of second round, the officer is going out there and giving them a citation. That is just to start the ball rolling, not that we are going to cut the grass but we are giving them a citation saying that you are not listening to what the ordinance calls for, you have been given letters and now you are getting a citation, a Civil Citation. So that will push the issue faster on our end. If they continuously not do it, that third letter that the council will do, then we will go ahead and clean up the property. In the meantime if they violate our ordinance and we give them their warnings and their letters and they still don't it, they will get a ticket. That will help us speed the process up."

Councilman Jerry Red Jr. questioned, "What is the cost?"

Parish President Jessie Bellard stated, "Whatever is in the ordinance. I am not sure what the cost is. Whatever fines that you all have in the ordinance, I am not sure."

Councilman Jerry Red Jr., stated, "So you don't know what it is."

**Parish President Jessie Bellard stated,** "No, but if they are given a citation, the citation will be presented to the front office with a copy of the ordinance that they have violated. Then they will adhere to whatever it is. You have first, second and third offenses, I am not exactly sure of the fines or the fees. That is something that we might have to look at in the future, possibly increasing it. It might be \$25.00, I am not sure."

**Councilwoman Nancy Carriere questioned,** "Do they have a certain amount of time?" **Parish President Jessie Bellard stated,** "They have 45 days. If they don't pay the fine then it becomes an issue brought to the courts and the courts can order them to pay the fine. If they don't pay the fine then it becomes a Criminal Matter. Until it gets to the court it is a Civil Matter between us."

**Parish President Jessie Bellard stated,** "I am not sure what it is. I just said that because I know our fines and our fees are very low in our ordinance. Also, I don't need a resolution, oh yes I could use a resolution for this. Community Action is applying for another Transit Vehicle. Another bus through DOTD. I need a Resolution to authorize the application to apply for this Grant.

**Parish President Jessie Bellard stated**, "That is the one that was just redeemed the other day." **Councilwoman Nancy Carriere stated**, "So how are we going to handle that? Are we going to maintain the grass? Are you going to send them a letter?"

Mr. Richard Lewis, Code Enforcement could not be heard over the microphone for his response."

**Parish President Jessie Bellard stated**, "While we are on that subject, Garett, I don't know if this is what the procedures are because we put it in place by ordinance. What the law says, two letters that takes 30-45 days and another letter that take 30 days, if we are dealing with grass cutting by the time the process has ended it could be 5 feet tall. We are doing this according to what the ordinance calls for but is that mandated by some kind of state law. Can we change the ordinance where we don't give people much time when it comes to grass cutting?"

**Legal Counsel Garett Duplechain stated,** "On the Blighted property ordinance, if it is Blighted Property like maybe a structure that is falling down we have to send the certified letter and it takes a long time to get it back. If it does not come back or it is not accepted then notice is sent regular mail ten or more days before the meeting. The meeting comes and they show up or they don't show up then the council goes forward with it and that is for Blighted Property. When it comes to grass cutting, that maybe another ordinance where you cut the grass but they have to pay for it."

**Parish President Jessie Bellard stated,** "What I am asking, do we have to wait on the three letter process or can we streamline it and make it faster because the grass is getting out of control."

**Legal Counsel Garett Duplechain stated,** "There is no set period of time, we can send the letter today and have them to show up 30 days later, we can do that Certified Mail. It takes so long to get the Certified Mail back is why we are sending the letter in July for the Don Guilbeau Road and setting it for October."

**Parish President Jessie Bellard stated,** "So the next council meeting, if I come to the council with a new ordinance amending the ordinance strictly on grass cutting, not on the Blighted Property or Structure of any type but just cutting the grass and lessen the time frame would we be in order to do that?"

**Legal Counsel Garett Duplechain stated,** "Right, we can do that, put just the grass cutting. We can tailor it to a timeline that is more efficient and acceptable."

**Parish President Jessie Bellard stated,** "In the ordinance it specifies 18 inches or so. It is just a time line and it is taking so long to get it done."

Councilwoman Nancy Carrier questioned, "Are you all going to draw this up?" Parish President Jessie Bellard stated, "Yes, I will get with Mr. Duplechain and we can get something drawn up for the next council meeting."

13. Authorize Legal Counsel Garett Duplechain to check the right-of-way for Laterals on the Fleur Des Coteau Subdivision.

**Legal Counsel Garett Duplechain stated**, "I think that is set for today. I check the Conveyance Records and I found a Right-of-way for the Laterals on the Fleur Des Coteau Subdivision. It is signed and recorded at the courthouse. There is a copy for each of the council which I have placed where you sit. It is a Right-of-way for the Prairie Basse Gravity Drainage District #15 for the Laterals located on Fleur Des Coteau Road. You all have copies."

Councilman Wayne Ardoin stated, "Madam Chair, I asked that this be researched. If they did not have anything they would get an Attorney General's Opinion but we have it here so I will ask that the Drainage District be notified and let Public Works be notified. Mr. Soileau was notified about it but they did not want to move until we get this Right-of-way. So I will ask that Parish Government and the Drainage District proceed on trying to clean this lateral up. Mr. Bellard are you aware of the one that we are talking about?"

**Parish President Jessie Bellard stated,** "Yes I will get with Barry in the morning and he can contact the drainage board for them to go and do it. We will support them and provide what we need to but if they can do it it would be a lot better for us."

**Councilman Wayne Ardoin questioned,** "Thank you, do we need a motion for that or will you take care of it."

Parish President Jessie Bellard response could not be heard over the microphone. Councilman Wayne Ardoin stated, "Thank you."

AN ORDINANCE TO REPEAL ORDINANCE SECTION 36-180 AND REMOVE THE BARRICADE AT RAINBOW DRIVE AND PEBBLE ROAD BECAUSE THERE SHALL NO LONGER BE A DEAD END AT RAINBOW DRIVE AND PEBBLE ROAD

WHEREAS, there is no longer a need to have a dead end at Rainbow Drive and Pebble Road.

WHEREAS, this Ordinance repeals Ordinance Section 36-180.

**BE IT ORDAINED BY THE COUNCIL FOR ST. LANDRY PARISH GOVERNMENT** that St. Landry Parish Ordinance Section 36-180 is hereby repealed and the barricade at Rainbow Drive and Pebble Road shall be removed because there shall no longer be a dead end at Rainbow Drive and Pebble Road.

Parish President Jessie Bellard stated, "I understand, no I don't have a typo.

**Councilman Easton Shelvin stated,** "What he is saying is that the Resolution is the same but the numbers are different."

**Parish President Jessie Bellard stated,** "That is right, the numbers are different." **Council Clerk Sherell Jordan stated,** "That is a different Resolution. That first one is Community Action, the second one is Steve Duhon and the third one is the Block Grant Application. This is a DOTD Resolution."

**Parish President Jessie Bellard stated,** "The very first one on my Parish President's Report is this one. It is about the CIP Plan for the airport."

**Council Clerk Sherell Jordan stated,** "The first one on here, the Transportation Grant is a different one that I received from Community Action. That is not this one here. This is totally different from what I received from Community Action."

## **RESOLUTION NO. 023-2022**

WHEREAS, Title 2 of the Louisiana Revised Statutes of 1950 provides that cities, towns, parishes, and other political subdivisions of this State may separately or jointly acquire, establish, construct, expand, own, lease, control, equip, improve, maintain, operate, regulate, and police airports and landing fields for the use of aircraft; and,

WHEREAS, the State of Louisiana, Department of Transportation and Development, Division of Aviation (formerly the LA DOTD-OAPT) is charged by Title 2 with the responsibility for the development of aviation facilities within the State to foster air commerce and to safeguard the interests of those engaged in all phases of the aviation industry and of the general public; and,

WHEREAS, the St. Landry Parish Government hereinafter referred to as "Sponsor", has completed an FAA and DOTD approved Master Plan, Action Plan, and/or Airport Layout

Plan which outlines the specific future development of the St. Landry Parish Airport; and, the sponsor is desirous of implementing a portion of the approved Plan recommendations which provide for the critically needed improvements as stated below to substantially improve the safety and usability of the Airport, but does not have sufficient funds of its own required for completing the needed improvements; and,

WHEREAS, the LA DOTD, Division of Aviation is authorized by Title 2 to expend funds for the construction or enlargement of airports for the safety and advancement of aeronautics;

NOW, THEREFORE, BE IT RESOLVED:

## **SECTION I**

That the St. Landry Parish Government, hereinafter referred to as "Sponsor" does hereby formally request that the LA DOTD, Division of Aviation provide funds required to complete the airport improvements at the St. Landry Parish Airport specifically as

described in the Six (6) year Capital Improvement Program Application for State Financial Assistance which is dated October 19, 2022 and which commences in the year 2023.

## **SECTION II**

That the said LA DOTD, Division of Aviation be and is hereby assured that all necessary servitudes, rights-of-way, rights of ingress and egress and means thereof will be fumished by the Sponsor and the titles thereto will be valid and indefeasible, and that the Sponsor will assume ownership, financial reporting, and complete responsibility for the maintenance and upkeep of the airport after completion of said improvement.

#### **SECTION III**

That the Sponsor will save and hold the said LA DOTD, Division of Aviation, its officers, agents, and employees harmless from any liability or claim for damages arising out of the project, including death or injuries to third parties including, but not limited to, liability or claim for damages out of the negligence of said LA DOTD, Division of Aviation, its officers, agents, or employees, and expressly agrees to defend any suit of any nature brought against the DOTD Division of Aviation as a result of this project.

## **SECTION IV**

That the President of the Sponsor be and is hereby authorized and directed to evidence this agreement by affixing his signature at the place provided therefore on this resolution and on subsequent related documents/agreements as required by the rules and regulations of the Federal Aviation Administration and the State of Louisiana and the Clerk is hereby authorized to attest said execution.

## **SECTION V**

That this resolution shall be in full force and effect from and after its adoption.
