I have another concern about the one previously before this one. When we have the banks especially banks that are out of state that own these properties and they are not maintaining them. We are saying that they are cutting the grass but they are from out of state and we can hardly reach them."

*Ms. Cynthia Fontenot, Code Enforcement Officer stated,* "I have been very proactive on it. I have been contacting them, I have various e-mails back and forth and I have made contact with someone there. I have been in contact with the Bullard Street Property. There is a lady who I contact in Alexandria. She is the local contact and we have gone to the property and she is working on getting things done. The one on McNeese Street, the same thing. I have been talking back and forth with the bank representative and they were not aware that they had a mobile home on that property. The owner let someone put a mobile home there so now they are taking action on that. They are keeping up the property."

*Councilwoman Nancy Carriere stated*, "Okay, I have tried before you calling the bank and they have an alarm service that they contract with and a lot of times they don't do it."

*Ms. Cynthia Fontenot, Code Enforcement Officer stated,* "They have been very good on these, even on Bullard Street. The started cutting the grass. They just have not gone the whole property. On McNeese Street the lady is very good and she is staying on top of it."

Councilwoman Nancy Carriere stated, "Thank you."

*Chairman Wayne Ardoin questioned*, "Ms. Fontenot do you have an update on the Tate Property on Victoria's Loop?"

*Councilwoman Nancy Carriere stated*, "I have one question. I know that I have spoken to you Mr. Bellard a little while ago about this. We just got that letter today about the Lewisburg Water. You said that you were waiting on another water system to see if they would be able to handle this. I don't know who district it would be in, It maybe Ms. Vivian's District."

*Parish President Jessie Bellard stated*, "If I am not mistaken I think you are the contractor am I correct?"

*Chairman Wayne Ardoin stated*, "Would you come up please and state your name and address and who you are representing."

*Mr. Clay Menard addressed the council. He stated*, "I live at 136 Clara Von Drive, Lafayette, LA. We are the consulting Engineers for this property. We did get an approval from the department of Health to have individual water wells on this property. The nearest water system was Lewisburg and Bellevue and they cannot furnish adequate water supply or pressure to this property so that is why we are asking for the approval and the state did give us an approval to have private water wells."

*Parish President Jessie Bellard stated*, "What about Water District Two? It should be North of Sunset, I tried to contact them this afternoon I am not sure if they cover that certain area I know Lewisburg do not go that far out."

*Mr. Clay Menard. stated*, "Right out of Sunset, they are South of the property, they do not come near the property so they could not furnish the water. We did reach out to both of them to see if they could because we did want to have public water instead of individual wells."

*Councilwoman Nancy Carriere stated*, "I just have a question because I am curious when the State approves individual wells that means everyone have to buy their own well."

*Mr. Clay Menard. stated*, "Yes mam, they would have to hire a contractor to drill a water well depending upon the size that they want for the property."

*Chairman Wayne Ardoin stated*, "At this time you want to delay this thing. Do have to wait and get something approved about the water wells."

*Parish President Jessie Bellard stated*, "No it is ready to go. Everything approved by the state, we good."

*Councilwoman Nancy Carriere stated,* "If I am at liberty, I know Mr. Ardoin just asked if there were any stipulations but I just want to make a comment that the land owners will be aware of this before and it will be written down somewhere."

*Mr. Clay Menard. stated*, "Right the developer is going to split the subdivision governing everything and we have a letter from the Department of Health saying that they can have private water wells and it is their responsibility to get such."

Councilwoman Nancy Carriere stated, "Thank you."

*Chairman Wayne Ardoin stated,* "Matter of record that they are aware that they have to get water wells."

*Councilman Harold Taylor stated,* "I have a question I would like to refer to the parish president, didn't we talk about getting a copy of the HOA when we make these approvals."

Parish President Jessie Bellard stated, "I do not know if we passed it in an Ordinance."

Councilman Harold Taylor stated, "Could we get a copy of that?"

Number two, some of the councilmembers are still at work and Number three the public, those who are still in ordinances take them that are time sensitive and put them first and let the others be pushed back to the following month. It is just me that is why I said that I would like to have a discussion. Another thing, I don't think that it is necessary and I could not find anything that states that we have to spend 15 minutes on each ordinance. So I am open for discussion. I would appreciate it if we can get something together and possibly get something put in place so that we don't start no earlier than 5:00 p.m. with the Public Hearing."

*Councilwoman Nancy Carriere stated*, "I agree with Ms. Thierry. I would like to suggest if there is any way possible that it would be a ten minute interval."

*Councilwoman Mildred Thierry stated*, "That is exactly what I had in mind. Ten minutes per ordinance. I don't know what the rest of the members think of this."

*Councilwoman Nancy Carriere stated*, "Five p.m. would be an appropriate time for me. I do work and I sometimes do after tutoring and we don't finish until 4:30 p.m. or 4:45 p.m. I am in agreement with it."

*Councilman Timmy Lejeune stated*, "If they are only ten minute ordinances each and you are putting four you don't have to start at 5:00 p.m. if you will roll them to ten minutes a piece."

*Councilman Harold Taylor stated*, "That is a good point Mr. Lejeune. Why don't we have it flexible? We have some ordinances that have no discussion about them."

Chairman Wayne Ardoin stated, "There is no comments on some ordinances."

*Councilman Timmy Lejeune stated*, "Why don't we try to limit it to three ordinance at ten minutes a piece and everyone starts at 5:30 p.m. at the earliest. Then you will have three of them and if it is something that is an emergency or something that is very time sensitive like Ms. Mildred said then we can always have that waived or get it in there if we need to instead of having 5 or 6 of them."

*Councilman Harold Taylor stated*, "Instead of putting a time on each ordinance it says that it will be discussed between 5:00 p.m. and 6:00 p.m. It use to go into an extra 15 minutes after 6:00 p.m. Our Charter clearly says that we are not suppose to have a meeting before 5:00 p.m. and these hears are a Public Meeting. We are already violating the Charter."

*Councilman Dexter Brown stated*, "This is just a suggestion whereas some of these ordinances are basically open and shut. My suggestion and this is just a suggestion, we can put it at a 5 minute time limit. If need be we can extend it to 15 minutes, that is just a suggestion. What do you all think?"

*Councilman Harold Taylor stated*, "Mr. Chairman, if you don't put a time on any ordinance and you have an ordinance that you are interested in general public then you should be here between 5:00 p.m. and 6:00 p.m. because you will get to talk and view your comments. If you put that it will be at 5:30 p.m. they may not come until 5:25 so leave it flexible is my point."

*Chairman Wayne Ardoin stated*, "Are there any other comments from any other councilmember?"

*Parish President Jessie Bellard stated*, "Mr. Chairman, I think that Mr. Taylor is right. I think that we need to do the time frame, most times at other council meetings that is what they do. If anybody is there to talk on it and they are there or they are not there they move on to the next one. How many times do we have anyone talk on an ordinance? It is hardly ever but I know that we have to do it. This is going to help us a lot."

*Chairman Wayne Ardoin stated*, "This evening you had no one here on two ordinances, which we only had 2 and no one spoke except for the sponsors. Are there any other comments?"

*Councilwoman Mildred Thierry stated,* "I am in agreement with doing whatever is the best thing that is going to work. Just because I made certain suggestions it does not have to be that, whatever works best."

*Chairman Wayne Ardoin stated*, "So Ms. Thierry you will get with Mr. Duplechain and you will come up with some of the timeframes that we discussed tonight and you will be the sponsor of it, please."

*Legal Counsel Garett Duplechain stated*, "Mr. Chairman, I think what we are dealing with is Internal Policy as to the procedure that is going to be used as far as the time each hearing will be and when the starting time and how many ordinances we put forth. I would not pass an ordinance to bind the council to just four ordinances or a certain procedure or anything like that. It is an Internal Procedure that the council would establish as to the time for each hearing and when the hearing will start, how many ordinances and things like that. I don't think an ordinance is really required for that. The council could pass a Resolution to express his will but I don't really think that is even necessary. The meeting are really managed by the Chairman and so you can set your Internal Policy like that. As I understand it the hearings will start at a certain time and then whoever has something to say on that ordinance would show up at that time and we would move on to the next hearing if no one show up so it could be flexible like that. All the statue law says is that whoever has something to say on an ordinance has to be given an opportunity to talk on it so as long as they have an opportunity and it is being fulfilled. This is really an Internal Policy on the part of the council which would be established as to how these hearings take place."

*Councilman Harold Taylor stated*, "Mr. Duplechain it is all ingrained in our council rules so that is all that we have to change is our rules. The rules says 15 minutes, we can make it what we want. That is the part, it does not require an ordinance for council rules is what I am saying."

*Councilman Faltery Jolivette stated*, "Mr. Duplechain, Councilman Taylor mentioned that our Charter requires us to start our meetings after 6:00 p.m. My question is this: Are we in non-compliant? Are we Non-Compliant by starting before 5:00 p.m.?"

Councilwoman Mildred Thierry stated, "Yes."

*Legal Counsel Garett Duplechain stated*, "If that is what the Charter says then that is true. I will have to find that in our Charter. You can't start before 5:00 p.m. So from now on we won't start before 5:00 p.m."

*Councilman Timmy Lejeune stated*, "Do we need to do that as a Resolution or let the ordinance be set at the discretion of the Chairman, the time frame."

*Chairman Wayne Ardoin stated, "*I am for whatever the council wants to do. I am like Ms. Thierry. We are starting at 4:15 in the afternoon, it makes it impossible for people to come here and be able to speak on whatever we are discussing. At 5:00 p.m. if that is what we are going to decide on let's go with it. If it is 5:30 p.m. let's go with it.

*Councilman Timmy Lejeune stated*, "I make a motion that we start all Public Hearings at the time of 5:30 p.m. and the length of the discussion is determined by the Council Chairman of the meeting."

*Chairman Wayne Ardoin stated*, "What I will do I will get with Ms. Sherell on the Thursday before the agenda goes out and we will make a decision of what time we will start the meetings and that way she will let you all know that morning of the meeting on what time everything is going to start. Is that fair enough."

Councilwoman Mildred Thierry stated, "Yes, but it definitely won't before 5:30 p.m."

Chairman Wayne Ardoin stated, "No Ma'am."

#### ORDINANCE NO. 2024-032 Sponsored By: Councilwoman Nancy Carriere

AN ORDINANCE TO DONATE IMMOVABLE PROPERTY LOCATED ON BERNICE STREET, OPELOUSAS, LOUISIANA, TO THE CITY OF OPELOUSAS FOR A SEWAGE TREATMENT STATION WHICH IS FOR A PUBLIC PURPOSE Chairman Wayne Ardoin stated, "Do you want to enlighten us on that Mr. Bellard."

Parish President Jessie Bellard stated, "Mr. Duplechain has been handling that matter.

*Legal Counsel Garett Duplechain stated*, "The City of Opelousas is building a Sewage Treatment Facility on that lot on Bernice Street. They wanted to start before ownership of that lot was transferred to them by the St. Landry Parish Government. So St. Landry Parish Government granted a right way to the city so they have been constructing their Sewage Treatment Facility on that lot. As of the beginning of August 1<sup>st</sup>, 2024 St. Landry Parish Government has acquired full and complete ownership over that so it is not Adjudicated Property anymore. St. Landry Parish Government now has full and complete ownership of that lot on Bernice Street. Now for a Public Purpose St. Landry Parish Government can transfer/donate ownership of that lot to the City of Opelousas so Opelousas will then own it and they will have a Sewerage Treatment Facility on it. So what this ordinance does: It will provide the ownership of this lot on Bernice Street be donated and transferred by the St. Landry Parish Government to the City of Opelousas for a Public Purpose which is the Sewerage Treatment Plant."

*Chairman Wayne Ardoin stated*, "You will have all of the specifications on the ordinance that you will draw up?"

*Legal Counsel Garett Duplechain stated*, "Right, the Opelousas City Attorney and I will take the further steps for the Conveyance of Transfer after today."

*Councilwoman Nancy Carriere stated*, "Just as long as we have all of our 'I's' dotted and 'T's' crossed so that when we donate it we are donating it. We had this with the Sewerage and the City of Opelousas before and the paper work had not been properly done. I want to make sure that we get this paperwork done and there be no recourse and we give it to them, we donate it and it is donated. No fault on you but I want to make it clear."

*Parish President Jessie Bellard stated*, "There is no issue with this one because it was done through the proper process."

*Councilwoman Nancy Carriere stated*, "I just want to make sure that we follow through with the paperwork is all that I am saying."

Parish President Jessie Bellard stated, "I agree."

*Councilwoman Nancy Carriere stated*, "Because we did vote and the paperwork was not done and we had to face that issue. That is fine. I understand that this is near the Inaclare Subdivision"

Parish President Jessie Bellard stated, "Yes."

Chairman Wayne Ardoin stated, "Do I have any other comments? Do I have a Sponsor?"

Councilwoman Nancy Carriere stated, "I will sponsor it."

Chairman Wayne Ardoin stated, "Mr. Duplechain, would you comment on this ordinance."

*Legal Counsel Garett Duplechain stated*, "That would be me. This is a requirement from FEMA. Basically the word 'Less' has to be 'Lesser'. I have been speaking with FEMA numerous times over the weeks and the months. We have over 1,900 Flood Insurance Policies in St. Landry Parish and FEMA wants St. Landry Parish to succeed in continuing to be able to have Flood Insurance Accessible to the people in St. Landry Parish. To do that there is a certain Bureaucratic Procedure that will have to be done. One of them is when they require a flood ordinance to be amended, that is what this is here. They are working with St. Landry Parish and they want us to succeed in being able to have Flood Insurance down here from FEMA and this is a requirement that they have. It is just simply amending the Ordinance to a wording that they would want, so that is what this is right here."

*Councilman Harold Taylor stated*, "Mr. Duplechain, I sponsored an ordinance that we changed it to this some time ago, was it not worded right?"

*Legal Counsel Garett Duplechain stated*, "It was the same ordinance and they wanted another change in it so they contacted me."

Councilman Harold Taylor stated, "What is the other change?"

*Legal Counsel Garett Duplechain stated*, "It is one word. Lessor. They wanted Lessor instead of Less. Originally it was 50 lots or five acers and it was changed to 50 lots or five acres with the number 5 and then they contacted me again and they wanted Lessor instead of Less."

Councilman Harold Taylor stated, "I am good, I will sponsor that."

*Parish President Jessie Bellard stated*, "I am just here to tell you all that this is not going to be the end of it. It is unbelievable what they are asking everybody to do and they are holding that little insurance card over everybody's head. Those little words like that, they drafted the last one basically and said this is what you need to pass. We pass exactly what was drafted then they want to change."

Chairman Wayne Ardoin stated, "Mr. Taylor is sponsoring 2024-034 with the wording changes."
