**ORDINANCE NO. 2024-040**

**(Sponsored By: Councilman Ernest Blanchard)**

**AN ORDINANCE TO ABOLISH HOSPITAL SERVICE DISTRICT NO. 1 IN ST. LANDRY PARISH AND TO REPEAL SECTION 20-27, SECTION 20-28, AND SECTION 20-29 IN CHAPTER 20 OF THE ST. LANDRY PARISH CODE OF ORDINANCES IN ORDER TO ABOLISH HOSPITAL SERVICE DISTRICT NO. 1 WHEREAS , Section 20-27, Section 20-28, and Section 20-29 in the St. Landry Parish Code of Ordinances created Hospital Service District No. 1, which is located in that part of the City of Eunice which is inside St. Landry Parish.**

**WHEREAS, with the authority granted to parish governing authorities by Article VI, Section 15, of the Constitution of the State of Louisiana of 1974, and La. R.S. 33 1415, Hospital Service District No 1 in St. Landry Parish shall be abolished and the St. Landry Parish Council shall repeal Section 20-27, Section 20-28, and Section 20-29 in the St. Landry Parish Code of Ordinances in order to abolish Hospital Service District No. 1, which is located in that part of the City of Eunice which is inside St. Landry Parish.**

**BE IT ORDAINED BY THE COUNCIL FOR ST. LANDRY PARISH GOVERNMENT that Section 20-27, Section 20-28, and Section 20-29 in Chapter 20 in the St. Landry Parish Code of Ordinance are hereby repealed and Hospital Service District No. 1 in St. Landry Parish is hereby abolished.**

**BE IT FURTHER ORDAINED BY THE COUNCIL FOR ST. LANDRY PARISH GOVERNMENT that the ownership and title to the following contiguous parcels of immovable property owned by Hospital Service District No. 1 shall hereby be conveyed, transferred, and vested in St. Landry Parish Government, to-wit:**

1. 11.896 acres in Section 29, Township 6 South (T-6-S), Range 1 East (R-1-E), St. Landry parish, Louisiana.
2. One (1) Lot measuring 435 feet by 300 feet in the Southeast Quarter (1/4) of Section 30, Township 6 South (T-6-S), Range 1 east (R-1-E), St. Landry parish, Louisiana.
3. One (1) Lot containing 0.822 of an acre, and bounded, now or formerly, North by Fruge Street; South formerly by Hospital Service District No. 1, and now by St. Landry Parish Government; East by an unnamed street; and West by Moosa Boulevard. Said parcel of land being in Section 30, Township 6 South (T-6-S), Range 1 East (R-1-E), St. Landry Parish, Louisiana.
4. One strip of property measuring 10 feet by 261 feet, and said property is an abandoned alley, in St. Landry Parish, Louisiana.

**BE IT ORDAINED BY THE COUNCIL FOR ST. LANDRY PARISH GOVERNMENT that Ordinance 2024-024, which was enacted by the St. Landry Parish council on July 17, 2024, shall be amended and shall now read as follows:**

**An applicant for an appointment to a Board or Commission in St. Landry Parish who is applying for the first time for an appointment must go before the St. Landry Parish Council for an interview at a St. Landry Parish Council meeting in order to be eligible for the appointment to the Board or Commission that they are applying for.**

**AN ORDINANCE TO SELL ADJUDICATED PROPERTY TO AN ADJOINING LANDOWNER OF THE ADJUDICATED PROPERTY AS PER LA R.S. 47:2202 (B)**

WHEREAS, Louisiana Revised Statute 47:2202 B. states that the governing authority of each political subdivision may allow an adjoining landowner to purchase adjudicated property for any price set by the governing authority without public bidding at a public meeting of the governing authority; provided, that the governing authority determines that the adjoining landowner has maintained the adjudicated property for a period of one year prior to the sale. Such a sale shall be deemed a public sale.

**XI. RESOLUTIONS TO BE ADOPTED:**

**RESOLUTION NO. 027-2024**

**A RESOLUTION GIVING PRELIMINARY APPROVAL TO  
THE ISSUANCE OF TWO MILLION FIVE HUNDRED  
THOUSAND DOLLARS (\$2,500,000) OF REVENUE NOTES,  
PARISH OF ST. LANDRY, STATE OF LOUISIANA;  
PROVIDING CERTAIN TERMS OF SAID BONDS;  
MAKING APPLICATION TO THE STATE BOND  
COMMISSION FOR APPROVAL; AND PROVIDING FOR  
MATTERS IN CONNECTION THEREWITH.**

**BE IT RESOLVED** by the St. Landry Parish Council, State of Louisiana (the "**Governing Authority**"), acting as the governing authority of the Parish of St. Landry (the "**Parish**"), State of Louisiana, that:

**WHEREAS**, pursuant to the Consolidated Local Government Indebtedness Act, Title 39, Subtitle II, Chapter 4, and particularly 39:1430 (Revenue Bonds) (the "**Act**") of the Louisiana Revised Statutes of 1950, as amended, and other applicable constitutional and statutory authority, it is now the desire of the Issuer to adopt this Resolution in order to provide for the issuance of not

exceeding Two Million Five Hundred Thousand Dollars (\$2,500,000) of St. Landry Parish Revenue Notes (the "**Bonds**"), in one or more series, for the purposes of the Project as set forth herein;

**WHEREAS**, the Bonds will be secured by the ad valorem taxes and other revenues received and accruing in the Parish Roads and Bridges Fund ("**Roads and Bridges Fund 21**") and Road District 1 Fund ("**Road District 1 Fund 42**") (collectively, the "**Pledged Revenues**") the Pledged Revenues which are authorized to be used for the purposes of the Project as set forth herein;

**WHEREAS**, the Governing Authority desires to grant preliminary approval for the issuance of the Bonds and to make a formal application to the Louisiana State Bond Commission for approval to issue the Bonds;

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Authority as follows:

1. **Preliminary Approval of Bonds**. Preliminary approval is hereby given to the issuance of not exceeding \$2,500,000 aggregate principal amount of St. Landry Parish Revenue Notes, State of Louisiana, to be issued in one or more series, to provide funds for repairing, maintaining, and improving public roads and bridges, including acquisition, maintenance and/or operation of equipment and materials for said purpose (the "**Project**") within the area designated by the Parish as "District 9 of Road District 1" (the "**District**") and (ii) paying the costs of issuance of the Bonds as further described in Section 2 hereof.
2. **Security**. The Bonds will be payable from and secured by an irrevocable pledge and dedication of the ad valorem tax and other revenues received and accruing in the Roads and Bridges Fund 21 and Road District 1 Fund 42 and shall bear interest at a rate or rates not to exceed six percent (6%) per annum, to be sold at the prices and in the manner to be determined by subsequent proceedings of this Governing Authority, and will mature over a period not exceeding (10) years from the date issuance, all in the manner provided by the Act.
3. **State Bond Commission Approval**. Application is hereby formally made to the State Bond Commission, Baton Rouge, Louisiana, for its consent and authority to issue and sell the aforesaid Bonds, and a certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of the Governing Authority, together with a letter requesting the prompt consideration and approval of this application. By virtue of the applicant/issuer's application for, acceptance, and utilization of the benefits of the Louisiana State Bond Commission's approval(s) resolved and set forth herein, it resolves that it understands and agrees that such approval(s) are expressly conditioned upon, and it understands, agrees and binds itself, its successors and assigns to, full and continuing compliance with the "State Bond Commission Policy on Approval of Proposed Use of Swaps, or other forms of Derivative Products Hedges, Etc.", adopted by the Commission on July 20, 2006, as to the borrowing(s) and other matter(s) subject to the approval(s), including subsequent application and approval under said Policy of the implementation or use of any swap(s) or other product(s) or enhancement(s) covered thereby. For purposes of meeting the requirements of the May 11, 2009, memorandum of the Director of the State Bond Commission to all bond counsel, any proceedings of the Issuer relating to the Bonds that refers to a principal amount or interest rate of the Bond shall be deemed to include the words "not to exceed" or "not exceeding" whether so stated or not, and any reference to a final maturity date or term contained herein shall be deemed to include the words "to mature on or before" whether so stated or not.
4. **Bond Counsel**. This Governing Authority finds and determines that a real necessity exists for the employment of special bond counsel in connection with the issuance of the Bonds, and accordingly, LaFleur & Laborde, namely Eric LaFleur, Ville Platte, Lafayette, New Orleans, and Baton Rouge, Louisiana is hereby employed as Bond Counsel to do and perform comprehensive legal and coordinate professional work with respect to the issuance and sale of the Bonds ("**Bond Counsel**"). Bond Counsel shall prepare and submit to this Governing Authority for adoption all of the proceedings incidental to the authorization, issuance, sale and delivery of the Bonds, shall counsel

and advise this Governing Authority as to the issuance and sale the Bond and shall furnish its opinion covering the legality of the issuance of the Bonds. The fee of Bond Counsel shall be fixed at a sum not exceeding the maximum fee allowed by the Attorney General's fee schedule for comprehensive, legal and coordinate professional work in the issuance of revenue bonds and based on the amount of bonds actually issued, sold, delivered and paid for, plus "out-of-pocket" expenses, said fees to be contingent upon the issuance, sale and delivery of said Bonds. A certified copy of this resolution shall be submitted to the Attorney General of the State of Louisiana for his written approval of the employment and of the fees described herein, and the Clerk is hereby empowered and directed to issue payment or to authorize payment Bond Counsel upon completion of the work and under the conditions specified herein.

5. **Municipal Advisor.** The employment of Sisung Securities Corporation, Metairie, Louisiana as Municipal Advisor ("**Municipal Advisor**") pursuant to a Municipal Advisor Engagement Letter dated October 17, 2024 is hereby ratified and confirmed..
6. **Declaration of Official Intent.** Prior to the delivery of the Bonds, the Parish anticipates that it or the District may pay a portion of the costs of the Project from their General Fund and other available funds. Upon the issuance of the Bonds, the Parish reasonably expects to reimburse any such expenditures of other available funds from a portion of the proceeds of the Bonds. Any such allocation of proceeds of the Bonds for reimbursement will be with respect to capital expenditures (as defined in Reg. 1.150-1(b)) and will be made upon the delivery of the Bonds and not later than one year after the later of (i) the date such expenditure was paid or (ii) the date on which the Project was placed in service. This Section is intended to be a declaration of official intent within the meaning of Reg. 1.150-2.
7. **Executive Officers.** The Chairman, the Parish President, and the Clerk of the Governing Authority are hereby authorized to do all things necessary, on the advice of Bond Counsel and Municipal Advisor, to effectuate and implement this Resolution, including the publication and recordation hereof as may be required by the Act.
8. **Purchase Agreement / Commitment Letter.** An Executive Officer of this Governing Authority is authorized to execute and deliver to the purchasers of the Bonds, a purchase agreement, commitment letter, or such other document evidencing the intent to purchase the Bonds as the case may be, if deemed necessary upon advice of Bond Counsel.
9. **Authority to Proceed.** This Governing Authority hereby authorizes and directs Bond Counsel and the Municipal Advisor to proceed with the preparation of all necessary and appropriate financing applications and documents and to file drafts of said applications and documents with the State Bond Commission in accordance with its Rules.
10. **Other Professionals.** Should it be necessary to engage other professionals, an Executive Officer shall be authorized to engage such professionals provided the contracts employing such professionals shall be promptly submitted to this Governing Authority.
11. **Electronic Signatures.** The Governing Authority consents and agrees to the execution of documents by electronic signature in accordance with the Louisiana Uniform Electronic Transactions Act (La. R.S. 9:2601, et. seq.), and electronically executed documents are deemed binding and legal on all parties to the extent allowed by the provisions of that act.
12. **Effective Date.** This Resolution shall become effective immediately upon adoption or at the earliest date allowed by law.

**A RESOLUTION GIVING PRELIMINARY APPROVAL FOR THE  
ISSUANCE OF NOT TO EXCEED TWO MILLION DOLLARS

**PARISH OF ST. LANDRY, STATE OF LOUISIANA; PROVIDING CERTAIN TERMS OF SAID BONDS; MAKING APPLICATION TO THE LOUISIANA STATE BOND COMMISSION FOR APPROVAL; AND PROVIDING FOR MATTERS IN CONNECTION THEREWITH.**

**BE IT RESOLVED** by the St. Landry Parish Council, State of Louisiana, acting as the governing authority (the "**Governing Authority**") of the Parish of St. Landry (the "**Parish**"), State of Louisiana, that:

**WHEREAS**, pursuant to the Consolidated Local Government Indebtedness Act, Title 39, Subtitle II, Chapter 4, and particularly 39:1430 (Revenue Bonds) (the "**Act**") of the Louisiana Revised Statutes of 1950, as amended, and other applicable constitutional and statutory authority, it is now the desire of the Parish to adopt this Resolution to provide for the issuance of not exceeding Two Million Dollars (\$2,000,000) Revenue Bonds, in one or more series (the "**Bonds**"), for the purposes of the Project (as defined herein) as set forth herein;

**WHEREAS**, the Bonds, with respect to each series, will be secured by the ad valorem taxes and other revenues received and accruing in the Parish Roads and Bridges Fund and Road District 1 Fund (collectively, the "**Pledged Revenues**") which Pledged Revenues are authorized to be used for the purposes set forth herein;

**WHEREAS**, this Governing Authority desires to grant preliminary approval for the issuance of the Bonds and to make a formal application to the Louisiana State Bond Commission (the "**State Bond Commission**") for approval to issue the Bonds;

**NOW, THEREFORE, BE IT RESOLVED** by this Governing Authority as follows:

- 1. Preliminary Approval of Bonds.** Preliminary approval is hereby given to the issuance of the Bonds by the Parish, to provide funds for repairing, maintaining, and improving public roads and bridges, including acquisition, maintenance and/or operation of equipment and materials for said purpose (the "**Project**") within the area designated by the Parish as "**District 9 of Road District 1**" (the "**District**") and (ii) paying the costs of issuance of the Bonds.
- 2. Security for the Bonds.** The Bonds will be payable from and secured by an irrevocable pledge and dedication of the Pledged Revenues and shall bear interest at a rate or rates not to exceed six percent (6%) per annum, to be sold at the prices and in the manner to be determined by subsequent proceedings of this Governing Authority, and will mature over a period not exceeding eight (8) years from the date issuance, all in the manner provided by the Act.
- 3. State Bond Commission Approval.** Application is hereby formally made to the State Bond Commission, Baton Rouge, Louisiana, for its consent and authority to issue and sell the aforesaid Bonds, and a certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of this Governing Authority, together with a letter requesting the prompt consideration and approval of this application. Pursuant to the Parish's application for, acceptance, and utilization of the benefits of the Louisiana State Bond Commission's approval(s) resolved and set forth herein, it resolves that it understands and agrees that such approval(s) are expressly conditioned upon, and it understands, agrees and binds itself, its successors and assigns to, full and continuing compliance with the "State Bond Commission Policy on Approval of Proposed Use of Swaps, or other forms of Derivative Products Hedges, Etc.", adopted by the Commission on July 20, 2006, as to the borrowing(s) and other matter(s) subject to the approval(s), including subsequent application and approval under said Policy of the implementation or use of any swap(s) or other product(s) or enhancement(s) covered thereby. For purposes of meeting the requirements of the May 11, 2009, memorandum of the Director of the State Bond Commission to all bond counsel, any proceedings of the Parish relating to the Bonds that refers to a principal amount or interest rate of the Bond shall be deemed to include the words "not to exceed" or "not exceeding" whether so stated or not, and any reference to a final maturity date or term contained herein shall be deemed to include the words "to mature on or before" whether so stated or not.

4. **Bond Counsel.** This Governing Authority finds and determines that a real necessity exists for the employment of special bond counsel in connection with the issuance of the Bonds, and accordingly, LaFleur & Laborde is hereby employed as Bond Counsel to do and perform comprehensive legal and coordinate professional work with respect to the issuance and sale of the Bonds ("**Bond Counsel**"). Bond Counsel shall prepare and submit to this Governing Authority for adoption all of the proceedings incidental to the authorization, issuance, sale, and delivery of the Bonds, shall counsel and advise this Governing Authority as to the issuance and sale of the Bond, and shall furnish its opinion covering the legality of the issuance of the Bonds. The fee of Bond Counsel shall be fixed at a sum not exceeding the maximum fee allowed by the Attorney General's fee schedule for comprehensive, legal, and coordinated professional work in the issuance of revenue bonds and based on the number of bonds issued, sold, delivered and paid for, plus "out-of-pocket" expenses, said fees to be contingent upon the issuance, sale, and delivery of said Bonds. A certified copy of this resolution shall be submitted to the Attorney General of the State of Louisiana for his written approval of the employment and of the fees described herein, and the Clerk is hereby empowered and directed to issue payment or to authorize payment Bond Counsel upon completion of the work and under the conditions specified herein.
5. **Municipal Advisor.** The employment of Sisung Securities Corporation, Metairie, Louisiana as Municipal Advisor ("**Municipal Advisor**") pursuant to a Municipal Advisor Engagement Letter dated October 17, 2024 is hereby ratified and confirmed.
6. **Declaration of Official Intent.** Before the delivery of the Bonds, the Parish anticipates that it or the District may pay a portion of the costs of the Project from their General Fund and other available funds. Upon the issuance of the Bonds, the Parish reasonably expects to reimburse any such expenditures of other available funds from a portion of the proceeds of the Bonds. Any such allocation of proceeds of the Bonds for reimbursement will be with respect to capital expenditures (as defined in Reg. 1.150-1(b)) and will be made upon the delivery of the Bonds and not later than one year after the later of (i) the date such expenditure was paid or (ii) the date on which the Project was placed in service. This Section is intended to be a declaration of official intent within the meaning of Reg. 1.150-2.
7. **Executive Officers.** The Chairman, the Parish President, the Clerk, and/or any such other officer (individually or collectively, the "Executive Officers") of this Governing Authority are hereby authorized to do all things necessary, on the advice of Bond Counsel and Municipal Advisor, to effectuate and implement this Resolution, including the publication and recordation hereof as may be required by the Act.
8. **Purchase Agreement / Commitment Letter.** An Executive Officer of this Governing Authority is authorized to execute and deliver to the purchasers of the Bonds, a purchase agreement, commitment letter, or such other document evidencing the intent to purchase the Bonds as the case may be, if deemed necessary upon advice of Bond Counsel.
9. **Authority to Proceed.** This Governing Authority hereby authorizes and directs Bond Counsel and the Municipal Advisor to proceed with the preparation of all necessary and appropriate financing applications and documents and to file drafts of said applications and documents with the State Bond Commission in accordance with its Rules.
10. **Other Professionals.** Should it be necessary to engage other professionals, an Executive Officer shall be authorized to engage such professionals provided the contracts employing such professionals shall be promptly submitted to this Governing Authority.
11. **Electronic Signatures.** The Governing Authority consents and agrees to the execution of documents by electronic signature in accordance with the Louisiana Uniform Electronic Transactions Act (La. R.S. 9:2601, et. seq.), and electronically executed documents are deemed binding and legal on all parties to the extent allowed by the provisions of that act.

**12. Effective Date.** This Resolution shall become effective immediately upon adoption or at the earliest date allowed by law.

**RESOLUTION NO. 030-2024**

A resolution approving the holding of an election in Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana, on Saturday, March 29, 2025, to authorize the renewal of a special tax therein.

WHEREAS, the Board of Commissioners of Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana (the "Governing Authority"), acting as the governing authority of Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana (the "District"), adopted a resolution on November 19, 2024, calling a special election in the District on Saturday, March 29, 2025, to authorize the renewal of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Landry, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to authorize the District to continue to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of St. Landry, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, March 29, 2025, at which election there will be submitted the following proposition, to-wit:

PROPOSITION  
(MILLAGE RENEWAL)

Shall Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana (the "District"), continue to levy a special tax of 10.36 mills on all property subject to taxation in the District (an estimated \$2,422,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2026 and ending with the year 2035, for the purpose of constructing, maintaining and operating the District's fire protection facilities, and paying the cost of obtaining water for fire protection purposes, provided that a portion of the Tax proceeds is required to be contributed to state and statewide retirement systems as provided in R.S. 11:82?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.

**RESOLUTION NO. 031-2024**

Resolution authorizing the filing of an application with the State of Louisiana FY 2025 Community Development Block Grant (LCDBG) Program.

WHEREAS, there are many dilapidated and potentially dangerous buildings and structures in St. Landry Parish.

THEREFORE, BE IT RESOLVED, by the St. Landry Parish Council that the St. Landry Parish Government approves the project to demolish all structures listed in this resolution.

THEREFORE, BE IT FURTHER RESOLVED, by the St. Landry Parish Council that the St. Landry Parish Government shall be responsible for all legal fees that are incurred during the preparation and/or implementation of this program. Local funds will be used to pay all legal fees incurred by the St. Landry Parish Government.

THEREFORE, BE IT FURTHER RESOLVED, by the St. Landry Parish Council that the St. Landry Parish Government shall be responsible for all administrative costs associated with the implementation of this program; such costs will include, but not be limited to application preparation fees, audit fees, advertising and publication fees, local staff time, workshop expenses, and/or administrative consultant fees. Local funds will be used to pay all administrative costs incurred by the St. Landry Parish Government.

**PUBLIC WORKS COMMITTEE MEETING MINUTES**

1. Public Works Chairwoman Vivian Olivier called this meeting of the Public Works Committee of the St. Landry Parish Council to order.
2. **Roll Call:** Jody White, Mildred Thierry, Alvin Stelly, Timmy Lejeune and Jimmie Edwards. Ex-Officio Wayne Ardoin. **ABSENT:** None.
3. **Person to address the Committee:**

*Mr. Brian Anthony Romar addressed the council. He stated, “How are you all doing this evening? My name Brian Anthony Romar. I am from Rideau Settlement that was established in 1857. I had a problem with Animal Control. I am not saying that I was all the way right but I was not all the way wrong. Animal Control seized 71 head of animals from me. If 71 head of animals would have been out they still would have been running around trying to catch them. All the animals that they picked up was not out. They did it in two sessions. One time they came and they did not have a search warrant and they picked up 17 heads of horses. They waited three days to four days later and they came back with a warrant and the cattle was pinned up and they could not get out and they had not been out for at least a week but they seized them too. I think I was wrongfully treated and I would like to present this to the council and let them know how I feel about the situation. I went to get my animals and they told me that I had a fine of \$17,000.00. I told them that I would pay it and they told me that I still could not get my animals. I ask them why not? They said because you can’t you will have to go to court. I asked about the court date and they could not tell me. They told me to go down to the DA’s Office and I went down to the DA’s Office. The DA did not know anything about it. I ask why did the Animal Control send me here, I don’t know. If you have power use it in the right way. If you got me right you got me right but if you are wrong you are wrong. That is all that I have to say.”*

**Councilman Dexter Brown stated,** “Mr. Romar can you step back to the microphone please. In total how many of your horses were confiscated? Roughly.”

**Mr. Brian Anthony Romar stated,** “17 and 6. That would be 23 total.”

**Councilman Dexter Brown questioned,** “The rest of the animals that were confiscated were cattle. Did Animal Control tell you the reason why?”

**Mr. Brian Anthony Romar stated,** “They said because they had been getting out. I had some animals that had never been out. I am not saying that I did not have some animals out but it was not 71 head.”

**Councilman Dexter Brown stated,** “Did you have fencing around?”

**Mr. Brian Anthony Romar stated,** “Where the horses were they had not been out in a long period of time. They had a drought, they had wind come through and they had several trees on it. I am only me, I don’t have anybody to help me with this so it takes me time.”

**Councilman Dexter Brown stated,** “So you are basically out of 48 head of cattle that they confiscated.”

**Mr. Brian Anthony Romar stated,** “No together 71 heads with the horses. With the cattle it is probably about 62 or 63 heads.”

**Councilman Dexter Brown stated,** “Did you call Mr. Bellard?”

**Mr. Brian Anthony Romar stated,** “He did not want to talk to me.”

**Councilman Dexter brown questioned,** “Mr. Bellard, can you say anything about this? Is it under investigation or what?”

**Parish President Jessie Bellard stated,** “No it is not under investigation. The DA’s Office has the matter and they are going to bill him with the proper charges. The \$17,000.00 he is speaking about is not a fine it is a bond in order for us to feed the animals and stuff. But it is not an issue it is an issue with the DA’s Office and they are handling the case. So it is between him and the District Attorney’s Office.”

**Mr. Brian Anthony Romar stated,** “If I was charged with something why didn’t I get a citation or something saying I was charged with that?” Why? Answer me that.”

**Parish President Jessie Bellard stated,** “Your argument is with the District Attorney’s Office.”

**Mr. Brian Anthony Romar stated,** “My Argument is why I did not get something when you picked the animals up saying what I was charged with?”

**Parish President Jessie Bellard stated,** “So let me do this Dexter if you don’t mind. I was trying not to embarrass people but I am just going to tell you what is happening. This has been going on for about 18 months. Over the time there have been calls after calls after calls. We worked with Mr. Romar for the last 18 months on this same issue to no resolve. So at this point there is nothing else for us to do. I like to give people opportunities to fix their fences and make sure their animals don’t get out. I have animals, you have animals, a lot of us do and things happen, however this is an ongoing problem and it is not getting fixed so now he is being charged with the District Attorney’s Office and they are going to proceed further in court. It is out of our hands but we tried for 18 months working with Mr. Romar. So we are not working with him anymore.”

**Councilman Dexter Brown stated,** “Okay, thank you sir.”

**Mr. Brian Anthony Romar stated,** “You said 18 months. You said 18 months. It was not constantly 18 months.”

**Parish President Jessie Bellard stated,** “Like I explained to Mr. Brown I am not working with you anymore.”

**Councilman Dexter Brown stated,** “Mr. Romar if you don’t mind can you get together with Mr. Chad Pitre and his office the District Attorney and see what type of resolution can come about. They Bush-Hog and it is grass. It goes to a Bayou and it is a dead-end road and it serves two farmers. It would be a waste of money to place Limestone with all of these roads that need Limestone, I don’t feel justifiable. If the road would be used and it would need Limestone I would do what I have to do. At this point I don’t see that it is necessary but it is up to you all to tell me what to do. I just don’t think that it is necessary to waste limestone on this road. It is actually two turn roads for farmers. We provide drainage and we do the ditches and we do everything else.”

**Councilman Timmy Lejeune stated,** “Live Oak Road.”

*Mr. Barry Soileau, Public Works Director stated, "Live Oak Road same thing. We maintain it."*

*Councilman Timmy Lejeune stated, "It connects to that."*

*Mr. Barry Soileau, Public Works Director stated, "Correct."*

*Councilman Timmy Lejeune stated, "Grassy Lane and that whole road exits on two state highways."*

*Mr. Barry Soileau, Public Works Director stated, "Correct. Hwy 358."*

**Councilman Timmy Lejeune stated,** "One time we had to change a culvert out on a bridge because you could not get through there. Exiting on both sides of the highway there is material on both sides of that road so it is suitable for passage if someone cuts across? I am going to use the word accident, if they have an accident in that curb where that state bridge is located and they have to use that as an alternate route for a minute can cars or vehicles pass down there?"

*Mr. Barry Soileau, Public Works Director stated, "Certainly, the only time there is an issue is when the cane farmers are working you are going to have some mud on the road. The farmer who does that really accommodates. He picks up all of the debris and he will call me after it dries, I go and re-grade and pull the road and we put material as needed."*

*Councilman Timmy Lejeune stated, "I am going to make a request that if we get some Black Gold or anything that we can get from the state we can address those roads and we are not purchasing Limestone or some material of some kind. I would appreciate it that we would take that into consideration."*

*Mr. Barry Soileau, Public Works Director stated, "Sure will."*

*Councilman Timmy Lejeune stated, "I know that this guy have been trying to get some of that done for quite a long time. It is the second time that I have placed this on the agenda. I am asking that we could please look at that."*

*Mr. Barry Soileau, Public Works Director stated, "We could put some crush cement down there but this is what is going to happen, when they get on the bush-hog they are going to start complaining because material will be flying into the fields and everywhere else. I will take it into consideration. As soon as we get crush cement I will put them some."*

## ADMINISTRATIVE/FINANCE COMMITTEE MEETING MINUTES

1. Chairman Harold Taylor called this meeting of the Administrative/Finance Committee of the St. Landry Parish Council to order.
2. Councilman Faltery Jolivette led the Pledge of Allegiance & Invocation.
3. **Roll Call:** Nancy Carriere, Faltery Jolivette, Dexter Brown and Ernest Blanchard. **Ex-Officio** Wayne Ardoin. **ABSENT:** Ken Marks.
4. **Person to address the Committee.**

*Major Mark LeBlanc-St. Landry parish Sheriff Depart/Crime Stoppers Coordinator addressed the council. He stated, "My name is Mark Allen LeBlanc. I live at 448 St. Jude Avenue, Opelousas, LA. I have some handouts if I may pass them out and I really appreciate the time to speak before you. I come before you not really to ask for anything of any material significant and I am not asking for money. I know that it is a bit unusual but I am actually here to present a hope of very brief proposal of my recent duties. Many of you have known me a long time, I actually came out of retirement once again much to my wife's dismay to go back into law enforcement. I have been with the St. Landry Parish Sheriff's Department just over three and one-half years. The Sheriff in his wisdom has seen fit to promote me to major and I am now the Public Information Officer, I am also the Crime Stoppers Coordinator. I work directly with the St. Landry Crime Stoppers Board. I presented this to them and I got an overwhelming response so I am hoping I am on the right track. I am here to present this to you but also to seek information and guidance and if you think I am going down the wrong road that is fine or maybe there are other suggestions that you may be able to offer. The objective here is to assist in the combatting of the prevalent litter and dumping that goes on throughout our beautiful parish. I have listed the vested parties but we only need to drive around our rural areas to see what extent this travesty has occurred. I truly believe that our parish government and its resources are doing everything humanly possible to try and clear this up. The problem is that it happens and it has to be located and the resources are allocated. There are not enough resources to deal with the problem on the magnitude that we have but we have another resource and that is our citizens. I want to try and use St. Landry Crime Stoppers to utilize our citizens in keeping watch over our citizens to make sure that when dumping occurs they report it and they can be rewarded through the Crime Stopper Program. When I started this I was unaware of the detail components of the statue involved which is under the Louisiana Revised Statues 30. I was pleasantly surprised to find out that throwing a cigarette butt, the citation cost is \$300.00. It only goes up radically from that point. If you get caught dumping a tire that is a \$1,800.00 fine and you will pay for the cost of retrieval and you will pay for the cost of the transportation of the tire and you will pay for the cost of the disposal and the proper recycling disposal of the tire. That is written in the law. I have recently spoken with our District Attorney, Mr. Chad Pitre and he assures me that he has not yet and he will not forgo any of these citations. He said to this date every citation for littering or dumping that has gone through his office went through and it went to court. Whatever benevolence the judge sees fit within the boundaries of the law of course that prevails. We have the teeth to make this work and I think it is just a matter of getting the word out to our citizens and allowing them the opportunity to enforce each other and we will pay the tip money. The dollar amount have to be assigned. It is a mathematical computation that is used by Crime Stoppers. It is based on the level of the criminal act defined and the fees accessed etc. People may be getting a couple of hundred bucks for turning people in for dumping, littering or whatever, there are three primary grades. I am happy to say or I am more fully ignorant of any industrial dumping that goes on in our parish. I think that you all have a handle on that. Many years ago Solid Waste has really taken the bull by the horn in that regards. Now we are looking at the two lower levels which is gross dumping and littering. I may need from this a gust body either individually or collectively your appearance in a Promotional Public Service Announcement of some type. You only have to look to the south of us and see Lafayette has been running an Anti-Litter Program. We have to see the likes of Mr. Stuller who owns Stuller Settings, picking up trash. That impacts the public to see our elected officials promoting this and to see our other promote citizens business leaders promoting this and it can only have a positive effect. I have to admit this stuck close to home. I live in Westgate Subdivision which is a beautiful little subdivision and I have to tell you that they have one short section of wooded area on St. Berchman right now, Andrepont Road and I have been maintaining the grass along that road out of the goodness of my heart because it make it easier to see the intersection and it does*

not cause me any grief doing it. One weekend I filled the front end loader bucket of my tractor with trash. My neighbor came alone three days later pulling a cart and had it overflowing with trash. That is ridiculous, it is absolutely ridiculous. Some of these areas are not easily monitored. It would be very difficult to set a camera system or something. I have assurances from the sheriff and we have a camera surveillance system and we may be able to use it if it is not being occupied in any other activities. There may be some other resources that we can bring to bear the help with this. We would prefer that the word get out with a strong enough message that the citizens correct their own behavior. I would much rather see our parish resources utilized for the beautification of our parish instead of having to clean up everybody else mess. I don't think any of our good citizens here today would argue with that. Some of it is innocent enough and sometimes a little piece of something blows out of the back of a truck I am not worried about that. When I am seeing dumping of garbage bags full of trash that is being thrown out of vehicles. I am here to present this and you have my contract information and I would really appreciate any suggestions. The older I get and the longer I do this sometimes the dumber I feel. I really respect the opinion of others, any of our citizens and any of our other community leaders you know of please pass this word on and I am looking at a start date sometimes in 2025, right before the spring or something along those lines. Are there any questions?"

**Councilwoman Nancy Carriere questioned**, "Are you going to work in conjunction with the two detectives?"

**Major Mark LeBlanc stated**, "I certainly can. I would be more than happy to work with anybody and everybody in this endeavor. We will be utilizing our own enforcement personnel within the Sheriff's Department. The city themselves pretty much have a grasp on everything. I think the biggest problem area is mostly the rural area within the parish."

**Councilwoman Nancy Carriere stated**, "I just want to tell you that I go on St. Patrick's every day and I saw you last week so kudos to you."

**Major Mark LeBlanc**, "Thank you Ma'am."

**Councilman Faltery Jolivette stated**, "Thank you very much. My question is this, what is the next step? What is next?"

**Major Mark LeBlanc**, "We are going to get together with the Crime Stoppers Board. By the way I have a slogan, I don't know if it will take off or not, this is not my area of expertise. I would like to see the primary slogan saying: "**Store it, don't throw it.**" It is not a copyright slogan and nobody have used it in anywhere. It has typically been used in Florida along waterways. I am modifying it for use here within our parish."

**Councilman Faltery Jolivette stated**, "We won't be infringing on come some copyright?"

**Major Mark LeBlanc**, "No Sir. I researched that."

**Councilman Faltery Jolivette questioned**, "How do we get the word out? How do we advertise it?"

**Major Mark LeBlanc**, "That is going to fall to our wonderful news media. My relationship is the public information with the Sheriff's Department. I will endeavor to meet with our area news people and see if we can get PSA's their call and try to mention it in each and every possible opportunity when we have engagements with our news media. As much as I can and as much as they are allowed a saturation of information we are looing at possibly utilizing handouts, they don't call them bumper stickers anymore but the sticker program we initiated one with Crime Stoppers that went over like crazy. In fact we recently won a national award for our sticker program for St. Landry Crime Stoppers. I am hoping to do it that way through connections with other Crime Stopper Entities throughout the United States. We can poll information from them and find best practices, techniques to get the information out there. It can be as simple as word of mouth."

**Councilman Faltery Jolivette stated**, "Thank you. That will work. I appreciate your efforts."

**Councilman Ernest Blanchard stated,** “It just so happen that I had dinner with a Code Enforcement Officer in Eunice today. We turned in 23 sheets to Richard LeBouef and his crew. That is how much debris we have in Eunice. When the wind blows it is all over the streets. You might want to talk to Richard LeBouef to see if you can get some help.”

**Major Mark LeBlanc,** “I would appreciate that. We have noticed in our subdivision when you have massive amount of trash I would argue and I would be willing to argue with anybody that we don’t have a drainage problem in this parish we have a debris problem. Some of that is going to be naturally occurring and that is just something that the maintenance crews are going to have to handle but I am telling you the amount of trash that have choked off drainage just in my subdivision. I can’t tell you in the 25 years that I have lived there how many times my yard has been completely inundated with water. You are talking about property damage, let’s hit it where it means the most. If you can stop the flooding through this effort or mitigate the flooding if nothing else then you will stand a high probability of people suffering less property damage, less cooperate damage and business damages from flooding which hopefully will reduce our rates and I don’t think anybody will argue against that.”

**Mr. Perry Fontenot addressed the council regarding his application for the SLED Board. He stated,** “Good afternoon I am Perry Fontenot. This is my daughter Karis Fontenot, she is a dancer with Ms. Grace Hamilton and my son is with me but he had to step out, he wanted to go to the restroom. My address is 122 Spanish Moss Lane here in Opelousas. Mr. Chairman, board, thank you for having me this evening. I just wanted to inform the board that I will be applying for the SLED Board Position.”

**Administrative/Finance Chairman Harold Taylor stated,** “Tell us a little bit about yourself.”

**Mr. Perry Fontenot stated,** “I am an Environmental Scientist. It was great to hear the conversation we just talked about with the debris. I am the Regional Consultant at DQ for the Acadian and Central Louisiana Region. I work primarily with small businesses and outreach development. Just today I was in Jennings doing what they call Enviroscape talking about liter and pollution and developing a plan on how to stop a lot of those things in that area. Additionally I am a Lieutenant in the Army, a Special Project Officer. Whenever there is an emergency we go to the Regional Staging area which is in Roseland and we wait for the respective Parish Presidents to send out their orders and we make sure the respective comedies get to the regions wherever requested.”

**Councilman Faltery Jolivette questioned,** “Mr. Fontenot, what is your interest? I read your notes, why would you want to serve?”

**Mr. Perry Fontenot stated,** “Why not, I am a citizen here in the parish and I feel that I have a lot to offer. Giving that I am working primarily with small business and having the military connection I think that is something that I can contribute to the board.”

**Councilman Faltery Jolivette stated,** “Thank you.”

**Administrative/Finance Chairman Harold Taylor stated,** “Are there any other question? Thank you very much. Our next speaker is Mr. Thurman Johnson. Please give us your name and address and tell us about yourself.”

**Mr. Thurman Johnson addressed the board regarding his application for the SLED Board. He stated,** “My name is Thurman Johnson. I live at 408 Collins Lane, Opelousas. The Plaisance area, Ms. Thierry’s District. I am a Business Manager at Great Beginning Pediatrics, my wife’s pediatrics practice. I am also co-owner of Pedro’s Lodge and Event Center here in downtown. I am a former member of the Chamber of Commerce Board of Directors. The chairman of the board three years ago, I am also on the Chamber Foundation Board. I call myself an in port to Louisiana because I was born and raised in Beaumont Texas. We moved to Austin Texas. I was an Electrical Engineer, Manufacturing Engineer Project Manager. I also spent some time in St. Clair and Silicon Valley with my job. We moved here because my wife wanted to move back home. She is a Plaisance girl. We came back home for her to open up her practice.”

**Administrative/Finance Chairman Harold Taylor stated,** “Are there any questions?”

**Councilman Faltery Jolivette questioned** “Why?”

**Mr. Thurman Johnson stated**, “I wanted to continue to use my experiences in the different areas. I was also a coach here at North West High School and I have been around the kids. I have two boys of my own who are in college. Unfortunately I don’t feel that they can come back here to work. It needs to have more business opportunities and I feel my experience can help with that. I have seen Austin grow from to what it is now. I lived there during that time and it is a big difference. I think I can share some of that experience here and hopefully build something for our youth to come home for.”

**Administrative/Finance Chairman Harold Taylor stated**, “Are there any other questions for Mr. Johnson? Our next speak is Ms. Toni Effingger.”

**Ms. Toni Effingger addressed the board regarding her application for the SLED Board. She stated**, “How are you all doing today? My name is Toni Effingger. My address is 329 Rodeo Drive, Opelousas. I am re-applying to continue my spot on the SLED Board. During the time that I originally got on the SLED Board it was 2020. There were a lot that we did not get a chance to do in 2020 because of COVID. It took a long time to understand what the process was in being on the SLED Board and what my purpose was. After being there for the last four years I want to continue so I can continue to learn and continue to help. I am the Broker Owner of Re/Max Excellence Real Estate here in Opelousas so I am working to make everybody a home owner so that we can combat crime so that we can have business growth. That are some different things that I feel that I can offer based on my experience. My family is originally from here but I was not raised here, I came back here so that I can be in between my parents and care for them. Opelousas have grown on me so it is my home and I want to continue to support the SLED Board and its growth to Opelousas. Do you all have any questions for me?”

**Councilman Faltery Jolivette stated**, “You pretty much answered them.”

**Ms. Toni Effingger stated**, “Thank you. “By the way, I think you all have a flyer for the Thanksgiving Dinner.”

**Administrative/Finance Chairman Harold Taylor stated**, “Ms. McKnight, Ms. Devin McKnight. Please state your name and address and you may have the floor.”

**Ms. Devin McKnight addressed the board regarding her application for the SLED Board. She stated**, “Good evening everyone. My name is Devin Manuel McKnight. My address is 713 S. Walnut Street, Opelousas, LA. I just want to thank each and every one of you for allowing me to come forward to formally introduce myself. I have recently applied for the SLED Position. I am a lifelong resident here in St. Landry Parish, District 2. I am the youngest of two girls. My mother is Della Lewis Manuel and my father is Martin Wayne Manuel. I am happily married to my husband Alfred Brandon McKnight. We have been happily married for four months now as of today so I am a newlywed. I am a graduate of Opelousas High School and upon from graduating from Opelousas I attended the University of New Orleans. There I received my Bachelor of Science and Business Management with a Concentration in Human Resources. Thereafter I went back to graduate school and I received my Master of Business Administration with a Secondary Degree in Health Care Management. With my education as well as with my professional background I have served 8 years in the Health Care Profession with 6 of those years being with Ochsner Lafayette General. There I am the Clinical Supervisor and I oversee 7 clinics. I also work with a team of medical professional that range from doctors to nurse practitioners to nurses and a multitude of other health care professionals, I love what I do. I love what I do and I love being a service to all individuals and I feel that health care is definitely the place for me. In addition to my professional I am deeply committed in my Faith. I am a lifelong Parishioner of Holy Ghost Catholic Church. There I am a Lector, a Eucharistic Minister and when needed I am an Adult Alter Server. In addition to that I have had the honor of being the Chairperson for the Centennial Core Committee when we celebrated our 100<sup>th</sup> year celebration for Holy Ghost. I am also a member of the Knights of Peter Claver and the Ladies Auxiliary Court 8. In that organization I serve as the Junior Daughter Assistant Counselor. That is basically me wrapped up in one. I truly feel that I would be beneficial and an asset to the SLED Board and I look forward to it. I feel that I have strong communication skills and I am a team player and I am extremely supportive of the people that I work along beside me. I am a strategic planner and there are a wide range of things that I can do. I can go on and on but I won’t do that

tonight. I appreciate you all letting me come forward to speak to you. I am open to any and all questions if anyone have any.”

**Councilwoman Mildred Thierry questioned,** “What is your name again?”

**Ms. Devin McKnight stated,** “My name is Devin Manuel McKnight.”

**Councilman Faltery Jolivette questioned,** “Are you going to have some time to serve on the board?”

**Ms. Devin McKnight stated,** “Absolutely. I always have time. I make time.”

**Councilman Faltery Jolivette stated,** “Thank you Ms. McKnight.”

**Ms. Devin McKnight stated,** “Thank you and you all have a blessed evening.”

##### **5. Parish President & Finance Reports:**

**Parish President Jessie Bellard stated,** “You all have in front of you the Inventory Tax that the Governor is proposing for this year. The Inventory Tax that they want to take away from the Tax Rolls. In front of you is what we would actually lose as a parish. When I am talking about as a parish is what we collect to run Government as Parish Government. That is not counting District 5 or District 6. That is \$9,100,000.00 and some change. I meet with the Governor two weeks ago and there were 26 Parish President’s in the room and every last one of us said that same thing, we can’t do it. If this tax goes away we can’t survive as a Government because of a lot reasons. Number one: Mandated Expenses. Our Mandates are \$4,600,000.00 per year as we sit now. We collect about \$4,000,000.00 a year in taxes for that Mandate. We are already \$600,000.00 in the hole. If we would take the option of doing away with the Inventory Tax that would cripple us another \$900,000.00 a year for Parish Government’s Mandated Expenses. The option of that and I can pretty much tell you that we are going to probably say ‘No’ and every last one of us in that meeting told them ‘No’. There are two other options where if you phase it out over 5 years we would get \$8,000,000.00 upfront money and that would carry us over for basically 7 years. In 7 years you have to find a way to recoup your \$900,000.00 that you are losing. There is another option that gives you \$15,000,000.00 if you phase it out now. January 1, 2025 and you phase it out you get \$15,000,000.00 but as you can see that is \$9,000,000.00 right here just on what Parish Government takes in and that would not help us at all. So they are doing away with the Franchise Tax so the business Community will get a break on the Franchise Tax. I don’t know of any parish in the State of Louisiana that will do the Inventory Tax voluntarily because of the loss of revenue for each one of them. Other than that we haven’t seen anything that is going to be drastic as far as Government is concerned. This is something that if we take that option we would lose a lot of money that we could not function without it. Sherry put this together for us and I wanted to hand it out to you all tonight so you all can have it and look at it and see what you all think about it. I don’t know if anybody is going to take it. They are leaving it up to the Parish President, the Sheriff and the School Board Superintendent. It has to be a unanimous decision to take it or not take it. I did not say nothing one way or the other but I am telling you all unless you all tell me different I am going to say ‘No’ because I don’t see where we are benefitting at all with this program. I wanted you all to get a copy of it so you all can see the actual numbers that Sherry put together for us.”

**Administrative/Finance Chairman Harold Taylor stated,** “So Mr. President if I understand it right the Governor wants to do away with the Inventory Tax. As it is today these merchants pay the Inventory Tax and then they get a refund from the State and he want to eliminate the state’s share of it.”

**Parish President Jessie Bellard stated,** “That is correct.”

**Administrative/Finance Chairman Harold Taylor stated,** “If I am correct then he is going to allow the parishes to continue doing the Inventory Tax, in other words he is shifting the responsibility. How is he saying that, he is getting the cut and he is making us the culprits?”

**Parish President Jessie Bellard stated,** “It is not a bad thing but it is the truth and he told us that. He is taking away the credits on this. It is \$285,000,000.00 that the state pays in credits. He told us that he is taking it away and you all have the option to keep it on the books or not but that is



the decision for the locals. He was open and honest with it and that is what his plan is. It is up to the locals to decide on how.”

*Administrative/Finance Chairman Harold Taylor stated, “So when do we have to do that?”*

*Parish President Jessie Bellard stated, “They have to pass it. I think the session just started today. I just wanted you all to have this in front of you all and the most recent information that I received from the Governor Office reference to this. Out of everything in the package this is the one that we were most worried about and it is an option so it is not mandatory. There were 26 parishes there were there and none of us said that we were taking the option.”*

*Administrative/Finance Chairman Harold Taylor stated, “Are there any other questions? Is there anything else?”*

*Parish President Jessie Bellard stated, “Yes Sir. The other thing is one of the issues we are having in collecting the liens on adjudicated properties. Whenever an adjudicated piece of property comes up we go and we clean it up and we put a lien on the property. They have been going straight to the Sheriff’s Office and redeeming the property without paying the lien. What I want to is pass an Ordinance requiring that a lien certificate or release is given by the parish once we collect the liens on it before they can redeem their property back. The Sheriff may collect it, there is no saying that he shall but Lance told me today that it is an ordinance that we have to pass on a local level to require that anybody going to redeem property. If there is a Governmental Lien on it they have to pay the Lien first before we will release the property. I want to get that ordinance drafted and bring it back to the council for the full council meeting. I just wanted to give you all that as the information.”*

A motion was made by Councilman Dexter Brown, seconded by Ernest Blanchard to accept the Parish President & Finance Report.

*Administrative/Finance Chairman Harold Taylor stated, “Are there any questions? The next item was a discussion of the budget. Are we ready to go forward with a budget?”*

*Parish President Jessie Bellard stated, “I was going to ask if you all wanted to form a committee to sit down so we can look at that budget cuts that we will have to do this year. I am good with whoever you all want to put on the committee. Whatever you all decide.”*

*Administrative/Finance Chairman Harold Taylor stated, “Do you want the Finance Committee to serve on that?”*

*Parish President Jessie Bellard stated, “That is fine.”*

*Administrative/Finance Chairman Harold Taylor stated, “If someone can’t then we will bring in another member. The Chairman should be around I am sure.”*

*Chairman Wayne Ardoin stated, “I will be glad to sit on it.”*

*Administrative/Finance Chairman Harold Taylor stated, “We can’t be seven members correct?”*

*Parish President Jessie Bellard stated, “Right, correct, yes Sir.”*

**RESOLUTION NO. 030-2024**

A resolution approving the holding of an election in Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana, on Saturday, March 29, 2025, to authorize the renewal of a special tax therein.

WHEREAS, the Board of Commissioners of Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana (the "Governing Authority"), acting as the governing authority of Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana (the "District"), adopted a resolution on November 19, 2024, calling a special election in the District on Saturday, March 29, 2025, to authorize the renewal of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Landry, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to authorize the District to continue to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of St. Landry, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, March 29, 2025, at which election there will be submitted the following proposition, to-wit:

**PROPOSITION  
(MILLAGE RENEWAL)**

Shall Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana (the "District"), continue to levy a special tax of 10.36 mills on all property subject to taxation in the District (an estimated \$2,422,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2026 and ending with the year 2035, for the purpose of constructing, maintaining and operating the District's fire protection facilities, and paying the cost of obtaining water for fire protection purposes, provided that a portion of the Tax proceeds is required to be contributed to state and statewide retirement systems as provided in R.S. 11:82?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.
