### REGULAR COUNCIL MEETING MINUTES

The Council of the Parish of St. Landry, State of Louisiana, convened in a regular session on this 20<sup>th</sup>, day of November, 2024 at 6:00 p.m.

- I. Chairman Wayne Ardoin called the meeting of the St. Landry Parish Council to order. He asked that the audience please silence all of their electronic devices.
- II. Councilwoman Nancy Carriere led the Pledge of Allegiance & Invocation.

**Chairman Wayne Ardoin stated**, "I am going to ask at this time that the agenda be amended to add two ordinances. Ordinance No. 2024-048. \*Chairman Wayne Ardoin called for a moment of silence for the families that lost their loved ones.

### V. PERSON TO ADDRESS THE COUNCIL:

Sheriff Bobby Guidroz addressed the council. He stated, "Thank you Mr. Chairman. I am here to give you all some information regarding where we stand, the Sheriff's Office with the new Trustee Dorm, I am really impressed with it. I don't know if you have been to see it but Jessie you all did a great job with it. I am happy that we can at least put 68 inmates in there and that is going to save Parish Government a lot of money. A couple of things I wanted to mention to you regarding inmates and the state inmate issue. Jessie and I have been discussing for a while and I think that we are coming close to settling our, it is not an argument, it is just a disagreement on some of the things that have come up. I want you all to know that I am committed fully to staffing a new trustee dorm. I appreciate that effort that you all put in, it is really a nice, nice facility. I am looking forward to moving in hopefully in early January. We have to get the Fire Marshall if you all have not done it already and I think the Board of Health needs to come in. The Department of Corrections already came by and we toured it and she was impressed. It is going to be a total Male Dorm. We are not going to have any Female Corrections Officers working in there because it is an open dorm setting. It is not going to be a problem for us. I have to hire 8 additional Correction Officers which is not a problem, we have the money in the budget and I am looking forward to really getting this thing going. The cost of 8 new Correction Officers is right under \$500,000.00. It is expensive with related benefits and salaries, again my department budget is sound and financially able to handle the hiring of these people so don't let that concern you because it does not concern me at all, we are ready. An update for you on the State Inmate Food Reimbursement, Mr. Bellard and I had a conversation regarding State Inmate Food Cost about two or three months ago. We are almost there, we have just a few little things to work out. My lawyer called me this afternoon and spoke to Lance, your attorney."

### Parish President Jessie Bellard stated, "Correct."

Sheriff Bobby Guidroz continued to state, "I think that we are just about there. We get \$26.38 a day per inmate, for State Inmates. I want to help Parish Government and I understand that you are spending a lot of money every month to house Inmates in other parishes. I hope you don't mind me saying but \$100,000.00 a month is a lot of money for Parish Government to be spending on inmates in other parish jails. This facility, the Trustee Dorm is going to be a big, big help to that. We are looking forward to it. I have agreed to pay whatever the cost is to Parish Government once we know what that cost truly is. I spoke to my Financial Officer and she says and I think that Jessie is aware of it, we are going to get a Faxed Sheet showing my Financial Officer what it actually cost to feed the State Inmates. We know Parish Government have to feed our local inmates but when it comes to State Inmates it is a different ball game. So there is a different cost associated and I understand and respect that. I certainly want to help Parish Government get that done, hopefully we can come to an agreement before December, I think that will be workable. Parish Government is going to provide us with some Financial Documentation that we requested. My Financial Officer said because I am disbursing

money from my budget, which I understand is what she wants me to do, so in order to show our Auditors how much money we are paying Parish Government to help feed the State Inmates she needs something in writing to show the cost, so that is what we are going to be working on together. I look forward to working with Parish Government to properly calculate the variable cost on the Jail Expenses. Let me tell you something, you are going to be hearing some things from these papers here about the cost of inmates, not just in St. Landry Parish, this is an issue throughout the state. I keep state inmates that are from St. Landry Parish and have family in St. Landry Parish. You may ask why do I do that. Why do I keep inmate, state inmates from St. Landry Parish? There are a few reasons for that. The first one is: Many of the State Inmates are from St. Landry Parish. Their family don't have the means to be able to travel to Angola or to Richmond or to Richland Parish Jail or any other facility that is far away, they just don't have the means to do that. Some of the inmate families are elderly and they can't take that long trip. So we try and keep our local state inmates that were born and raised here, that live here and have family here in our jail. State inmates make up our inmate road crew, not so much anymore, I think you have a full crew on inmate road crews. We did it one time and some of them get a little greedy and want to smuggle something into the jail so we had to reign them in. They clean grave yards, they paint and clean public school buildings and they work on Litter Abatement Crews and do almost anything else for Non-Profit Organizations. State Inmates provide Janitorial Services, Mechanical Services and Lawn Care for our Public Safety and Complex Grounds. The State Inmates provide assistance at our Parish Wide TRIAD Program, Elderly Programs and they serve food and they assist our cooks. The State Inmates keep our department units and our boats and other safety equipment clean and ready for the next assignment. I cannot take local pre-trial inmates that have not been adjudicated in court yet and put them on work crews, I can't do it. If I did not have state inmates to help us do the things that we need to do for the Public and for us and for you, government services we could not do it. I am thankful that the Trustee Dorm is going to work well. It is going to be able to house those folks that need the work and they are learning a trade and the families will have their loved ones here close by. Why do I have so many inmates in our jail? That is the question that I want you all to hear the answer to. The Criminal Justice Procedure in Louisiana consist of Parish Pre-Trial Detainees that don't make bond. If they can't make bond or the Judge won't let them make bond they are staying in jail and they are a burden on the Tax Payers. Once they are convicted if they are convicted of a Felony or plead guilty to a Felony then what happens to them, they become a State Inmate. A State Inmate at that time is in our jail and you know how long it takes for the State Department of Corrections to come and get these people out of our jail, months. What happens is we have a back log and once we get a Felony Conviction or a Plea to Guilty we contact the Department of Corrections. I never ever, ever, call the Department of Corrections and ask them to send me State Inmates, I can't do it. I can't do it because we don't have the room to put them. We have enough locals in our jail and state inmates I don't have to call the Department of Corrections. The money that we make off of that, the \$26.38 a day per inmate and Parish Government has an expense in that. I have been shown what our cost is for State Inmates and again I am not here to complain I am here to tell you that I am willing to work with Parish Government, you all, to help keep that cost down as much as we can. There is a very slow and tedious process because of severe overcrowding of State Corrections Institutions. I told you that the State Department of Corrections doesn't respond fast enough for me, as soon as we get a convictions on a State Inmate and he is not from here he needs to go, he or she. Because the state is overcrowded they will not process that inmate to a State Facility. If you hear people say why he don't get rid of these state inmates, I am trying and I can't. Louisiana Sheriffs are constitutionally and legally required to make all decisions regarding the Operations of the Parish Jails including maintaining the inmate capacity. I am restricted by the Fire Marshall to have so many. If the Fire Marshall come down tomorrow and says you are 40 people over, guess what I have to do, I have to a home for 40 inmates and that is not easy to do. They have kind and we have been trying to maintain the right number. There are reasons why we are overcrowded and I am fixing to get to the last part here to tell you about that. Contributions to jail overcrowding and why do we have jail overcrowding? You know how many municipalities we have in this parish, we have 12. Each Chief of Police in the parish when they make a criminal case and make an arrest where are they bringing that inmate? My Jail. I can't turn them down, I would not if I had the right to but since they are charging them with State Charges the Sheriff have to take in the inmates. The second

thing, once an inmate is found guilty or pleads to a felony he or she becomes a State Inmate. As I mentioned earlier the state does not come promptly enough to pick them up and they stay here 3 or 4 months. I have to instruct our Warden to call the State again and inquire on who they are talking to. I had to call the President of the Sheriff's Association once last year and ask him to talk to the Governor's Office, a Governor's Appointee to the Department of Corrections asking him to step on somebody's toes because this process is taking too long, we are suffering down here, you are paying the bill. He did and it did not help because we go no relief, no immediate relief. The third thing is this: The Parish Criminal Trial Docket, for those of you that are not familiar with that one, anytime someone is arrested and they make bond or they don't make bond they have a case filed and the District Attorney have to take each case and present it to the court. A lot of times there are delays for legal and other various reasons. I can tell you right now I don't like it. I have probably three people in my parish jail that are not the prime suspect in a major drive by shooting and they have been in jail 4 or 5 years and they are just someone that was in the car. I spoke to the District Attorney about seeing if we can take these cases and get them to a plea, bring them forward and give them credit for time served and get them down to plea so they can go home to their families. They can't bond out of jail because they don't have the money and they are not the primary suspect in this major crime although they were in the vehicle they did not have the gun and they did not fire it so we are working on that and he was real receptive to that idea, the District Attorney. The last thing is this: Our parish jail is too small. When it was built in the late 1979 and early 1980's it was too small then and it is too small now. I don't have an answer for that and I don't think anybody does except more money and we can't pour more money into a new jail. I am thankful for the 60 - 70 bed facility that we have coming in but that is just a bandage right now. Crime has increased everywhere, it is not just St. Landry Parish or Louisiana it is everywhere you watch the news. Thanks to members of the Parish Government staff that we are working together and that is what I want. I am not here to fight, I am here to work with you and see what we can do to handle this problem. It is going to get worst, not better, it is just getting worst. Do anyone have any questions?"

*Chairman Wayne Ardoin stated*, "Thank you very much Sheriff. Are there any questions form any councilmembers?"

Councilman Ernest Blanchard questioned, "Did you all look into the Ankle Program?"

Sheriff Bobby Guidroz stated, "Yes Sir we do have people on Ankle Monitors. It works, it seems to work for the non-violent. People can't afford the \$5.00 a day. You are talking about \$5.00 a day times 30 days which is \$150.00 per month and some families just can't afford to pay that and I wish I had a program that would pay that. I was successful in a lawsuit against the Opioid Epidemic and we got \$180,000.00 for my office just last year but the restriction on spending that money is so restricted that I can't use it for the things that we really need to use it for and Jessie knows. I wish I could take that \$180,000.00 and apply it towards things like this."

Councilman Alvin Stelly questioned, "How many do we have in jail that are guilty and found guilty and they are still in our parish jail?"

**Sheriff Bobby Guidroz stated,** "That are found guilty we probably have about 12 that the state have to pick up."

Councilman Alvin Stelly questioned, "We can't charge the state?"

Sheriff Bobby Guidroz stated, "They are paying us. Once the inmate becomes adjudicated as guilty and they are a State Inmate and he is still here they start paying us the \$26.38 a day and that is what Jessie and I are working on now to see how to split that cost. It is a money maker but it is not a big money maker when you look at the cost of it. You have to feed them, you have to medicate them and you have to cloth them."

Councilwoman Mildred Thierry stated, "I just want to say thank you so very much for saying that you have a mind frame to want to work together. When you work together on a problem you can come up with a possible solution and I want to thank you for that. I

want to also thank you for considering when the inmates who possibly have elderly families or who cannot afford to go out of town I want to thank you for keeping that in mind and thank you for having that mid-frame to want to work together so we can possible come up with a positive solution."

Sheriff Bobby Guidroz stated, "I wish I could keep the number of phone calls that I get during the month from families that ask if I can transfer their brother or my son or my grandchild back. They are in Angola because of the overcrowding. When I first got here 18 years ago on today we could get inmates transferred very easily back into the parish because we did not have the overcrowding issue and the Fire Marshall did not pay much attention as he has now but thank you for that."

Councilwoman Nancy Carriere questioned, "What is the Medical aspect of the Trustee Dorm? I know you all said no female workers and I know that we have nurses are they going to be taking care of those trustee's? Also, what are the expense and how will we deal with that?"

**Parish President Jessie Bellard stated**, "The Sheriff and I are working that out. The Trustees already have access to the nurses. Medical will not be an issue."

Sheriff Bobby Guidroz stated, "It won't be because the way we are going to have to handle that is if we have a male sick in the trustee dorm we will get the nurse to come over. We have a room that we can seclude the sick inmate and the nurse. She will not be exposed to the open dorm setting. That all have been provided for and thanks for the planning that Jessie did."

Councilman Timmy Lejeune stated, "Sheriff, I would like to thank you for coming. You gave us a lot of information tonight and we really appreciate that."

Councilman Ken Marks stated, "Thank you Sheriff for being here and working with our Parish President for this situation. It is a long going situation that is not just our parish as you indicated it is state wide. My question is this: Is there any process or any thought of moving to discuss with Legislature to see if we can change some laws or do somethings differently than what we have on the books currently to expedite what you are talking about some of these delays or some other avenues of discussion around the table with the Department of Corrections and the Sheriff's Association or whomever else is working on that."

Sheriff Bobby Guidroz stated, "I presented an idea last year to our District Attorney and Ed Lopez who is in charge of the Defender Board and we all talked about this. If the Defenders would come and appear in court and the lawyers that are assigned to inmates would come and take care of their issues. Judge Meche had to get on the phone and call a well know defense lawyer at his office and inform him that he had a client in court today. If we can't get a whole of the lawyer then they would have to postpone again and that is ridiculous. If we had more cooperation and we went the judges to know that we are frustrated. We have 4 judges and they each take 1 month to handle criminal cases. Every fourth month they are on criminal cases. We should have 2 judges handling criminal cases and make it faster. We need a faster docket turn over. I am just the Sheriff, I am not their boss but I suggested that we do something different because it is costing all of us."

Councilman Ken Marks questioned, "You mentioned a \$100,000.00 a month for 12 months that is costing this parish. Is there any running total or daily total of what you have to deal with on a daily basis? Is that electronically able to be transferred to his department?"

Parish President Jessie Bellard stated, "We get it every morning."

Councilman Ken Marks stated, "So that was already in place. I was not aware of that."

Sheriff Bobby Guidroz stated, "It is unfortunate that we live in this world and it is sad that we have to do what we do. You hear it every day in the news of the shootings, the

killings, the assaults and the rapes. You use to here that from far away and now it is right here in our back yard."

Councilman Dexter Brown stated, "I want to command you for being here tonight and I want to thank your deputies and your team for working for our residents of the parish. Thank you all for all that you all do and keep up the good work."

Sheriff Bobby Guidroz stated, "Thank you. It is getting harder and harder to hire young men and women to come into Law Enforcement because of the danger, it really is. We compete against Lafayette and Acadia and Point Coupee on salaries. I am probably the second highest paid in Acadiana for Deputies. Lafayette has a \$60,000,000.00 budget and mine is \$19,000,000.00 so I can't compete with them. It makes it tough."

Councilman Jody White stated, "I will say something that might end it all but Sheriff thank you for being here along with Mr. Meche. I know everything that you said is true after being in Law Enforcement myself for 25 years. I was a Warden for one year and I know that it is true. Once I became a part of Parish Government and I can see the expenditures that Parish Government actually pays toward the jail I am happy to see that we can get to the road where agreements are being made. I commend you and Mr. Bellard for trying to make this happen to get everybody in a better position."

**Sheriff Bobby Guidroz stated,** "He is faced with the Constitutionally Mandated Expenses. He has to find it somewhere or the Clerk or the Sheriff or the District Attorney have to say you can't pay it, okay. We try to pick up that slack as much as we can but a lot of times these smaller departments can't do it."

Chairman Wayne Ardoin stated, "Thank you Sheriff."

### VI. APPROVAL OF MINUTES:

A motion was made by Councilwoman Mildred Thierry, seconded by Councilman Jody White to approve the Regular Meeting Minutes from October 16<sup>th</sup>, 2024 as transcribed.

### VII. PARISH PRESIDENT REPORT:

Parish President Jessie Bellard stated, "On the Parish President's Report we don't have much to talk about other than the Sheriff talking about the Mandated Expenses and I gave you all a copy of the Mandated Expenses. I don't think that we ever received this before and with all of the talks and negotiations it made us look at more stuff. So you all have a copy to review. It is just backing up everything that we said before. At the end of the day regardless of what people think or say those inmates across the street and the 27 JDC has to be funded before anything else and that is how the law is written. We did make the laws and we did not pass it but we have to follow it and it is a big expense that nobody can help. This year along we will be close to \$700,000.00 over budgeted on inmates. The Coroner's Office is about \$275,000.00 over budgeted and nobody can predict who is getting arrested and nobody can predict who is dying and nobody can predict who needs CEC or OPC's. There are a lot of things that are a normal citizen just does not know. It is a cost that we have to bear. I am going to have the budget ready in the next two weeks and I will send a copy to everybody so everybody can have it and we can sit at the table and look at it and see how we are going to make everything work for 2025."

**Chairman Wayne Ardoin questioned**, "Mr. Bellard, I got the e-mail from Ms. Sherell in reference to effective immediately the only person who can do any filing on your ordinance or your resolutions has to go through your Finance Department first."

Parish President Jessie Bellard stated, "That is correct."

**Chairman Wayne Ardoin stated**, "The Home Rule Charter states in item 2-15 that she is responsible. What are we doing? Are we going to change the way that it is being done?"

**Parish President Jessie Bellard stated,** "If anybody goes upstairs in room 206 and tries to file something and charge it to the Parish Government they will be denied unless it comes from Finance."

Chairman Wayne Ardoin stated, "She will have to bring it to Finance is what you are saying?"

Parish President Jessie Bellard stated, "Correct."

Chairman Wayne Ardoin stated, "Mr. Duplechain is that the right procedure that we are talking if the Home Rule Charter says that she is responsible?"

Legal Counsel Garett Duplechain stated, "The Home Rule Charter states that all enacted ordinances have to be recorded by the clerk. Recording will have to be paid so you all will have to come to an agreement on that.

**Parish President Jessie Bellard stated,** "It does no say that it has to be recorded in the Clerk of Court. It has to be recorded. She is the official record keeper of these ordinances and resolutions. It was an ordinance by the council that said to go and record it at the Clerk of Court which is an extreme expense. This year alone between Publications and recording fees we spent \$69,000.00.

Chairman Wayne Ardoin questioned, "Are we doing it properly is what I am asking?"

Parish President Jessie Bellard stated, "I would say that you don't have to file your ordinances and your resolutions in the Clerk of Court's Office. It is \$110.00 every time you walk in there with one piece of paper. It is just ridiculous and I don't think the law requires us to record it in the Clerk of Court. The Clerk and the Council are the official keepers of those records. Where you all put them and how you all store them is up to you all. I am just saying that \$69,000.00 of publications and recording fees is ridiculous, that is all."

Chairman Wayne Ardoin stated, "In other words she was not liable for them she can put them in a file and keep her own file here in the council chambers."

**Parish President Jessie Bellard stated**, "We always handle them like that before but the council passed an ordinance before I came back and said it had to be recorded in the Clerk of Court so she if just following what the ordinance called for and that is all."

Chairman Wayne Ardoin stated, "Do you want to un-do that ordinance or make a change in the ordinance?"

**Parish President Jessie Bellard stated,** "Only if you all want to. All I am saying is that she need to go to the Finance Department so they can go upstairs with her to sign off on doing it. It is not about who is doing it or why it is about making sure that the finance team gets the invoice to make sure that we pay the bill that is all."

Chairman Wayne Ardoin questioned, "The Clerk of Court does not give us Cart-Blanch Card. We just tore down a building for him am I correct? I don't think it was just on a hand-shake."

**Parish President Jessie Bellard stated,** "We had an Intergovernmental Agreement with him to do that so we did it legally. Again I am not sure how the statue reads for him whether he can do that or not, I am not sure."

Chairman Wayne Ardoin stated, "I think that we need to look at it. I understand that she was turned down the other day because there was a balance. She is used to doing it that way and that is why I am asking now that we are looking at trying to change the situation."

Parish President Jessie Bellard stated, "Again this year is a unique situation with the budget being over. I am looking at every line item that I can cut \$10,000.00 - \$15,000.00 from. need to do and this I think is one of them but if the law says that we have to do it then we have to do it."

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, March 29, 2025, at which election there will be submitted the following proposition, to-wit:

### PROPOSITION (MILLAGE RENEWAL)

Shall Fire Protection District No. 3 of the Parish of St. Landry, State of Louisiana (the "District"), continue to levy a special tax of 10.36 mills on all property subject to taxation in the District (an estimated \$2,422,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2026 and ending with the year 2035, for the purpose of constructing, maintaining and operating the District's fire protection facilities, and paying the cost of obtaining water for fire protection purposes, provided that a portion of the Tax proceeds is required to be contributed to state and statewide retirement systems as provided in R.S. 11:82?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.
