The Council of the Parish of St. Landry, State of Louisiana, convened in a regular session on this 15<sup>th</sup>, day of January, 2025 at 6:00 p.m.

- II. Councilman Jody White led the Pledge of Allegiance & Invocation.
- III. ROLL CALL: Jody White, Nancy Carriere, Faltery Jolivette, Mildred Thierry, Harold Taylor, Alvin Stelly, Vivian Olivier, Timmy Lejeune, Jimmie Edwards, and Ernest Blanchard. ABSENT: Ken Marks and Dexter Brown.

# IV. APPOINT LEGAL ADVISOR GARETT DUPLECHAIN AS TEMPORARY PRESIDING OFFICER TO HOLD THE ELECTION OF OFFICERS.

A motion was made by Councilman Harold Taylor, seconded by Councilwoman Mildred Thierry to appoint Legal Counsel Garett Duplechain as a Temporary Presiding Chairman to hold the Election of Officers.

Councilman Ernest Blanchard stated, "I will nominate Ms. Vivian for Vice-Chairman."

Councilman Timmy Lejeune stated, "Second."

*Legal Counsel Garett Duplechain stated*, "We have a motion and a second to nominate Vivian Olivier for Vice Chairman."

**Councilwoman Nancy Carriere stated**, "I have a nomination. I will nominate Mr. Harold Taylor."

Councilman Harold Taylor stated, "Thank you very much Ms. Nancy but I have too much going on to do that and I am sorry. I will withdraw."

*Legal Counsel Garett Duplechain stated*, "Are there any other nominations for Vice-Chairman?"

**Parish President Jessie Bellard stated**, "That is just an introduction that he wants to do. I recommend that we just hold off until he can come and explain it a little bit better for all of us if you all don't mind."

Councilman Timmy Lejeune stated, "So let's not amend the agenda."

Councilman Wayne Ardoin stated, "I just wanted to make sure that we did not pass it up."

*Chairman Jody White stated*, "So we will wait until the next meeting and then he can come."

Parish President Jessie Bellard stated, "Yes."

## VI. PERSON TO ADDRESS THE COUNCIL:

*Mr. Eric Williams addressed the council. He stated*, "My name is Eric Williams. I am the President of Guns Down Power Up. Me and Ms. Patrice at the Opelousas Museum are partnering together to do a peace walk on February 1<sup>st</sup>, 2025 starting at 11:00 a.m. until 3:00 p.m. We would like to start at the Court House right here like we did two years ago. We will march from there to the Opelousas Museum where everything else will be happening. I want to ask you all a question. What are some of the problems you all are hearing in St. Landry Parish with our youths? What are our Youths doing?"

Councilwoman Nancy Carriere stated, "Breaking into cars."

Mr. Eric Williams stated, "What else? Shooting, Shooting. Destroying each other with these guns. I came here before and I am trying to figure out what it is I would have to do to get you guys support? We did a summer camp and I thank God for the Superintendent, Mr. Milton Baptiste and I thank God for the Marshall, Paul Mouton, partnering with the marshal, they gave us two classrooms, access to the chapel, the basketball court and we had over 60 plus kids. It was a miracle for us to do what we did Monday through Friday. We fed them, we made sure that they had some events, we kept them entertained, we had judges

come by and speak, the district attorney came by and spoke and we had a lot of people in the community come by to participate but there is more that can be done. What I would like to do with this building, every other weekend I would like to have something for those kids to do over there. We have the basketball court, we have footballs, I teach them chess and we have plenty of games. We were doing dances and everything but the support was not there to push it out to let people know what we were doing. I am wondering what is it that I have to do as president of this organization to get you guys help. I am wondering, what do I have to do?"

Councilman Faltery Jolivette stated, "Mr. Eric, what would you need us to do?"

*Mr. Eric Williams stated,* "The first thing is show up if you can. I understand you guys are busy, you all have a life, a family, jobs and you all have other stuff. If you all would come and be observant you could see what is needed. I can tell you but if you come you could see. We feed them snacks and make sure that they have Gatorade because it is hot during the summer because we will be doing this again. We will do a summer count again coming up. We provide them food because people gave donations so we make sure that we feed them a good meal, it was not snacks and chips although we have chips and snacks but they got a good hearty meal."

*Chairman Jody White questioned*, "How often do you these events? Is this a once a month, once a quarter? How often are you putting on these events?"

*Mr. Eric Williams stated*, "I am speaking of a summer program but I will probably start in the middle of February, I will try to do something but it is cold now. We have access to the inside and I will try to do something. We have chess games and board games. We have a basketball area set up there where they can shoot basketball and we can do dances. I will try to do something every other weekend and I will let you guys know once I get it all together. Before I do that I have to get the resources and I have to get the help, I don't want to put the court before the horse."

Councilman Faltery Jolivette stated, "Mr. Eric, perhaps we can meet at a different time and we can talk and see what all those resources are. Maybe we can bring it to the council and see exactly what we can and cannot do and perhaps something even personal on my part, maybe we can get together after the meeting."

*Mr. Eric Williams stated*, "Yes Sir. I have a Facebook page if you guys would like to follow. It is Guns Down, Power Up on Facebook. I also have a website, GunsDownPowerUp.Org. My phone number is 337-401-2545. Thank you all for your time and have a Happy New Year."

*Mr. Michael Kidder addressed the council. He stated*, "I am Mike Kidder. I am applying for a position on the Drainage Board, Ward 3 in Mr. Alvin's District."

Councilman Faltery Jolivette stated, "Mr. Kidder, thank you for your interest in serving. Could you tell us a little bit about your background and experiences that you would have?"

Mr. Michael Kidder stated, "I was a plumbing contractor for years

Councilman Faltery Jolivette stated, "That is good enough for me."

Mr. Michael Kidder also stated, "I also was a home builder."

Mr. Herman Fuselier addressed the council. He stated, "Good evening council and congratulations Mr. Chairman. Just a few things to run by you all this evening. I want to thank you for considering the re-appointments of 5 commissioners that we have now. John Slaughter, Mary Doucet, Yvonne Normand, Sylvia Guidry-Brown and Stephanie Tompkins. We have a good group in place. A couple of them are new comers and some of them have decades of experience but I will be glad to have them back with me. I know that you all are advertising two vacancies and I will ask you all to consider candidates with experience in tourism or have worked in tourism related industries, like hotels, restaurants, museums, B &B, festivals, music and things like that. Some people hear Tourist Commission and they think trips to Hawaii and big paydays and handing out with the stars and that is not how it is. I have to let them know no trips, no money, no t-shirts. The Tourist Commission is a volunteer advisory board. They meet once a month and they review the finances and reports

from me and my staff. They also review projects, grants, marketing, ads, lights, plumbing, signs, build boards, insurance and all of that non glamourous stuff that makes tourism work. I always meet with them with an orientation package just to let them know what they are in far. A few of them are disappointed at times because there is no trip to the Bahamas. By the end of the month you will be getting the annual report from us, if you don't let me know. That report shows that we have invested in technology that tracks visitor numbers. It is called Placer.ai Stats. It is very in depth technology and it tracks where visitors come from, the places that they have visited and how long they stay and how much money that they spend. I have asked Sherell Jordan to share one page of information with you all about the top 10 attractions in St. Landry Parish. By no surprise 8 of the top 10 attractions in St. Landry are food related. Billy's Boudin in Krotz Springs is number one. They had 598, 100 visits last year. Billy's Boudin in Opelousas comes in at number 10. At no surprise again Mama's Fried Chicken, both locations come in at the top ten in St. Landry Parish. The visitors also like Mardi Gras, Horse Racing and Casino Gambling. Down town Eunice is Number 2 on the list with 487,900 visits and a big chunk of that happen February 13 on Mardi Gras Day, there was a record of 11,300 people in Downtown Eunice for Mardi Gras. It is not shown on the list and it did not make the top 10 but Zyde-Gra with Keith Frank was held out here and there were 4,000 people around the courthouse square. That was a big number especially for a second year event. We will have more information in the annual report that you will get. Are there any questions for me?"

Councilwoman Nancy Carriere questioned, "I am just curious, I have been in Billy's and I have not signed a guest list. I am just curious how you all got those numbers."

Mr. Herman Fuselier stated, "The way Placer.ai works is based on technology, it tracks cell phone usage. Many times the apps on your phone have this information. You can opt out of it. There are always these user agreements that people never read and they just click okay so it feeds information to Placer.ai about where you are going and what you are doing and how much money you are spending. There are credit card apps that track these information."

*Councilwoman Nancy Carriere stated*, "So you have to have the app. It is not like they have a paper and you sign in."

Mr. Herman Fuselier stated, "No, they track your technology usage pretty much."

Councilwoman Nancy Carriere stated, "But you have to have that app."

*Mr. Herman Fuselier stated*, "Out of the thousands of apps lots of them are feeding this information to this company. Your cell phone tracks everywhere you go."

Councilman Wayne Ardoin stated, "I want to say thank you for all of your help that you do for St. Landry Parish."

Mr. Herman Fuselier stated, "Thank you Mr. Wayne, I appreciate that. Same to you and same to all of you all."

*Councilman Faltery Jolivette stated*, "I would like to say this; Herman I know you personally and I know your dad. I appreciate what you do and you do it well and I will buy the t-shirts."

Councilman Jimmie Edwards stated, "And I will pay for your trip to Hawaii."

Mr. Herman Fuselier stated, "I will take you up on that."

Chairman Jody White stated, "I think that we have a question from the Media."

Mr. Bobby Ardoin questioned, "How does St. Landry Parish track state wide?"

*Mr. Herman Fuselier stated*, "That is part of the software but there are so many layers to this. We can look it up but there are layers upon layers. You can draw boarders and squares and everything else but this information we can gather for you. Thank you all very much."

# LOUISIANA COMPLIANCE QUESTIONNAIRE (For Audit Engagements of Governments)

Dear Chief Executive Officer:

Attached is the Louisiana Compliance Questionnaire that is to be completed by you or your staff. The completed questionnaire and a copy of the adoption instrument, if appropriate, must be given to the auditor at the beginning of the audit. The auditor will, during the course of his/her regular audit, test the accuracy of the responses in the questionnaire. It is not necessary to return the questionnaire to my office.

Certain portions of the questionnaire may not be applicable to your organization. In such cases, it is appropriate to mark the representation "not applicable." However, you must respond to each applicable representation. A 'yes' answer indicates that you have complied with the applicable law or regulation. A 'no' answer to any representation indicates a possible violation of law or regulation and, as such, should be fully explained. These matters will be reviewed by the auditor during the course of his/her examination. Please feel free to attach a further explanation of any representation.

Your cooperation in this matter will be greatly appreciated.

**Parish President Jessie Bellard stated**, "Mr. Chairman, on next week with that weather coming, we are thinking Sunday afternoon until Thursday afternoon, we will have to open that Shelter again at the Country Club so we will have a place for people to stay. The last group that we had all got placed in some housing whenever they left. The last person will leave tomorrow morning. We had a couple from Melville and they will have permanent housing."

Chairman Jody White stated, "The last time it was open did we have a few people that utilized the facility?"

**Parish President Jessie Bellard stated**, "Definitely. What we are learning is that a lot of people don't have electricity and water at their house. With the weather like it is just terrible. We have a lot of good volunteers that help us and we can place them."

*Councilwoman Nancy Carriere questioned*, "Security, is there someone there? Is it an employee?"

Parish President Jessie Bellard stated, "It is one of our staff members, one of our Security Guys."

*Councilwoman Nancy Carriere questioned*, "What about the cooking, what is going on with that? I want to know if there is anything that I can do to assist."

**Parish President Jessie Bellard stated**, "So we don't really cook. We have the ability to cook but people usually bring food. They will call CiCi and tell her that they will bring food for the night or for noontime. We never had to do anything with cooking yet because people just bring food so we are very fortunate."

Councilwoman Nancy Carriere questioned, "What is the extent of their stay?"

**Parish President Jessie Bellard stated**, "We are looking at Sunday afternoon until Thursday afternoon. It should get above freezing by Thursday."

*Councilman Timmy Lejeune questioned*, "Is that a reimbursement to the Parish from the state or is it just something that we are doing?"

**Parish President Jessie Bellard stated**, "It depends on whether or not the state declares our parish any type of disaster. We don't know until after the fact but we will sign a declaration probably on Friday, we talked about that today."

Councilman Ernest Blanchard questioned, "What about sand on the bridges Mr. Bellard?"

**Parish President Jessie Bellard stated**, "We will have the crews ready to go out, we have the material at the yard. The state does a great job now with their bridges. We do the parish roads and stuff. We take care of all different areas and we have our equipment ready to go for that."

*Councilman Faltery Jolivette questioned*, "Mr. President I have two questions. Will you be giving out some information on what roads may be iced and what bridges may be out?"

Parish President Jessie Bellard stated, "Again, with the weather situation they are telling us a lot of stuff and sometimes it does not happen and sometimes they don't tell us and it happens so we kind of wait and see what happens. As things happen we will let the people know as it is happening. We know that on 3 mile lake, that own ramp, we know that we have to go and put some sand or some of these pebbles on there so people can get up the hill. We know a couple of areas in the parish that we are going to have to make sure we have regardless. The newer places that we are not aware of as it is called in we usually go and see about it."

# ORDINANCE NO. 2024-053 (Sponsored By: Councilman Ernest Blanchard)

Councilman Ernest Blanchard stated, "We found that part of the property behind the old hospital have an alley. At the end of that alley they have a metal building that is about 50 x 200. They had an agreement with the hospital about 20 years ago that they could use that building for storage if they would keep up the grounds. The building is full and tomorrow at 2:30 Jessie and I have a meeting with the Administrator of the new hospital to discuss what we are going to do about that building. I found out that Acadian Ambulance has a building on our property and they were paying \$150.00 per month rental to the old hospital board. Since then Jessie took care of that and they are now paying the parish \$250.00 per month and that part of the deal is settled. I don't know if you want to push this ordinance back or wait."

Chairman Wayne Ardoin stated, "Mr. Garett, do you have any comments?"

Legal Counsel Garett Duplechain stated, "Yes, the ordinance is ready to be passed today. It is an ordinance which abolish Hospital Service District No. 1 which is in the Eunice area. The St. Landry Parish Government succeeded through all of the movable property which is listed in the original ordinance. This ordinance amends the ordinance that we previously passed abolishing the Hospital Service District. So as of today the Hospital Service District is abolished and what this amendment to that ordinance does is it adds one extra tract of land that will be transferred and conveyed to St. Landry Parish Government. It also adds that the ownership entitled to all funds, assets, immoveable property and movable property owned by Hospital Service District No. 1 will be transferred and conveyed to St. Landry Parish Government and the Parish Government will succeed to that. Any and all contracts, rentals or buildings or other parties that contracts with that Hospital Service District No. 1 still exist it will be transferred to St. Landry Parish Government. What this ordinance does, amending the ordinance, which abolish it, it complete the transaction and it completes the transfer of all funds, assets and properties to the St. Landry Parish Government. If there are any existing contracts on that property the St. Landry Parish Government will succeed to those contracts. So that is what this ordinance does, it completes the transaction by amending the previous ordinance which abolishes the Hospital Service District. So the Hospital Service District in that Eunice area has been abolished and this just complete the transaction of the transfer of all assets to the Parish Government."

*Councilman Ernest Blanchard stated*, "The old board, the old hospital, they still have \$6,500.00 Surplus in their account. That needs to be transferred to."

*Legal Counsel Garett Duplechain stated*, "If there are any funds or assets left over the Parish Government will succeed to those funds and assets since the Hospital Service District is abolished all of those assets are transferred and conveyed to the ownership of the parish."

*Chairman Wayne Ardoin stated*, "Are there any questions from any councilmembers on this ordinance in reference to the Eunice Hospital? Mr. Duplechain you will see about the funds that are in that Hospital?"

Legal Counsel Garett Duplechain stated, "This ordinance completes the transaction."

*Chairman Wayne Ardoin stated*, "The funds that Mr. Blanchard is talking about are you going to see that that is taken care of also?"

LANDRY PARISH GOVERNMENT.

R.S. 33:1415, Hospital Service District No 1 in St. Landry Parish shall be abolished and the St. Landry Parish Council shall repeal Section 20-27, Section 20-28, and Section 20-29 in the St. Landry Parish Code of Ordinances in order to abolish Hospital Service District No. 1, which is located in that part of the City of Eunice which is inside St. Landry Parish.

BE IT ORDAINED BY THE COUNCIL FOR ST. LANDRY PARISH GOVERNMENT that Section 20-27, Section 20-28, and Section 20-29 in Chapter 20 in the St. Landry Parish Code of Ordinance are hereby repealed and Hospital Service District No. 1 in St. Landry Parish is hereby abolished.

BE IT FURTHER ORDAINED BY THE COUNCIL FOR ST. LANDRY PARISH GOVERNMENT that the ownership and title to funds, assets, immovable property, and movable property owned by Hospital Service District No. 1, including the following parcels of immovable property owned by Hospital Service District No. 1, shall hereby be conveyed, transferred, and vested in St. Landry Parish Government, to-wit:

- 1. 11.896 acres in Section 29, Township 6 South (T-6-S), Range 1 East (R-1-E), St. Landry Parish, Louisiana. Parcel Number 0601643000A.
- 2. One (1) Lot measuring 435 feet by 300 feet in the Southeast Quarter (1/4) of Section 30, Township 6 South (T-6-S), Range 1 east (R-1-E), St. Landry Parish, Louisiana. Parcel Number 0601094300.
- 3. One (1) Lot containing 0.822 of an acre, and bounded, now or formerly, North by Fruge Street; South formerly by Hospital Service District No. 1, and now by St. Landry Parish Government; East by an unnamed street; and West by Moosa Boulevard. Said parcel of land being in Section 30, Township 6 South (T-6-S), Range 1 East (R-1-E), St. Landry Parish, Louisiana. Parcel Number 0632767769.
  - 4. One strip of property measuring 10 feet by 261 feet, and said property is an abandoned alley, in St. Landry Parish, Louisiana. Parcel Number 0601094320.

Chairman Wayne Ardoin stated, "The equipment one is suppose to come up tonight at the full council."

*Councilman Harold Taylor questioned*, "So Mr. Bellard, the \$2,000,000.00 are we getting that from the Bond Commission? We really needed \$3,000,000.00 right?"

Parish President Jessie Bellard stated, "No, we only borrowed \$1,200,000.00 so far."

Councilman Harold Taylor stated, "What is that?"

Parish President Jessie Bellard stated, "We only borrowed \$1,200,000.00."

Councilman Harold Taylor stated, "Why do we need to vote on this tonight?"

**Parish President Jessie Bellard stated**, "So evidently Eric sends this out after the Bond Commission approves and the bank loans the money. That was my question about the \$2,000,000.00 for the equipment. The Bond Commission already approved everything. So I am not exactly sure why because Eric sent these e-mails to Sherell with these ordinances. So I am not quite sure why we are passing an ordinance whenever we approved this through Resolution last year."

Chairman Wayne Ardoin stated, "Mr. Taylor are you finished?"

Councilman Harold Taylor stated, "I am really confused."

*Chairman Wayne Ardoin stated*, "Mr. Bellard, out of all fairness. Eric has been here before. Can he come here and explain to this council what we are trying to do here?"

Chairman Wayne Ardoin stated, "Timmy are you in favor of that?

Councilman Timmy Lejeune stated, "I am good with that."

#### ORDINANCE PULLED

AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF NOT EXCEEDING \$2,000,000 REVENUE NOTES, SERIES 2025, OF THE ST. LANDRY PARISH GOVERNMENT, STATE OF LOUISIANA; PROVIDING FOR THE PAYMENT THEREOF; ESTABLISHING THE RATE OF INTEREST THEREON; PROVIDING FOR A PLEDGE AND DEDICATION OF REVENUES FOR SECURITY AND PAYMENT THEREOF IN PRINCIPAL AND INTEREST; AND OTHER MATTERS IN CONNECTION THEREWITH.

**WHEREAS**, the St. Landry Parish Government, Parish of St. Landry, State of Louisiana (the **''Issuer''**) is a home rule charter government and a political subdivision of the State of Louisiana (the **''State''**) pursuant to Article VI, Section 5 of the Louisiana Constitution of 1974; and

WHEREAS, the St. Landry Parish Council (the "Governing Authority") as the governing authority of the Issuer pursuant to Section 1430 of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority (collectively, the "Act"), desires to authorize the incurring of debt and borrowing of an amount not to exceed \$2,000,000, secured by revenues to accrue to the Issuer's General Fund (11) (the "Revenues"); and

**WHEREAS**, pursuant to the Act and other constitutional and statutory authority, the Parish desires to incur debt and issue its Revenue Anticipation Note, Series 2025, in a principal amount not exceeding Two Million Dollars (\$2,000,000) (the "**Note**"), to pay current expenses for the fiscal year ending December 31, 2024, and paying costs of issuance, in anticipation of the revenues of the Parish for the current fiscal year ending December 31, 2025;

**WHEREAS**, this Governing Authority has found and determined that it is necessary and desirable to approve the sale of the Note with terms and conditions within the parameters set forth in this Bond Resolution and authorize the Parish's authorized representatives to execute a term sheet with the purchaser (the "**Term Sheet**") within the parameters set forth herein; and

**WHEREAS**, this Governing Authority further desires to proceed with the issuance, sale and delivery of the note to the Purchaser and authorize and obligate the Parish's Authorized Representatives to take action and execute documents as may be necessary to accomplish the issuance, sale and delivery of Note.

**NOW, THEREFORE, BE IT ORDAINED** by the Parish Council for the Parish of St. Landry, State of Louisiana (the **"Parish Council"**), acting as the governing authority of Parish of St. Landry, State of Louisiana (the **"Parish"**), that:

SECTION 1. Authorization of Revenue Anticipation Note. Pursuant to the Act and other constitutional and statutory authority supplemental thereto, the Parish is hereby authorized to incur debt for the purpose of paying current expenses for the fiscal year ending December 31, 2024, and paying costs of issuance in anticipation of the revenues of the Parish for the current fiscal year ending December 31, 2024, and to represent said indebtedness, the Parish shall issue its Revenue Anticipation Note, Series 2025, in an amount not to exceed Two Million and No/100 Dollars (\$2,000,000) (the "Note"). The Note shall mature not later than October 1, 2025, and shall bear interest at a fixed or variable rate to be negotiated by the President of the Parish of St. Landry with the Parish's fiscal agent, provided that such interest rate shall not exceed six percent (6.00%) per annum. Interest on the Note shall be computed based on a 360-day year consisting of twelve 30-day months and shall be payable upon the maturity of the Note. The Note shall be issued in the form of a single fully registered note, dated the date of delivery thereof to the initial purchaser and numbered R-1. The principal of the Note shall be subject to prepayment at any time, in whole or in part at the option of the Parish, at a price of par plus accrued interest on the amount so prepaid to the date of prepayment. The purchase price of the Note shall be paid to the Parish by the purchaser in installments (often time referred to as a draw down loan) on an "as-needed" basis, and the date and amount of each installment of the purchase price shall be noted on the Note and interest shall accrue only on the amount of principal which shall have been borrowed by the Parish.

The Note is hereby awarded to the Parish's fiscal agent, Washington State Bank, in Parish of St. Landry, Louisiana, pursuant to its commitment to purchase the Note, a copy of which shall be filed with this governing authority.

**SECTION 2.** Form and Execution of Note. The Note shall be in substantially the form attached hereto as **Exhibit A**, and the Chairman and the Clerk to the Parish Council are authorized and directed on behalf of the Issuer to execute, seal, and deliver the Note to the purchaser.

**SECTION 3.** Security for Note. The Note will be secured by and payable from the revenues of the general fund (11) for the fiscal year ending December 31, 2025, until the Note is paid in full in accordance with its terms, all in accordance with the provisions of the Act and other constitutional and statutory authority.

**SECTION 4.** <u>Irrevocable Pledge</u>. The note shall be secured by and payable in principal, premium, if any, and interest solely from an irrevocable pledge and dedication of the general fund (11). The Pledged Revenues are hereby irrevocably and irrepealably pledged and dedicated in an amount sufficient for the payment of the Note in principal, premium, if any, and interest as they shall respectively become due and payable, and for the other purposes hereinafter set forth in this Ordinance. The General Fund shall be and remain pledged for the security and payment of the Note in principal, premium if any, and interest and for all other payments provided for in this Bond Ordinance until the Note has been fully paid and discharged.

**SECTION 5.** <u>Authorization of Officers.</u> The President of the Parish of St. Landry and the Chairman of the Council and the Council Clerk is individually or collectively, are hereby empowered, authorized and directed to execute and deliver or cause to be executed and delivered all documents required to be executed on behalf of the Parish or deemed by, either, in their sole discretion, necessary or advisable to implement this Bond Ordinance or facilitate the sale of the Note including the execution of the term sheet.

**SECTION 6.** <u>Note is "Bank-Qualified"</u>. In the event that the Note is issued as a tax-exempt note for federal income tax purposes, the Note shall be designated as a "qualified tax-exempt obligation" within the meaning of Section 265(b)(3) of the Internal Revenue Code of 1986, as amended (the "Code"). In making this designation, the Parish finds and determines that:

- a. the Note is not a "private activity bond" within the meaning of the Code; and
- b. the reasonably anticipated amount of qualified tax-exempt obligations which will be issued by the Parish and all subordinate entities in calendar year 2025 does not exceed \$10,000,000.

**SECTION 7.** <u>Financial Statements.</u> The Parish covenants and agrees that it will furnish the owner of the Note as soon as available, but in no event later than 120 days after the end of each fiscal year, its balance sheet, and income statement for the year-end, audited by a certified public accountant. All financial reports required hereunder shall be prepared in accordance with generally accepted accounting principles, applied on a consistent basis, and shall be in a form and substance acceptable to the owner of the Note. Failure to comply with this provision shall constitute a default hereunder and shall entitle the owner of the Note to exercise all remedies provided hereunder.

**SECTION 8.** Severability. In case any one or more of the provisions of this Ordinance or of the Note shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provisions of this Ordinance or of the Note, but this Ordinance and the Note shall be construed and enforced as if such illegal or invalid provisions had not been contained therein. Any constitutional or statutory provisions enacted after the date of this Ordinance that validate or make legal any provision of the Ordinance and/or the Note that would not otherwise be valid or legal shall be deemed to apply to this Ordinance and to the Note.

**SECTION 9.** <u>Publication; Peremption.</u> A copy of this Ordinance shall be published immediately after its adoption in one issue of the official journal of the Parish. For thirty (30) days from the date of such publication, any person in interest shall have the right to contest the legality of this Ordinance or the Note and the provisions securing the Note. After the expiration of said thirty (30) days, no one shall have any right of action to contest the validity of the Note or the provisions of this Ordinance, and the Note shall be conclusively presumed to be legal, and no court shall thereafter have authority to inquire into such matters.

**SECTION 10.** Continuing Disclosure Exemption. It is recognized that the Issuer will not be required to comply with the continuing disclosure requirements described in Rule 15c-2-12(b) of the Securities and Exchange Commission [17 CFR §140.15c2-12(b)], because the Note is not being purchased by a broker, dealer, or municipal securities dealer acting as an underwriter in a primary offering of municipal securities, and the Note is being sold to only one financial institution (i.e. no more than thirty-five persons), which (i) have such knowledge and experience in financial business matter that they are capable of evaluating the merits and risks of the prospective investment in the Note and (ii) are not purchasing the Note for more than one account or with a view to distributing the Bond. The Issuer shall nonetheless covenant to provide the purchaser or its assigns the information provided for in Section 7 so long as the Note remains outstanding.

**SECTION 11.** Effective Date. This Ordinance shall take effect immediately upon its adoption.
