AN ORDINANCE TO LEVY THE MILLAGES FOR THE 2026 TAX ROLLS ON ALL PROPERTY SUBJECT TO TAXATION BE IT ORDAINED BY THE COUNCIL OF THE ST. LANDRY PARISH GOVERNMENT THAT the following millages are hereby levied on the 2026 tax rolls on all property subject to taxation:

BE IT FURTHER ORDAINED BY THE COUNCIL OF THE ST. LANDRY PARISH GOVERNMENT THAT that the proper administrative officials of the Parish of St. Landry, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment rolls of said Parish for the year 2026, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.
